MINUTES OF THE MONTANA DISTRICT LCMS CONVENTION

Billings, Montana – June 11-14, 2012

"Go Into All the World and Proclaim the Gospel to the Whole Creation" (Mark 16:15)

Monday - June 11

During the morning and early afternoon, the floor committees met. At 3:45 p.m. President Forke opened the convention with the invocation and opening prayers.

Gospel of Mark Bible Study – Session One (Mark 1:1 – 5:43). Rev. Arlo Pullmann read Mark 1:1 – 3:12 to the delegates. Under the general theme of "Go Into All the World and Proclaim the Gospel to the Whole Creation" (Mark 16:15), the delegates at each table discussed the reading by answering the three questions provided. After discussion, Rev. Pullmann read Mark 3:13–5:43 and the pattern with discussion questions was repeated.

At 4:50 p.m. President Forke ended the time of discussion and Bible Study. He then introduced to the convention delegates Steve Hildenburg, Montana District Treasurer and Betty Bagley, Montana District Administrative Assistant. After a few closing announcements, President Forke closed the opening session with prayer at 5:00 p.m.

The opening worship was held at Trinity Lutheran Church at 7:00 p.m. with 4th Vice-President Daniel Preus preaching, Rev. Dan Rinderknecht as liturgist, and Rev. Timothy Richholt as lector.

Tuesday - June 12

Opening devotions were led by Convention Chaplain Rev. Christ Tabbert with Eastern Circuit Counselor Rev. James Hageman preaching on the theme "Go" from Mark 16:15.

Committee #7 – Registration and Credentials Report

Rev. Ray Larson reported 42 voting pastor delegates, 48 voting lay delegates, and 27 advisory delegates.

President Forke explained some parliamentary procedures to the delegates to facilitate their convention work.

Moved and seconded to adopt the agenda in the convention workbook pages 4-6. Motion carried.

District President's Report

District President Forke gave his report and address to the convention following the theme of Proclaiming the Gospel in the 21st Century. A copy of his address will be included in the Convention Proceedings report.

Committee 6 – Nominations and Elections Committee

Rev. Dan Jacobs, chairman, directed the delegates to pages 95-96 of the convention workbook and then introduced those who have been nominated to the various offices – President, Vice-President, BOD members, etc.

After those introductions, the first order of business was the election of District President – the nominees were Rev. Terry Forke and Rev. Dr. John Sias. The ballots were distributed and the delegates voted.

President Forke introduced Rev. Ryan Wendt and thanked him for his work in setting up and managing the AV, computers, and various other electronics for the convention.

Report of Synodical Representative

President Forke introduced Rev. Daniel Preus, 4th VP of the LCMS, who brought a report to the convention following the theme of "Witness, Mercy, Life Together", focusing on "Witness".

Committee 6 – Nominations and Elections Committee

Rev. Jacobs reported that the vote for District President is as follows: Rev. Terry Forke-78; Rev. Dr. John Sias-9; 1-blank. **President Forke has been re-elected as District President.** He asked for additional nominations from the floor for 1st Vice-president of the District. No additional nominations were received. The committee was dismissed to prepare the ballots for First-Vice-President of the District.

President Forke welcomed new members of the Montana District since the last District convention (2009). Pastors: Rev. Kyle Whaley; Rev. David Carver; Rev. Dr. John Sias; Rev. Gerald Paul; Rev. Steven Thomas; Rev. Marcus Baikie; Rev. Paul Shupe. Teacher: Joann Cutler. He also introduced William Beck, lay-representative from Shepherd of the Valley-Thompson Falls (our newest District congregation). He introduced Rev. Mark Nicolaus, Missionary at Large, called by the District, who worked in the Thompson Falls area for the last 2+ years.

Gospel of Mark Bible Study – Session Two (Mark 6:1-9:50). Rev. Arlo Pullmann read that section in two parts: Mark 6:1-7:37 and Mark 8:1-9:50. The delegates at each table discussed the questions provided after each section.

President Forke spent a few minutes acquainting the delegates with the Montana District website and also made a few announcements.

Committee #6 – Nominations and Elections Committee

The ballots were distributed and the delegates were instructed to vote for one of the following for First Vice-President of the District: Rev. Mark Grunst; Rev. Dan Rinderknecht; Rev. Howard Schreibeis; Rev. Chris Tabbert; Rev. Ryan Wendt.

The delegates recessed for lunch following a closing prayer by Rev. James Hageman at 11:45 a.m.

Opening Devotions for the afternoon Session were led by Convention Chaplain Rev. Chris Tabbert with Central Circuit counselor Rev. Steven Schlund preaching.

Committee #6 – Nominations and Elections Committee

Chairman Rev. Dan Jacobs announced the results of the 1st Ballot for 1st VP. Rev. Mark Grunst – 18; Rev. Dan Rinderknecht – 15; Rev. Howard Schreibeis – 13; Rev. Chris Tabbert – 35; Rev. Ryan Wendt – 5. Since no one had received a majority of the votes cast, the committee distributed the 2nd ballot and the delegates were instructed to vote for one of the following: Rev. Mark Grunst; Rev. Dan Rinderknecht; Rev. Howard Schreibeis; Rev. Chris Tabbert.

Report of Synodical Representative – part 2

The original plan was for Rev. Daniel Preus to show a video entitled "Witness, Mercy, Life Together" from LCMS President Matthew Harrison and then field questions from the delegates. However, due to a technical glitch, Rev. Daniel Preus fielded questions at this point to give time to work on the technical problem with the video.

Committee #6 – Nominations and Elections Committee

Rev. Jacobs reported the results of the second ballot for 1st Vice-President. The vote totals were as follows: Rev. Mark Grunst – 16; Rev. Dan Rinderknecht – 9; Rev. Howard Schreibeis – 10; Rev. Chris Tabbert – 50. He announced that **Rev. Christopher Tabbert has been re-elected as 1st Vice-president of the Montana District.**

The delegates were then instructed to nominate by paper ballot one pastor to serve as 2nd Vice-President. The three men receiving the highest number of nominations will comprise the ballot.

Report of Synodical Representative (cont'd)

Rev. Daniel Preus showed the video entitled "Witness, Mercy, Life Together" as the final part of his report to the convention.

Lutheran Malaria Initiative

President Forke introduced Director of LMI for LCMS Martha Mitkos She talked with the delegates about the Lutheran Malaria Initiative. The administrative costs are being covered by a grant from the UN, so 100% of the offerings given go directly to fighting malaria in Africa (bed nets, medicine, and training). She stated that the District has given \$18,000 to LMI to date. President Forke presented her with a check from the opening service offering in the amount of \$1,212.82.

Committee #6 – Nominations and Elections Committee

Rev. Jacobs announced the results of the nominating process. The three who received the most nominations are Rev. Mark Grunst; Rev. Daniel Rinderknecht; Rev. Howard Schreibeis. Rev. Mark Grunst and Rev. Howard Schreibeis indicated their willingness to serve. The committee asked for time to determine whether or not Rev. Rinderknecht is willing to serve. The committee was dismissed to prepare the ballots.

Committee #1 – Missions/Evangelism

Rev. David Warner read three resolutions from the committee (1-01, 1-02, 1-03).

Resolution 1-01 TO ADOPT WITNESS, MERCY, LIFE TOGETHER AS MISSION AND MINISTRY EMPHASIS FOR SYNOD. Moved and seconded. It was moved and seconded to amend

Res. 1-01 by striking in line 19 the words "congregations, circuits, and". Motion carried. By friendly amendment the singular "emphasis" was changed to "emphases". The amended motion was ADOPTED.

Resolution 1-02 was presented. **TO ENCOURAGE AND SUPPORT THE MINISTRY OF ALL CONGREGATIONS REGARDLESS OF DEMOGRAPHICS AND SIZE.** Moved and seconded. In the second Whereas, "III" was changed to "VII" by friendly amendment. After discussion Res. 1-02 was ADOPTED.

Resolution 1-03 TO ENCOURAGE EACH CONGREGATION IN UNDERSTANDING AND PURSUING ITS CALLING WITHIN GOD'S MISSION Moved and seconded.

One delegate raised a point of order asking whether the resolutions from the committees could be printed in addition to having them on the screen. It was decided to print one resolution per table. Resolution 1-03 ADOPTED.

Committee #2 – Indian/Campus/Deaf/Youth

Resolution 2-01 TO AFFIRM AND ASCERTAIN THE USE OF TRINITARIAN BAPTISM

Moved and seconded. It was moved and seconded to amend the resolution by striking "and ascertain" in the title of the resolution. It was moved and seconded to amend the amendment to retain the words "and ascertain" and add "the use of". Amendment ADOPTED. The amended amendment ADOPTED. Moved to amend the whereas after "Trinitarian baptism" by adding "is valid when water and our Lord's words of institution are used within the confession of a congregation that confesses the Triune God" and striking "is valid when administered by a congregation that confesses the Triune God". Moved to amend the amendment by substituting "within the confession of" for "by a congregation that confesses". The delegates agreed to accept that change by friendly amendment. After discussion the amendment CARRIED. After further discussion **Resolution 2-01** was ADOPTED.

Resolution 2-02 TO ENCOURAGE THE TEACHING AND PRACTICE OF CLOSED

COMMUNION Moved and seconded. After much discussion, the previous question was moved and seconded. Motion to end debate CARRIED. Resolution 2-02 was ADOPTED.

Resolution 2-03 TO DECLINE OVERTURE 2-02. Moved, seconded, and ADOPTED.

Committee #6 – Nominations and Elections Committee

The committee distributed the ballots for 2nd Vice-President. The delegates were instructed to vote for one of the following: Rev. Mark Grunst; Rev. Daniel Rinderknecht; Rev. Howard Schreibeis.

The convention recessed for the evening following a closing prayer by Rev. Steven Schlund.

In a meeting convened by the District Secretary after the convention recessed on Tuesday afternoon, Principal Dave Topp was selected from the commissioned ministers of the District to serve as an advisory delegate to the Synodical Convention in 2013. Rev. Richard Thompson was selected from the advisory ordained ministers and specific ministry pastors to serve as an advisory delegate to the Synodical Convention in 2013.

Wednesday - June 13

Opening devotions were led by Convention Chaplain Rev. Chris Tabbert with Flathead Circuit Counselor Rev. Mark Cutler preaching on the theme "Proclaim" from Mark 16:15.

President Forke introduced Cindy Speed who is playing the hymns for the opening devotions during most of the convention and he also introduced Ted Kober who played the organ for the opening service and will be playing the hymns on Thursday. The delegates expressed their appreciation with a round of applause.

Gospel of Mark Bible Study – Session Three (Mark 10:1–13:37). Rev. Arlo Pullmann read that section in two parts: Mark 10:1–11:33 and Mark 12:1–13:37. The delegates followed the same format after each reading by discussing the questions provided after each section.

After some announcements, President Forke called Committee #6 to come forward.

Committee #6 – Nominations and Elections Committee

Rev. Jacobs reported the results of the vote for Second Vice-President as follows: Rev. Mark Grunst–22; Rev. Dan Rinderknecht–19; Rev. Howard Schreibeis–44. Rev. Howard Schreibeis has been elected 2nd Vice-President of the Montana District.

It was moved, seconded and carried to cast a unanimous ballot for **Rev. Mark Schultz as District Secretary.**

It was moved, seconded, and carried to cast a unanimous ballot to ratify the slate of Circuit Counselors as follows:

Eastern Circuit – Rev. James Hageman; Southern Circuit – Rev. Douglas Thompson; Central Circuit – Rev. Steven Schlund; Divide Circuit – Rev. Jason Menagh; Western Circuit – Rev. Raymond Larson, Sr.; Flathead Circuit – Rev. Matthew Nelson

Committee Chairman Jacobs announced those Pastors who had been nominated for the pastor member of the BOD: Rev. Mark Grunst; Rev. David Renfro; Rev. Dr. John Sias; Rev. David Warner. Committee Chairman Jacobs called for further nominations from the floor. Hearing none, ballots were distributed and the delegates were instructed to vote for one of the above.

Committee #3 – Stewardship/Human Care

Resolution 3-01 TO ENCOURAGE AND SUPPORT THE DEFENSE OF RELIGIOUS LIBERTY, FREEDOM OF CONSCIENCE AND THE SANCTITY OF HUMAN LIFE. The committee played a 5-minute video clip of LCMS President Harrison's testimony to Congress in February regarding religious liberty guaranteed in the U.S. Constitution. After the video, it was moved and seconded to adopt Res 3-01. The delegates agreed by friendly amendment to change "congregational" to "Congressional" in line number 11 and added periods to the abbreviation US in line 6. Resolution 3-01 ADOPTED.

Resolution 3-02 TO COMMEND THE USE OF RESOURCES WHICH ADDRESS AND INFORM ABOUT LIFE ISSUES. The committee played a clip of the video "Blood Money" after which it was moved and seconded to adopt Resolution 3-02. It was moved and seconded to amend the second to last resolve by adding "opposing physician assisted suicide" after the word "work".

Amendment CARRIED. It was moved and seconded to amend line 31 by adding the words "state and" after "urging" and "senators and" before the word "representatives". Amendment CARRIED. A number of friendly amendments were suggested and agreed upon by the delegates. After a prayer by Rev. Cutler, Res 3-02 was ADOPTED.

After a 15-minute break, President Forke called Committee 6 to the podium.

Committee #6 – Nominations and Elections

Rev. Jacobs announced the results of the voting for pastor member of the BOD. Rev. Mark Grunst–16; Rev. David Renfro–16; Rev. Dr. John Sias–31; Rev. David Warner–22. The delegates were instructed to vote for one of the following: Rev. Dr. John Sias or Rev. David Warner.

President Forke called Committee #4 to the podium.

Committee #4 – Education/Communication/Schools

Resolution 4-01 TO REQUIRE A HIGH STANDARD OF EDUCATION FOR ORDAINED

MINISTERS Moved and seconded. Moved and seconded to amend changing "direct" to "urge" in the first and last resolved. Amendment DEFEATED. After discussion, Resolution 4-01 ADOPTED.

Committee #6 – Nominations and Elections

Rev. Jacobs announced the results of the voting for pastor member of the BOD: Rev. Dr. John Sias -40; Rev. David Warner - 42. **Rev. Warner is elected as pastor member of BOD.**

Lay Members of the District Board of Directors: The current nominees are Johnny Buck, Mt. Olive, Billings; Frank Delgado, St. Paul, Ronan; Jerry Roseleip, St. John, Deer Lodge; Mark Scott, Mt. Calvary, Polson; Harry Trangmoe, Our Savior, Glendive. There were no nominations from the floor. The delegates were instructed to vote for four.

President Forke called Committee #5 to the podium.

Committee #5 – Administration/Special

Prior to the introduction of Resolution 5-01 President Forke asked 1st VP Tabbert to take the chair. **Resolution 5-01 TO AMEND THE BYLAWS OF THE MONTANA DISTRICT** Moved and seconded. From the floor, President Forke explained the history and purpose for this resolution. Moved and seconded to amend it by inserting the following to the first Resolved: IN BYLAW 1.3.2, PARAGRAPHS J.1, K.1, AND L.1 (PP. 63-64), INSERT, AFTER "FIRST," THE WORD "FULL.". Motion CARRIED. Amended Resolution 5-01 ADOPTED.

Resolution 5-02 TO REVIEW AALC RELATIONSHIPS Moved and seconded. After much discussion, it was moved, seconded, and CARRIED to extend the orders of the day by 5 minutes. After further discussion, the previous question was moved and seconded. Motion CARRIED to end debate. Resolution 5-02 was ADOPTED.

The delegates recessed for lunch following a closing prayer by Rev. Mark Cutler at 11:50 a.m.

Opening Devotions for the afternoon Session were led by Convention Chaplain Rev. Chris Tabbert with Western Circuit counselor Rev. Raymond E. Larson, Sr. preaching on the theme "The Gospel" (Mark 16:15).

Committee #6 – Nominations and Elections

Rev. Jacobs announced the results of the voting for lay-members of the BOD: Johnny Buck-66; Frank Delgado-76; Jerry Roseleip-69; Mark Scott-62; Harry Trangmoe-54. **Johnny Buck, Frank Delgado, Jerry Roseleip, and Mark Scott are elected as lay-members of the BOD.**

It was moved, seconded, and CARRIED to cast a unanimous ballot for **Dave Topp to be the teacher Member of the BOD.**

Rev. Jacobs announced the nominations for Pastor members of the MT District Nominations and Elections committee as follows: Rev. James Koss; Rev. Daniel Jacobs; Rev. Darold Reiner. After asking for nominations from the floor, Rev. David Carver was nominated. The committee was dismissed to prepare the ballots.

President Forke called Committee #1 to the podium.

Committee #1 – Missions/Evangelism

Resolution 1-04 To Direct and Support a Priority for Mission Work in the Bakken Oil Boom Region. Moved, seconded, and ADOPTED.

President Forke called Committee #2 to the podium.

Resolution 2-04 TO COMMEND, ENCOURAGE, AND EXPLORE CAMPUS MINISTRY Moved and seconded. Moved to amend line 47 by adding "in consultation with the local congregations" before the word "to". Amendment CARRIED. Resolution 2-04 ADOPTED.

Resolution 2-05 TO REAFFIRM COMMUNION FELLOWSHIP BETWEEN CONGREGATIONS OF THE LUTHERAN CHURCH—MISSOURI SYNOD Moved and seconded. After discussion. Resolution 2-05 DEFEATED.

Committee #6 – Nominations and Elections

The committee distributed the ballots for pastor members of the District Nominations and Elections Committee. The delegates were instructed to vote for three of the following: Rev. James Koss; Rev. Daniel Jacobs; Rev. Darold Reiner; Rev. David Carver.

President Forke called the chairman of Committee #3 to the podium.

Resolution 3-03 TO AFFIRM THE TEACHING OF SIX DAY CREATION IN SYNODICAL SCHOOLS A number of friendly amendments were agreed upon by the delegates. Resolution 3-03 ADOPTED.

Resolution 3-04 TO ENCOURAGE THE SUPPORT OF THE SEMINARIES Moved and seconded. The delegates agreed on a couple of friendly amendments. After discussion, Resolution 3-04 was ADOPTED.

Resolution 3-05 TO FACILITATE PLACEMENT OF RETURNING MISSIONARIES was brought before the delegates. However, during the reading, the committee realized that the resolution

before the delegates was not the resolution that had come out of the committee. The chair of committee # 3 relinquished the podium to resolve the problem.

Committee #6 – Nominations and Elections

Rev. Jacobs reported the results of the elections for pastor members of the District Nominations and Elections Committee. Rev. James Koss–68; Rev. Daniel Jacobs–83; Rev. Darold Reiner–57; Rev. David Carver–47. The members of the District Nominations and Elections Committee will be Rev. James Koss; Rev. Daniel Jacobs; Rev. Darold Reiner.

It was moved, seconded, and carried to cast a unanimous ballot for **Suzanne Rasmussen as teacher** member of the District Nominations and Elections Committee.

Receiving no nominations from the floor, the committee distributed the ballots for lay- members of the District Nominations and Elections Committee. The delegates were instructed to vote for three of the following: Roy Arves; Kale Bauer; Ernie Hergett; BJ Meyer.

President Forke called Committee #4 to the podium.

Resolution 4-02 TO EMPHASIZE ECCLESIASTICAL SUPERVISION IN REORGANIZATION OF DISTRICTS Moved and seconded. After discussion, Resolution 4-02 was ADOPTED.

Resolution 4-03 TO ENCOURAGE CHRISTIAN PUBLIC SCHOOL TEACHERS Moved and seconded. A friendly amendment was agreed upon by the delegates. Resolution 4-03 was ADOPTED.

Resolution 4-04 TO PROVIDE A RESOURCE TO EQUIP CHRISTIAN PUBLIC EDUCATORS WITH ALTERNATIVES TO THE EXCLUSIVE TEACHING OF EVOLUTION IN THE PUBLIC SCHOOL CLASSROOM Moved and seconded. The delegates agreed upon a friendly amendment for clarification purposes. Resolution 4-04 ADOPTED.

Resolution 4-05 TO SUPPORT THE LUTHERAN MALARIA INITIATIVE Moved and seconded. A friendly amendment in the resolved was offered: to add "members of those congregations, and called workers" in place of "individual members." Res 4-05 ADOPTED.

President Forke called Committee 3 back to the podium.

Resolution 3-05 TO FACILITATE PLACEMENT OF RETURNING ORDAINED MISSIONARIES Moved and seconded. Moved and seconded to amend the final resolved by inserting the words "and timely" after the word "full." Amendment carried. Resolution 3-05 ADOPTED.

Moved and seconded to dismiss Committee #3. Motion DEFEATED.

Break at 3:20 p.m.

Committee #6 – Nominations and Elections

Rev. Jacobs announced the results of the vote for lay- members of the District Nominations and Elections Committee: Roy Arves–63; Kale Bauer–65; Ernie Hergett–52; BJ Meyer–69.

Roy Arves; Kale Bauer; BJ Meyer were elected lay-members of the District Nominations and Elections Committee.

Moved and seconded to cast a unanimous ballot for **Rev. Dr. John Sias to serve on the Committee for Convention Nominations of the Synod.** Receiving no nominations from the floor, the delegates were instructed to vote for either Rev. Kevin Peterson or Rev. Robert Lane as alternate delegate to the Committee for Convention Nominations of the Synod.

President Forke called Committee #5 back to the podium.

Resolution 5-03 TO STUDY THE DIVERSITY OF WORSHIP PRACTICES

IN THE MONTANA DISTRICT. By friendly amendment a resolved was added "that the president's report be submitted to the 2015 District Convention" and to add "and Vice-Presidents" after "District President" in the first resolved. Resolution 5-03 ADOPTRED.

Resolution 5-04 TO DECLINE RESPECTFULLY OVERTURES 5-04. Since Overture 5-04 To review the Salaries of top Synodical Officers was accidently omitted from Convention Workbook, it was read in its entirety. Committee #5's Resolution 5-04 was then read to the delegates. Moved and seconded. It was moved and seconded to recommit Res 5-04 to Committee #5. More discussion. Motion to recommit DEFEATED. Resolution 5-04 ADOPTED.

Committee #6 – Nominations and Elections

Rev. Jacobs announced that Rev. Kevin Peterson was elected as the alternate member of the Committee for Convention Nominations of the LCMS.

With the exception of Committee #7–Registration and Credentials which will give a final report on the closing day of the convention, President Forke dismissed the committees and thanked them for their work.

One delegate suggested the assembly stand and give thanks to President Forke for his good work as District President for the past three years and for a great job chairing the convention. The assembled delegates thanked him with applause.

The convention recessed at 4:30 p.m. following a closing prayer by Rev. Raymond E. Larson, Sr.

Thursday - June 14

President Forke made a few opening announcements. He then commended the delegates for their work and decorum during the convention, the good discussion, the well-argued opinions, and the loving manner in which they treated one another when dealing with the resolutions — even when they disagreed.

Gospel of Mark Bible Study – Session Four (Mark 14:1–16:20). After listening to Rev. Arlo Pullmann read each section (Mark 14:1–72 and Mark 15:1–16:20), the delegates discussed the questions provided.

A delegate brought the following resolution to the floor: **To Redirect District Funds to Support LCMS Seminaries** Moved and seconded. It was moved and seconded to amend line 34 after the word "seminaries" by adding "with the 2.5% for Concordia Theological Seminary-Ft. Wayne to be given to

the Alumni Matching Program until the \$150,000 goal is reached. When the goal is reached then the 2.5% is directed to the Concordia Theological Seminary-Ft. Wayne undesignated funds;" Amendment CARRIED. It was moved and seconded to amend line 26 to read "by giving an additional 5% instead of reducing the percentage given to Synod by the District." Amendment DEFEATED. After discussion, the previous question was moved and seconded. The motion to end debate CARRIED. The amended motion was DEFEATED.

President Forke asked if there is any further business to come before the convention. Hearing none, he asked Committee #7 to come to the podium.

Committee #7 – Registration and Credentials

Rev. Raymond E. Larson, Sr. gave the committee's final report as follows:

President Forke dismissed Committee #7 with thanks and declared the 32nd Convention of the Montana District closed.

The convention concluded with the Closing Worship, following the Order of Matins with Rev. Chris Tabbert as liturgist and Southern Circuit Counselor Rev. Doug Thompson as preacher. The theme of the sermon: "Christ's Mission – Our Mission". 4th Vice-President of the LCMS Rev. Daniel Preus installed Rev. Terry Forke as District President and President Forke then installed of the officers and the others who were elected at this convention as part of the service.

Presidential Address 32nd Convention Montana District LCMS Holiday Inn, Billings, Mt June 11-14, 2012

"Go Into All the World and Proclaim the Gospel to the Whole Creation" (Mark 16:15)

I. Proclaiming the Gospel in the 21st Century

Dear brothers and sisters in Christ. There may be many reasons for attending a District convention: a chance to meet old friends, an opportunity to hear good preaching, a desire to learn more about the church. I suspect that the chief reason you showed up for this convention is that you believe the Gospel of Jesus Christ. You believe it is the truth, and you believe that it should be proclaimed to the world. That is the convention theme, from Mark 16:15, "Go Into All the World and Proclaim the Gospel to the Whole Creation".

In many ways proclaiming the Gospel is a timeless joy. The message always stays the same. In other ways proclaiming the Gospel in the 21st century presents challenges Christians may have never experienced. Let me outline three that I think you should spend some time considering.

A. Challenges to the proclamation of the Gospel.

1. Culture: For much of the history of this nation Christians have been cultural insiders. By that I mean that the Christian faith was thought of in a kindly way. Even if members of the community did not believe in Jesus they still respected the Church, its Pastors, and individual members. Many would have agreed that America is a Christian nation. The contributions of the Church to the general welfare of society were noted and applauded. There were even trappings of power accorded to the Church. Pastors and Bishops were considered to be leaders of their communities. They were asked to speak and even pray at community events. They were appointed to committees and boards because they were assumed to have some clout with their constituencies.

Today, many of these amenities have disappeared. Worse, the Christian faith is regularly mocked in film and print. Intellectuals bend over backward to explain that this is not a Christian nation. Public confessions of the faith often attract legal action. Pastors and Bishops are suspected instead of being respected.

This challenge must not be ignored. How will we proclaim the Gospel in a hostile environment? 2. Science: The modern world, where most of us grew up held to a theory of truth that is foreign to the latest generation. We grew up believing that an objective truth actually existed. Whether it was science or philosophy or religion asking the question the objective was to search out the truth, the reality, the answer. The post-modern world, we live in today, does not believe that truth actually exists. What passes for science and philosophy today is often understood only as a matter of perspective. Religion is summarily tossed onto the lazy susan of personal affinities. Most of you have heard someone say, "I'm not religious but I am spiritual." That usually means that they have drunk deeply at the trough of individualism to the point that they have constructed their own spirituality. They do not believe they have found truth. They believe they have cobbled together something that pleases them.

This challenge must not be ignored. How will we proclaim the Gospel to a generation that does not believe in the existence of truth?

3. State: First amendment rights have been held dear by most Americans. The Church is not the least among them. The Church has used these rights to bolster its ability to proclaim the Gospel.

In a recent series of decisions, ranging from Health and Human Services telling the Church that it must provide for birth control under its insurance plans, to the refusal of the House of Representatives to support a bill that would ban abortion for the sake of gender selection, to the President of the United States publicly declaring that he supports marriage rights for homosexual couples, it appears that first amendment rights, at least as far as the Church is concerned are being re-examined.

This is a challenge that must not be ignored. How will we proclaim the Gospel if the state chooses to limit that proclamation?

B. The Gospel answers the challenges and the needs of mankind.

We live in a day where a large portion of the Church seems to have forgotten that the answer to these challenges, and indeed the answer to all of the problems of living in a sinful world are found in the Gospel. Entire confessions of faith, whole denominations are floundering, searching for answers to these challenges. Unfortunately, they are often looking in all the wrong places. Some are looking to money, some to technology, some to entertainment, some to corporate business principles and some to human nature. "If we only have enough money," "If we had the right technology," "If our worship is entertaining enough," "If we ran this congregation more like a business," "If we give the people what they want," we will survive. These are no answer.

Instead, this is what Jesus says, "Go Into All the World and Proclaim the Gospel to the Whole Creation". He tells us to proclaim the Gospel. This is Jesus' answer. Why would Jesus tell us to proclaim something that was not the answer?

- 1. Sin. Lots of things have changed. This hasn't changed, people are still sinners. No, we cannot do whatever we feel is right at the moment. God has established an active law. It condemns us to the point that we cannot save ourselves. Every human being has the same status before God, apart from the Gospel. We are sinners because we do not meet His standard of holiness.
- 2. There is only one Savior. Much has changed. This hasn't, there is and can be only one savior. No, there are not many paths to God, and a self-constructed "spirituality" is nothing more than narcissistic silliness. All the religions of the world cannot be true, because they contradict each. Christianity is unique because it alone proclaims that man cannot save himself by his behavior. We proclaim a savior, Jesus Christ.
- 3. God's love sends a Savior to save. The world has changed, but God hasn't. God is love. God so love the world that He gave His only begotten Son that whoever believes in Him shall not perish but have eternal life. In this is love, not that we loved Him but that He loved us and sent His Son to be the expiation for our sin. Here the love of God is at work. Jesus Christ did not come to condemn the world but to save it. The love of God, demonstrated in the life, death, resurrection, ascension and return of Jesus is the answer to all of life's challenges.

C. We are commanded to proclaim.

- <u>1. Success?</u> So we proclaim. Please note that God does not give us quotas, benchmarks, goals, or deadlines. He doesn't even give us a concise, 25 words or less, comprehensive, inspiring, mission statement. The life of faith, the life of the body of Christ is not about success.
- <u>2. Growth?</u> Despite all the hoopla about Church Growth we must remember that God doesn't even tell us to grow the Church. In fact, He explicitly says that growth is His prerogative. Paul told the Corinthian congregation, "I planted, Apollos watered, but God gave the growth." Growth can become a harmful idolatry. We must be clear about God's command.
- 3. Proclaim. We are commanded to proclaim. The Gospel message stays the same. The applications, and to a degree even the method of proclaiming may change with the ages of this world. But, we have this command to speak the truth of the Gospel, boldly, courageously, in season and out of season, wherever and whenever He gives us leave.

II. Who is going?

A. Pastors

- 1. The Office of the Public Ministry. This text specifically refers to the office of ministry. This is not an office the Church created for its convenience. It is not optional. God created this office so that: there would be a seat of wisdom regarding the Word of God- (The title- elder); that there would reflection of the Father's love in Jesus- (The title- pastor); and a center of authority regarding the stewardship of the Gospel- (The title- overseer). The Lutheran Church recognizes the necessity of this office when it says in its Confessions, "It is taught among us that nobody should publicly teach or preach or administer the sacraments in the church without a regular call." (AC XIV)
- 2. Respect. This office is given little respect these days. Many, even some within our Confession seem intent on diminishing this office. If a layman, or a woman, or even someone with a different confession can get the job done, many seem to think that God's standards for the office should be relaxed. Further, it is common practice to feel that the Pastor is present to please the people, and if he doesn't then either he should leave, or the members will leave. Somehow we seem to have missed that what really suffers as a result of the current disrespect for the office, is the proclamation of the Gospel.
- 3. Proclamation. This office is given the responsibility to see to the proclamation of the pure Gospel. The Lutheran Church recognizes this when it says in its Confessions, "To obtain such faith God instituted the office of the ministry, that is, provided the Gospel and the sacraments. Through these, as through means, he gives the Holy Spirit, who works faith, when and where he pleases in those who hear the Gospel." (AC V) Yes, Pastors are going into the world to proclaim the Gospel.

B. People.

- 1. People. Pastors are not the only ones who are going to proclaim the Gospel. God gives the Pastor to a specific people. He gives the people to a specific Pastor. This arrangement exists not simply to give the Pastor someone to preach to, but for the sake of the proclamation. The people of God also live and speak the Gospel. Peter writes to the people of God, "But you are a chosen race, a royal priesthood, a holy nation, a people for his own possession, that you may <u>proclaim</u> the excellencies of him who called you out of darkness into his marvelous light." (I Peter 2:9)
- 2. Partnership. Together Pastor and people proclaim the Gospel. Paul writes to the Philippian congregation, "I thank my God in all my remembrance of you…because of your partnership in the gospel from the first day until now." (Phil 1:3) This fellowship, this working side by side for the sake of the Gospel is a beautiful creation of God.
- 3. Vocation. God is at work in His people. Although the farmer grows the food, God is the one who gives us our daily bread. So, Luther says, it is as if God clothes, or masks Himself in His people to accomplish His work. God is at work in His people in their various vocations and stations in life. Through these vocations and stations in life God sees to it that the Gospel is proclaimed to all creation. The people of each congregation have far broader and more intimate access to the people of their community than does their Pastor.

C. Congregations.

- 1. Congregations. God gathers congregations. Congregations are not accidents, nor are they social gatherings of like-minded people. Jesus said, "For where two or three are gathered in my name, there am I among them." (Mt 18:20) Please note the passiveness of the gathering. The people are not gathering themselves. God gathers congregations for the sake of proclaiming the Gospel to all creation.
- 2. The Body of Christ. Congregations are a reminder that the Church is the body of Christ. There are many members of our congregations. No two members are precisely alike. This is by God's design. Each member, with his unique set of skills, abilities, talents, vocations and stations in life proclaims the

Gospel in a unique context. And yet, each member works as a part of the body, not as an individual on his own quest.

3. Resources. Congregations, then, proclaim in ways that individuals cannot. By gathering people together in a congregation God creates a pool of gifts that is greater than the sum of its parts. Congregations can make a public confession to their community in ways that are more effective than individual testimonies.

D. Synod

- 1. Human institution. Synods are human institutions. There is nothing in the Scripture about creating a synod. However, there is nothing that says the Church does not have the freedom to create a gathering of congregations that have the same confession of faith. As long as the Synod abides by the confession of the pure Word of God the human institution can serve the Church.
- 2. Proclamation. Synods work for the proclamation of the Gospel, not their own survival. The danger is that a Synod spends more time working for its own survival than it does for the sake of the proclamation of the Gospel. This is one reason that we have District and Synodical conventions. We want to make sure that our Synod stays on track of proclaiming the Gospel in its truth and purity.
- 3. Synod. The word synod means to walk together. So a synod is a gathering of congregations that walk together to see to some aspect of proclaiming the Gospel. Synods proclaim in ways that individuals and congregations cannot. But synods should not get caught in the trap of doing what congregations should be doing. There very limited purposes for a Synod. A synod should be doing what congregations cannot do by themselves. Examples of this work might be: Educating Pastors and Teachers, sending out missionaries, ecclesiastical supervision and large scale works of mercy. Each of these duties of a synod is undertaken as a means of assisting the Church to proclaim the Gospel.

III. Who is "the whole creation"?

A. Believers

- <u>1. Believers.</u> Believers need to hear the proclamation of the Gospel. There are some voices in the Church today implying that proclaiming the Gospel to those who already know Jesus is not mission work. I disagree. Do believers need to hear the Word? Yes! Did Jesus send us to speak the Word to believers? Of course He did. This is <u>part</u> of the mission.
- <u>2. Pastors.</u> Pastors are sent to proclaim to believers. God gives congregations to Pastors and Pastors to congregations. The believers in each congregation do need to hear the Word of God from their Pastor lest they fall away from the faith. The Word of the Gospel is the only thing that can sustain their faith.
- 3. People. God's people are sent to proclaim to believers. God gathers congregations. One of the reasons He does this is so that His people can hear and see from each other the truth of the Gospel.

B. Unbelievers

- 1. Unbelievers. Of course, unbelievers need to hear the proclamation of the Gospel. Without the hearing of the Gospel that creates faith unbelievers are destined for hell. Yes, God did create a place of punishment for those who do not know Jesus. Remember we cannot save them. God does that work. He does use us to proclaim the Gospel to unbelievers.
- <u>2. Pastors.</u> Pastors are sent to proclaim to unbelievers as well. It is possible that this fact has been given less emphasis than necessary. God does not give the Pastor only to a congregation, but, as

a prophet of God, Pastors are given to the communities in which they reside to proclaim the Gospel to all who can hear.

3. People. Likewise the people of God are sent to proclaim to unbelievers. Friends, neighbors, relatives, and co-workers all hear and see the Gospel proclaimed by the people of God. God gives His people to the world so that unbelievers can hear the Gospel and come to faith.

C. Neighbors

- 1. "Who is my neighbor?" Jesus was once famously asked, "Who is my neighbor?" The answer was a surprise to His hearers. Loving our neighbors does not simply mean being nice. In the final analysis, love means proclaiming the Gospel. The story of the good Samaritan suggests that our neighbor is the people that we really don't like very much. While this is true it is, at the same time, much broader than that.
- 2. Near. We normally think of our neighbor as people who are physically, emotionally, or even spiritually close to us. Yes, these are people who need to know the love of God in Christ Jesus. God sends us to bind the wounds and care for our neighbors who are close.
- 3. Far. In another sense those who are not "close" to us are also our neighbors. The Samaritan was not close to the wounded man in any way. Likewise, there are people in our communities, and the world who are not close to us. They may be of another race, ethnicity, intellectual or financial status. Sometimes these differences loom larger in our minds than their need to hear the Gospel. God sends us to bind the wounds and care for neighbors who are far away so that they can hear the Gospel.

IV. How will we know when we get there?

A. Faith.

- 1. The world's map. Sometimes we fall into the trap of using the world's map instead of the one provided by the Word of God. How do we know when we have gone into all the world and proclaimed the Gospel to the whole creation? The number of people in the pews is not the answer to the arrival at the goal. Paul writes to the Church at Corinth, "So now faith, hope, and love abide, these three; but the greatest of these is love." These gifts may help us determine the destination of our proclamation.
- 2. Faith. God calls us to be faithful. "Moreover, it is required of stewards that they be found trustworthy." (Faithful) (I Cor. 4:1) What good does a faulty proclamation do? None. Our first act of proclamation is to be a careful assessment that we are saying what Jesus told us to say, nothing more, and nothing less. Just as arriving at one's destination alive is essential to the journey, so proclaiming the pure Gospel that brings life, is essential to the mission.
- 3. He is Faithful. "Let us hold fast the confession of our hope without wavering, for He who promised is faithful." (Heb. 10:23) We dare not think ourselves independent. The survival of the Church does not rest on our ability to be faithful. God is faithful. In His faithfulness He keeps us true to His Word. Thus we arrive, in His faithfulness, proclaiming the Gospel.

B. Hope.

1. Failure? We have examined only three challenges to the proclamation of the Gospel in the 21st century. There are countless others. It would be easy for us to become discouraged and lose hope. It is particularly tempting in Montana to think, "We are too small and too isolated to have much impact on the proclamation of the Gospel." I remind you that if you have proclaimed the Gospel in its purity there can be no chance of failure. The Word will do its work, when and where the Holy Spirit sees fit.

- <u>2. Hope.</u> Our hope is not based on our ability to fulfill the mission. Our hope is based on the power of the Gospel to save. God promises that He is at work in that Word. We have arrived at the goal of the mission when our hope is placed not in ourselves but in His Word.
- 3. Risks. Fear a failure seems to drive a lot of our decisions regarding when, where and how we proclaim the Gospel. So, allow me to speak a word of freedom to you. On the basis of our hope in the power of the Gospel I encourage to reconsider how you evaluate risks for the sake of proclaiming the Gospel. I submit to you that risks should not be evaluated on the basis of probability of success, but on the value of the goal. Proclaiming the Gospel to believers and unbelievers is a very valuable goal. I plead with you to jettison the "We've never done it this way before." and the "This isn't going to work." approaches. It is acceptable to take some risks so that the Gospel can be heard. It is hope, to believe that when it is proclaimed it will work.

C. Love.

- 1. Power? There is considerable confusion about how God is at work in the two kingdoms of Church and State. The Church dare not evaluate its mission on the basis of power or influence in the world. God works through the state by the power of the sword. He works through the Church by the power of the Word. From time to time the state may flex its muscles in areas God does not intend, but the Church cannot be intent on the defeat of the state. Instead of power, the greatest gift God has given His people is love. Love is mightier than the sword.
- <u>2. Love.</u> This is how God determined to work in the world, love. God so loved the world that He gave His only begotten Son. God knew what was best for us and sacrificed Himself on our behalf. Since this love is tied to a specific act of God in Christ Jesus, it cannot mean letting people do whatever they want to do. Love is strong. It is manifest in the proclamation of the Gospel. We cannot be in the mission without loving and we cannot love without being in the mission. Since God is love and since He is in His people we can be assured we have arrived.
- 3. Proclaimers. Jesus said, "Let us go on to the next towns, that I may preach, (proclaim) there also, for that is why I came out." (Mark 1:38) Jesus came to proclaim. Like teacher, like disciples. We have been sent out to proclaim. That happens in the context of love. That is why Jesus said, "By this all people will know that you are my disciples, if you have love for one another." (John 13:35) You, dear brothers and sisters, can be confident that the God of love is at work in you as you go into all the world proclaiming the Gospel to all creation. In Jesus' name. Amen.

WHEREAS, THE RESPONSIBILITY OF PASTORS AS STEWARDS OF THE MYSTERIES OF GOD IS NOT AS HIRELINGS OR PLEASERS OF ANY MAN OR GROUP OF MEN, BUT AS SERVANTS OF CHRIST, IT BEING REQUIRED OF STEWARDS THAT THEY BE FAITHFUL (2 TIM 4:3-4; 1 COR

4:1-2); AND AS THEY KEEP WATCH OVER SOULS AS THOSE WHO WILL HAVE TO GIVE AN ACCOUNT (HEB 13:17); AND

Our Convocation this triennium featured Rev. Glenn Merritt, Synodical Director of Disaster Response, speaking on Synodical relief efforts our Synod has accomplished in various parts of the world, and throughout the U.S.

Amicus Christi Edee Anderson

Edee Anderson and her husband Jim moved to Deer Lodge, Montana in the summer of 1971, shortly after their marriage and graduations from the University of Montana. One of their first actions was to transfer their church membership to St. John Lutheran Church, LCMS in Deer Lodge. Naturally, Edee became a member of the St. John LWML and has actively served in local, zone, and District LWML activities since that time. She has held offices at all levels and currently serves as Montana District Scholarship Chairman, a position she has held for many years. Edee also began teaching Sunday school at St. John soon after their arrival and continues in that capacity as needed today.

A natural extension of a Sunday school teacher is to make sure the kids get to church summer camp. When the first of Jim and Edee's children, along with other St. John campers, needed a ride to the District Youth Camp in 1983, Edee volunteered to provide transportation. She decided it would be better to help in the camp kitchen for a week rather than to drive back to Deer Lodge only to make the return trip in a few days. The next year she was asked to serve as Head Cook for the camp. So began her long "career" as Queen of the Camp Kitchen at the Montana District Youth Camp in Red Lodge. It was the philosophy of the camp director at that time, Rev. Clare Skov, that food would cost less if you cook what the kids will eat. And, since it is a proven fact that children return to where good food is served, the camp was assured of a steady supply of return campers the next year. This has proven true through the years as Edee continues to plan the menus and purchase the food for all three Red Lodge Camps. Campers continue to return and bring their friends for Good Lutheran Christian teaching and Great (not the typical) Camp Cuisine lovingly prepared by Edee and her able assistants. She also manages the First Aid station at the camp where she is proficient at applying dressings and medications (anything but stitches) to injured, bitten or otherwise stricken campers.

Jim and Edee have retired in Deer Lodge where they continue as Servants of Christ at St. John. Edee is known far and wide for her culinary and organizational skills at church sponsored dinners, Thrivent fundraisers and the annual Tri-county Fair Breakfast which is

sponsored by St. John. They have five grown children, all of whom attended the Red Lodge Camps as campers, counselors, and/or kitchen helpers over the years.

Thank you, Edee, for your many years as a "Servant of Christ" in St. John, The Lutheran Women's Missionary League, and The Montana District LCMS Youth Camps.

Amicus Christi Rev. Raymond Paul Wiegert

Rev. Wiegert has been a deeply respected and dearly loved servant in the LCMS for more than 50 years, 36 of those years in Montana. He grew up assuming he would be a pastor; his own father was an LCMS pastor. Ray was born in Danvers, Illinois, to Rev. Arthur and Louise Wiegert; that parsonage would know its share of joy and grief. He was the third of nine children, but Ray would lose five of those siblings: two in infancy, two in early childhood and a younger brother at age 37. Of the surviving siblings, the two sisters are nurses and the brother is a retired LCMS pastor.

Ray began parochial school with first grade when he would ride with his older sister on the "interurban" (trolley) twelve miles to Bloomington to attend Trinity Lutheran School. When his father accepted a call to Concordia Lutheran Church in Springfield, IL in 1944 he continued his education at Concordia's elementary school. After a little more than two years of public high school in Springfield, Ray's father accepted a call to Zion Lutheran in Farmersville, IL. Ray finished his junior year there. As a high school senior Ray was enrolled at prep school, Concordia Academy, St. Paul, MN. Ray was short just one English credit at the end of his junior year, but all the usual languages for ministerial preparation had to be taken! In what normally spanned three years Ray's last year of high school consisted of English and ministerial prep courses: beginning Latin, beginning German and beginning Greek! He graduated in 1953.

There were two more years of junior college at St. Paul and then Ray entered Concordia Theological Seminary in Springfield conveniently near his home. Vicarage was at St. Paul Lutheran Church, Council Bluffs, Iowa under District President Lobeck. Ray gained more than languages at St. Paul, after vicarage Ray married Dolores Betty Heuer August 27, 1958, whom he had met at Concordia, St. Paul. Dolores' home church was shared with Ray's relatives and as he says, "the attraction was immediate!" Together Ray and Dolores went to Springfield to finish the final year of seminary.

Ray's first call was to a subsidized parish of the Iowa West District numbering a little more than 100 communicants: Immanuel Lutheran in Osceola, Iowa. Ordination and Installation took place on July 5, 1959. LCMS congregations were not so close together in southern Iowa, and people drove from as far away as 40 miles; it would prepare them for Montana. Two boys, Neal and Mark were born in Osceola.

After four and a half years Ray accepted the call to St. John Lutheran Church and School near

Roselle, Illinois. The family spent eleven and a half years there, the church grew to 425 communicants, and the school reached 160 students in eight grades. The congregation erected an addition to the school including six classrooms and a gymnasium. Also during that time Renee, their beautiful daughter, was born. In 1968 Ray was diagnosed with Crohn's Disease. Ray has contended with that condition by God's grace for many years, but it did not stop the ministry or debilitate the minister.

Ray was called to Messiah Lutheran in Missoula in August of 1975. Ray says, "It was a delight right from the start!" The people were positive; their attitudes were refreshing and the Wiegerts never regretted moving west and so far from home. Ray was appointed District Missions Committee Chairman in 1978 and served joyfully until 1988. As part of his Mission Committee duties Ray visited many congregations throughout the district and met hundreds of God's wonderful people. Ray was elected Circuit Counselor of the Western Circuit in 1991 and served in that position until 1997. In 2005 Ray was appointed to the District Board of Directors.

A devastating blow would come to the Wiegert family in late 1985 when their daughter Renee, at 19, was diagnosed with lymphoma. Renee died after 5 months of illness. "Her death had a tremendous impact on my life and ministry. Our loving Savior was by our side as he worked through very caring and compassionate people."

Both of Ray and Dolores' boys live in Montana. Neal lives with his family near Stevensville and works as a graphic artist at the University of Montana. Mark is a Thrivent representative living Lewistown. They have both married and the Wiegerts enjoy six grandchildren. After more than twenty-seven years as pastor of Messiah Ray retired at the end of January in 2002, but that retirement was very short! Ray had started serving Trinity Lutheran in Superior shortly before this, in 2000. The following fall after retiring Trinity extended a call to pastor Wiegert and he was formally installed there in October of 2002. Ray has continued to drive the many miles from his home up the "Rattlesnake" to Trinity to this day.

It would serve us all well to do the math of miles, of messages and years. Ray has been preaching God's word, baptizing God's people, sharing His Holy Meal and serving the church at large for over 50 years with steadfastness and sincerity. His brothers in the ministry, the people in the pews and congregations scattered over the Synod greatly value his smile and his voice of calm and His preaching of clear salvation through the grace of Jesus Christ. We can see how He has carried the cross and lived the cross. Ray and Dolores are gracious, beautiful servants of our Lord. Shepherds would be blessed to walk as faithfully. Pastors and wives would be blessed to live as lovingly and all of God's people can pray thankfully for Ray and Dolores Wiegert. We have often heard of the three great "sola's" of the reformation, but in fact some count five: sola fide, sola gratia, sola scriptura and solus Christus (faith, grace, scripture and Christ alone), but to these we rightly add three more letters. It is what JS Bach used to sign to his music: "sdg" or soli Deo Gloria: to God alone be the glory! Ray wanted to end by saying, "God has been good! All glory is His alone! I truly thank Him that He has counted me worthy of being His instrument to serve in His Kingdom. He has surrounded me with caring, supportive people in my family and in the Church."

Amen, dear friend. Amen, dear friend of Christ!

CALLED TO GLORY

Rev. Paul Blunck was born on February 3, 1927 to Conrad and Frieda Blunck in New York, N.Y. He was called to glory on February 10, 2011 in San Diego from a stroke. A service was held at First Lutheran Church, Missoula, on February 20, 2011 with a military burial at Missoula City Cemetery.

After serving in the occupation forces in Italy in World War II, he graduated from Montana State University in 1952 and Concordia Seminary, Springfield, III in 1957. He also received a Master of Education degree from MSU in 1965. Rev. Blunck served Harlowton and Roundup from 1957-1964, followed by First Lutheran, Missoula from 1965-1993. He served as First and Second Vice President, Secretary, Missions Committee Chairman and on nearly every District committee. He is survived by his wife, Doris; sons Reginald, John, and Michael; and three daughters, Paula, Lisa, and Heidi.

Rev. George Draper was born on August 9, 1944 in Sacramento, CA to George L. Sr. and Nina Draper. He was called to glory on August 14, 2009, in Billings, MT. A service was held at Mount Olive Church, Billings.

He earned a B.S. in Civil Engineering from Oregon Institute of Technology in Klamath Falls, OR in 1978. He worked as a construction manager in Texas for several years before moving to Ft. Wayne, IN where he attended Concordia Theological Seminary and received a Masters of Divinity. Rev. Draper served as pastor of Trinity Lutheran Church in Wolf Point, MT and Faith Lutheran Church in Glasgow, MT from June 1999 until July of 2009.
