## PARLIAMENTARY PROCESS

The parliamentary process is intended to enable a group to conduct its business with the least possible confusion in order that everyone in the group may understand as clearly as possible what is being decided.

The parliamentary process also protects the rights of both minority and majority within an assembly. Unless the assembly creates special rules itself, the rules given in "Robert's Rules" are followed.

Ir

ln	order to help delegates understand parliamentary procedure we offer these few basic rules and procedures.
1.	Always address the chairman, or the presiding officer. Debate between members is not permitted. Comments and discussion are addressed to the assembly.
2.	Wait until the chairman has recognized you, and granted you permission to speak. "The chair recognizes Mr./Mrs " "You have the floor."
3.	Main Motions require a majority vote, and are amendable.
4.	Try to learn the basic language used in parliamentary procedure. This is given below for your use:  MAIN MOTION:  I move  I move the adoption of this report  I wish to present the following resolution I move its adoption, or I move the adoption of the proposition in the report.
	COMMITTEE RESOLUTIONS Resolutions presented by a convention committee do not require a motion or a second. The presumption is that this has already happened since the committee has formalized, adopted and presented the resolution to the convention.
	The chairman says, "This resolution (motion) is now before the Convention" places any motion or resolution on the floor for discussion. <i>Prior to this announcement by the chairman any discussion is out of order.</i>
	POSTPONE INDEFINITELY I move to postpone this matter indefinitely. In effect kills a motion.  AMEND
	I move to amend the motion by inserting between and  I move to amend by adding after
	I move to amend by striking out and inserting  I move to amend by striking out the motion and substituting this motion. (Read or state substitute motion)
	COMMIT OR RE-COMMIT
	I move that this matter be referred to a committee of to be named by with instruction
	POSTPONE TO A SET TIME

	Order of business. (2/3 vote is required)

## SPECIAL STANDING RULES

- 1. Only substantive amendments to a resolution shall be offered from the floor (those impacting its purpose or effect). Editorial corrections or non-substantive changes to introduced resolutions should be shared in writing with the Secretary. Until a resolution is presented to the delegates, any such changes should be suggested directly to the floor committee chair.
- 2. Unless covered by these Special Standing Rules, parliamentary procedure shall be governed by the most recent edition of Robert's Rules of Order Newly Revised.
- 3. Delegates are encouraged to keep their comments on task. In order to facilitate this, the Chair may ask delegates to limit their debate time. No delegate or representative may speak more than twice on the same motion on the same day and may not speak a second time until all delegates and representatives desiring to speak the first time have had the opportunity. The chair shall have discretion to make exceptions to this rule. When a floor committee is called on to answer a question or to give information, this rule shall not apply.
- 4. A delegate who speaks on an issue may not move to call the question at the close of his or her speech.
- 5. If a substitute motion is offered and seconded, the presenter shall be offered two (2) minutes to provide the rationale for offering it and a member of the floor committee shall be offered two (2) minutes to present rationale for why the committee believes the original motion is to be preferred. The convention shall decide by majority vote without further debate whether or not to consider the substitute. If the decision is in the affirmative and if the substitute motion is subsequently adopted, the original motion dies. If the substitute motion does not receive favorable action either to consider or adopt, the original motion is again considered.
- 6. No motion to reconsider or rescind shall be made or called up during the last day of the convention.
- 7. A delegate may speak against a resolution which was drafted by a floor committee upon which the delegate serves.

# 2022 MT District – LCMS Convention Expense Reimbursements

The MT District will cover delegates' (Pastor, Lay, and Advisory), Board of Directors', parish ministry committee members', and special invited guests' travel, meals, and lodging expenses as indicated below. All other convention guests will attend at their own expense.

Expenses will be reimbursed on an accountable basis in accordance with IRS guidelines. In the case of lodging and meals, this requires itemized receipts for all claimed expenses. Mileage reimbursement requires beginning and ending odometer readings and days traveled. <u>Use of the 2022 District Convention Check Request Form is REOUIRED for all reimbursements</u>, and is located following these directions.

#### Travel.

- Delegates are encouraged to travel to and from the convention by privately owned vehicle. Please share
  rides when possible. Any alternate method of travel must be approved in advance through the MT District
  office.
- The district will reimburse eligible attendees at the rate of <u>48 cents per mile</u> to the driver/owner of the vehicle. In order to meet the IRS reporting requirements, the beginning and ending odometer reading and dates of use must be reported. Only the driver/owner of the vehicle will be reimbursed for mileage.
- Mileage allowance will be limited to the most direct route from the delegate/guest home to/from Billings.
- Two-day travel is automatically authorized for those individuals traveling more than 300 miles to the convention using the most direct route from their homes to Billings.

#### Lodging.

- The MT District will cover up to \$50.00 plus the applicable taxes and fees per night for lodging during the convention. No fees/charges (i.e. room service, movies, etc.) beyond covered lodging will be reimbursed.
- The MT District will cover costs of lodging from Sunday night through Wednesday night. If additional nights are required, reimbursement will require advance approval through the MT District office.
- Covered lodging expenses for eligible attendees staying at the Billings Hotel and Convention Center will be billed directly to the MT District office. Attendees will be required to pay any charges above the covered lodging expenses at checkout including \$50/night for single room request. If you have no charges above the covered lodging expenses, you will not be required to make any payment at checkout.
- Eligible attendees may choose to lodge at a different establishment and will be reimbursed as noted above. Itemized receipts are required for reimbursement.
- Reimbursement of lodging expenses while traveling to and from the convention is limited to those individuals traveling over 300 miles from their homes to Billings. Lodging reimbursement during travel is limited to \$100 maximum per night charge plus taxes. Itemized receipts are required for reimbursement.

#### Meals.

- All meals while in travel status and while attending the convention are included. The convention banquet dinner is provided by the district at no cost to eligible attendees; meal reimbursement during the banquet is not available. Breakfast is provided Monday-Thursday for those lodging at the Billings Hotel & Convention Center and will not be otherwise provided or reimbursed.
- You are authorized a meal reimbursement of: **breakfast \$10.00**, **Sunday**; **lunch \$10.00**, **Sunday-Thursday**; **and dinner \$20**, **Sunday**, **Monday**, **Wednesday**, **and Thursday**. <u>Itemized receipts are required for all reimbursed meals (total of bill with tip and list of items). Alcoholic beverages are not eligible expenses. If you cover the meal costs of other delegates <u>please include their names on the receipt</u>. If your receipt includes the costs of ineligible guests, deduct their items from the total submitted for reimbursement. Meals consumed prior to leaving home and after returning home are not eligible for reimbursement.</u>
- Reimbursement of meals on 6/11 and 6/17 are reserved for those traveling an excess of 300 miles each way.

#### **Check Request Form Instructions:**

- 1. **Please print**. "Payable to," "Date," **full** "Mailing Address," "From," "Mode of transportation," expense information, and "Signature" are required blanks. **Incomplete forms will result in delayed payment.**
- 2. Itemized receipts are required for all meal and lodging reimbursements. Original receipts **OR** copies may be submitted (the IRS recommends you keep a copy or the originals for your own records). Actual odometer readings are required for mileage reimbursements.
- 3. Meals reimbursements are available as follows, unless prior authorization is received:
  - Breakfast, \$10.00 maximum, Sunday
  - Lunch, \$10.00 maximum, Sunday-Thursday
  - Dinner, \$20.00 maximum, Sunday, Monday, Wednesday, Thursday
    - On Tuesday, a dinner banquet is provided; no other reimbursement will be authorized.
- 4. Alcoholic beverages are not reimbursable.
- 5. Your check request and receipts may be submitted one of two ways:

# "Thy Word" President's Report 2022 Montana District Convention

Unmoored- our nation has been chewing away at the line that has provided safe anchor from the beginning. For centuries believers and unbelievers alike had some sense that the Word of God contained wisdom that stood the nation and its citizens in good stead. No more! We are completely unmoored from God's Word. No one outside of the Church any longer finds value in God's Word. What is more, huge swaths of "the Church" have abandoned God's Word for their own understanding. Without this anchor we are subject to the wind, waves, tides, and terrors of this world. The authors of the Formula of Concord rightly reminded us that the Word of God is a lamp to our feet and a light to our path. Let's take a few minutes to look at what Psalm 119, the source of our theme verse, has to say about the Word of God.

#### I. His Word.

- A. God's Word gives life.
  - 1. "My soul clings to the dust; give me life according to your word!" V25
  - 2. "I am severely afflicted; give me life, O LORD, according to your word!" V 107

The Word of God created all life in the beginning when He spoke it into existence. His Word alone gives life when it is spoken as the Gospel of Jesus Christ. As you receive physical life by God's creation, so you receive spiritual life when He creates faith in Christ in you by the power of His Word.

- B. God's Word never changes.
  - 1. "Forever, O LORD, your word is firmly fixed in the heavens." V89
  - 2. "The sum of your word is truth, and every one of your righteous rules endures forever." V160

The Word of God is the only permanent fixture of truth upon which we can build our lives. Our culture presses science forward as the final arbiter of truth, but this can only lead you away from the truth of God's Word. Scientific truths change from age to age as observations change, but the Word of God is always true and fixed by God's command.

- C. God's Word directs our life.
  - 1. "Your word is a lamp to my feet and a light to my path." V 105
  - 2. "The unfolding of your words gives light; it imparts understanding to the simple." V 130

Book stores are crammed full of self-help tomes. The Word of God does not teach you how to help yourself. It teaches you how God has helped you through the work

of Jesus and how it continues to help you by strengthening your faith. He provides the answers you need to live your life in faith in Jesus who is the light of the world.

- D. God's Word gives salvation.
  - 1. "My soul longs for your salvation; I hope in your word." V 81
  - 2. "You are my hiding place and my shield; I hope in your word." V 114

The Word of God teaches the way of salvation through faith in Jesus Christ. Faith means to see what can be only seen through faith. It is not based on evidence, but on the Word of God. Consequently, Christians are alive in hope. We hope in Jesus to have all that we need for this life and the next.

- E. God's Word gives strength
  - 1. "My soul melts away for sorrow; strengthen me according to your word!" V 28
  - 2. "Then shall I have an answer for him who taunts me, for I trust in your word." V 42

Do you sometimes get weary with the drag and stress of this daily life? Where do you turn for strength? The psalmist reminds us that the Word of God is our strength. We cannot find strength in ourselves or in our own words. Likewise, the words of worldly voices may sound cute, and perhaps even wise, but only the Word of God can give the strength you need to endure in faith through this sinful world.

- F. God's Word gives joy.
  - 1. "How sweet are your words to my taste, sweeter than honey to my mouth!" V103
  - 2. "I rejoice at your word like one who finds great spoil." V 162

The world depends on happiness to make it through the day. Happiness, however, is dependent on the circumstances of this life. If the circumstances are not what you envisioned, you will not be happy. Joy is not based the circumstances of life, but on the Word of God. We hear that we are forgiven in Jesus, and we rejoice despite the circumstances of life.

#### II. His Word in the Church

As the pressures on the Church grow as result of living in a world that is less respectful of the faith, it will become more and more significant that Christians are steeped in the Word of God. It is the only source of strength, peace, and endurance for the days ahead. This is why we listen to the Word during the Sunday services and bible class. This is why we attend weekly bible studies and hold family devotions. That is why, even at district conventions we devote so much time to the study of God's Word.

The problem is that sinners forget God's Word. Even in the most dramatic of circumstances we can forget what God has said to us. The ladies went to the tomb on Easter morning and the angel said, "Why do you seek the living among the dead? He is not here, but has risen. Remember how he told you, while he was still in Galilee, that the Son of Man must be delivered into the hands of sinful men and be crucified and on the third day rise." Luke 24:5–7. If the ladies who cared for Jesus had to be reminded of His Word how much more so do we, who in the busyness of our lives lose track of what He has to say to us, need to be reminded.

This is one reason that God invented the Office of Pastor. God sends Pastors to congregations to remind us of His Word, to deliver the gifts of Word and Sacrament so that we can regularly hear what God has to say to us. Pastors, as God's stewards, not only speak to the church members God has given them, but they also speak to a world that is lost in sin. Teachers in our Lutherans schools also teach God's Word daily to the children in their care.

Much has been written about how the Church is in decline. While the number of Americans who claim to be Christians fell from 70% in 1950 to 60% in 2020, the overall percentage of Americans attending church fell from 23% to 8% during the same time period. Furthermore, the number of Americans claiming no religious affiliation grew from 36 million in 2007 to 56 million in 2014. Estimates are that 3500 people are leaving the church every day.

One perspective on this decline is to wring our hands, descend into a depression, and calculate the days until the Church disappears. On the other hand, we could begin to calculate how many people need to hear about Jesus. The answer, of course, is all of them. This ought to remind us that Jesus said, "The fields are white for the harvest." John 4:35 There is much for us to do.

When Jesus contemplated the harvest of those who were yet to know Him, He did not wring His hands. Instead, He folded them, and encouraged you to do likewise. "The harvest is plentiful, but the laborers are few. Therefore, pray earnestly to the Lord of the harvest to send out laborers into his harvest." Luke 10:2

In 2022 we can again say that the laborers are few. From 2004 to 2018 enrollment for pre-seminary (undergraduates) students declined 59% and for Lutheran school teacher 61%. Enrollment at the seminaries has declined 55%.<sup>2</sup> Furthermore, 44% of active ordained men are over 55 years of age.

With these statistics in mind The Lutheran Church—Missouri Synod has initiated a program entitled "Set Apart to Serve" (SAS). It's goal is to encourage young men and women to go into full time church work. The program's early research has found that the top four influences that lead young people into church work are: Pastors,

Commissioned workers, Family, Lutheran School teachers. They have also discovered that youth going into church work are generally deciding in late middle school to early high school years. Resources for this program can be found at the LCMS website.

Dear brothers and sisters in Christ, Church workers, parents, grandparents, congregational members, for the sake of the proclamation of the Gospel please prayerfully consider how you may encourage young people to consider church work. I sincerely hope that this convention will adopt a resolution encouraging congregations to participate in "Set Apart to Serve."

#### III. His Word in the Home.

Worldly pressures are not only growing on the Church but also on the Christian family. There are forces that have proudly, publicly announced their desire to eradicate the nuclear family. These are generally anti-marriage forces. They believe that marriage harms their opportunities to function in the world as they desire. Christian families have only begun to feel this force. A more ubiquitous, if not widely recognized, force is that of extra-curricular activities that compete with Christian worship and education and fracture the family with a constant busyness. Many Christian parents have been convinced by the spirit of the age that they are being good parents when they enroll their children in multiple activities that just happen to preclude attendance at Sunday worship or catechism instruction. Somehow making it into a good university, or gaining a scholarship, has become more important than investing in an eternal welfare.

In contrast, listen to what God says about the responsibilities of parents. God commands parents to train children in the Word. "Fathers, do not provoke your children to anger, but bring them up in the discipline and instruction of the Lord." Ephesians 6:4 Long before Paul, Moses wrote, "And these words that I command you today shall be on your heart. You shall teach them diligently to your children, and shall talk of them when you sit in your house, and when you walk by the way, and when you lie down, and when you rise. You shall bind them as a sign on your hand, and they shall be as frontlets between your eyes. You shall write them on the doorposts of your house and on your gates." Deuteronomy 6:6–9. At its 2019 convention The LCMS called for parents to take these texts to heart in its Resolution 12-03a "Resolved, that congregations should encourage and train parents, guardians, and members to be active teachers and life-long learners of the faith..." (Emphasis added)

If Christian parents were to take this charge seriously perhaps we could head off a looming crisis. The family is in trouble in the United States. Although there is ample evidence, very few people seem to admit the significance of the father of the family actively living the Word of God.<sup>3</sup> If a father does not go to Church, even if the mother does only 2% of the children will become a regular worshipper in adulthood. If a father does attend, regardless of what the mother does over 66% of the children will become

regular worshippers. If a mother is the first person in a family to become a Christian, there is a 17% probability the household will follow. If a father is the first person in a family to become a Christian, there is a 93% probability that the household will follow. These hard statistics are not meant to diminish the role of the mother, they are simply a much-ignored reality.

These statistics also reflect how households in America have changed. Fewer than 25% of households are traditional nuclear families.<sup>4</sup> Our Lutheran school Teachers experience the fallout of this truth daily. They are also undoubtedly aware that 33% of American children are born out of wedlock.

How can Christian parents prepare their children for life with Jesus while at the same time help fend off the decline of our culture? The answer is not rocket science. Simply put, do what our Father has told us to do, read, study, and discuss His Word in our families. Consider the following statistics. If the Word of God is not taught and discussed in the family around 20% of the children will continue in the faith. If the Word of God is taught and discussed in the family around 65% of the children will continue in the faith. When both parents attend Sunday School 72% of their children will attend Sunday School when grown. When neither parent attends Sunday School 6% of their children will attend when grown. I sincerely hope that this convention will adopt a resolution encouraging, and equipping parents to raise their children in the faith.

#### IV. His Word in the Lutheran School.

One of the most overlooked jewels in The Lutheran Church—Missouri Synod is our Lutheran schools. These schools cannot take the place of Christian parents, but they are a marvelous supplement, and are pledged to the teaching of God's Word. We all know and agree that religion cannot be taught in public schools, but Lutheran Schools are places where God's Word is taught in every subject. Even if you do not have school age children you should be aware that our Lutheran Teachers seek to relate the Word of God to every subject taught in school. Jesus is not relegated to "religion" class. He is real in every subject.

In addition to godly subject matter, Lutheran Schools are also places where teachers model the love of Christ. Children are not subjected to the latest fads of the godless world in Lutheran schools. Instead, they are taught to avoid the ways of the world. This is not only taught. It is modelled in the words and lives of their teachers. Sometimes these attitudes are more readily caught than taught.

Lutheran Schools do not drive a wedge between the students and their parents. They are places where families are supported through the Word. A lateral benefit of Lutheran Schools is that because they follow the Word of God, they are also in the process of encouraging and enabling families to function as God calls them to function.

I sincerely hope that this convention will adopt a resolution encouraging the support of our Lutheran grade and high schools.

One more issue should be drawn to your attention. Lutheran Schools depend on orthodox education of their teachers. I have already noted the dire statistics regarding the number of Lutheran Teachers available. This is not a matter of numbers only. Many of you will be aware of the difficulties that our LCMS universities have been experiencing. Most of them are educating a very low percentage of Lutheran Church workers. Some have struggled with outside forces like gender-theory and critical race theory. If their primary objective is not to educate Lutheran Church workers, the pressure to compromise His Word in favor of one program or another is great. At our 2018 Montana District convention we adopted a resolution calling for a study of our LCMS universities. It was not acted on by the 2019 Synodical convention. I sincerely hope that this convention will adopt a resolution calling for a thorough study of the LCMS university system, with an eye toward prioritizing the education of Lutheran Church workers.

#### Conclusion

Dear brothers and sisters, I conclude by encouraging you not to despair. Despite the severe statistics I have shared, we know that God's Word is victorious. The Word was put in the tomb once before, but death could not hold it there. He is risen! "For the word of God is living and active, sharper than any two-edged sword, piercing to the division of soul and of spirit, of joints and of marrow, and discerning the thoughts and intentions of the heart. And no creature is hidden from his sight, but all are naked and exposed to the eyes of him to whom we must give account." Hebrews 4:12–13.

This sword is at work in you and in the world, and it will continue to be victorious. You can always depend on it for it is truly a lamp to your feet and a light to your path.

# Triennium Treasurer's Report 2022 District Convention

The importance of the relationship of service and oversight that exists between the Montana District and the District Congregations, expressed in part during District Conventions, is invaluable. Over the past triennium, in keeping with the Board of Directors (BOD, Board) focus on transparency and faithful stewardship, the Office of the Treasurer has pursued providing clear and useful financial information regarding the district finances and relevant financial information for use by congregational treasurers and their congregations. Included in the Triennium Report (expanded into four years) are comparative financial statements of The Montana District of the Lutheran Church – Missouri Synod, reporting years 2018-2020 (audited) and 2021 (unaudited). Through generous gifts, donations, and bequests from our district congregations and individual donors, as well as investment income, the Montana District has been able to both meet its financial obligations and plan for future ministry with confidence. This is possible both through the faithfulness of the Board in honoring the mission of the District and the faithfulness of the District Congregations in providing direction to the Board. For instance, the by-laws of the Montana District, proposed by the Board and approved at a District Convention, prevent any Board of the Montana District from engaging a loan to conduct operating activities (salary, office expenses, purchase of fixed assets for operations, etc.). This assists in keeping budgetary planning focused not just on the year ahead, but on the effect of the budget on future ministry years.

A brief review of the financial highlights of the past triennium, expanded, includes the following:

## 2018-2021 Highlights

- Periodic review of financial procedures and internal controls was conducted and updates were made as recommended.
- New FASB standards were enacted during the triennium and the District reporting was updated for implementation; the goal of these new standards is transparency in expense and liquidity reporting. Beginning with 2018, the Statement of Functional Expenses is included with District reporting.
- \$93,605 in scholarships were awarded to church worker program students at Concordia Seminaries and Universities. These scholarships were funded through donations, bequests, and investment revenue received from the Lutheran Church Missouri Synod Foundation where the monies are held in investment to maintain a scholarship program supporting the training in ministry of members of Montana District Congregations.

- Montana District awarded \$97,423 in student loan repayment grants to church workers serving Montana District congregations to support both district church workers and their congregations. These awards were funded primarily through LCEF Operating Results given to the District, and in part General Fund monies.
- Lutheran schools in Montana District applied for and received \$15,774 in grants in support of their programs. This fund was begun with donor money, increased with Board directed General Funds, and is held with LCMS Foundation to maximize income on the balance to maintain the grant program.
- The BOD directed \$25,584 in assistance to MT District congregations for various financial difficulties over the expanded triennium.
- \$15,116 in Mercy Fund Grants were awarded during the triennium. The Mercy Fund was created to aid MT District called workers who are facing catastrophic medical costs beyond their ability and their congregations' capacity to assist. This fund is fully supported by individual and congregational restricted donations.
- The BOD has been active in supporting pro-life ministry and in supporting religious freedom in Montana and nationally. \$934 was sent to Lutherans for Life, \$335 supported religious freedom in Montana and the Montana Life Coalition, and nationally \$2,250 was invested in religious freedom through Alliance Defending Freedom.
- To support District congregations in communicating the truths of God's word on His creation of men and women, the BOD purchased and provided 200 copies of God Made Boys and Girls by Marty Machowski. LCEF provided funding to support this.
- Montana District has four congregations that are subsidized mission foci of the District: Crow Lutheran Ministry, Circle of Life Lutheran Church, Emmaus Lutheran Mission and Redeemer Lutheran Church.
  - To support Indian ministry congregations, the Board directed \$308,494 in subsidies supporting Circle of Life, with \$4,146 sent in support from District congregations, and \$206,148 in subsidies supporting Crow Lutheran Ministries, with \$3,596 sent from District congregations.
  - Emmaus Lutheran Mission serving Big Timber and Livingston was begun in a previous triennium. This support has continued through this triennium. \$279,502 has been spent in support of this ministry as well as \$49,000 to assist in providing facilities for worship. MT District Congregations and individuals sent \$14,937 to the District office to support this subsidy, and LCEF supported the District subsidy in the amount of \$27,416.
  - During the Triennium, the BOD initiated a revitalization mission effort in Anaconda, Montana, through Redeemer Lutheran Church. The Montana District subsidizes this effort and has invested \$227,102. This subsidy was

- funded by MT District congregational support of the subsidy in the amount of \$1,919, and LCEF funding in the amount of \$9,616.
- Congregational convention assessments of \$45,100 were collected over the triennium, with \$26,976 expended for the 2018 District Convention and \$25,386 for the 2019 Synodical Convention.
- As directed through resolution 1-04 at the 2015 District Convention, the MT District sends support for missionaries called out of service in Montana District to the mission field. During the Triennium and 2021, the Board directed \$35,000 in support of 6 missionaries.
- In 2019, the District vehicle was destroyed by hail and replaced. The Board sets aside General Funds into a Vehicle Replacement Fund during every month with positive unrestricted net income to be prepared for such events, and the vehicle was replaced using these monies.
- The District office is moving locations in Billings. The BOD has signed a contract with Christ the King Lutheran Church, paying \$250,000 taken from the General Fund for 15 years rent in advance at a flat rental fee to rent office space in their new building, and anticipates moving into the facility in the Spring of 2022. The BOD plans to sell the current District facility within 2022.



To clarify, in this overture "division" is defined as standing apart, usually with some hostility. This is not to be confused with "difference", which is to acknowledge (and hopefully respect) that everyone is different in some way. For example, respecting that there is difference between female and male, and that there is blessing in the difference; whereas with division between female and male tends to lead to sexism and other abuses of one another.

WHEREAS, God created the human race, male and female, from one (Genesis 2:7 and Acts 17:26) in His image and likeness (Genesis 1:26-28), and, therefore, all people are equal by virtue of creation; and

WHEREAS, Because of Adam's disobedience, everyone is infected by sin and comes short of the glory of God, yet God gave His Son to reconcile to Himself all people (II Corinthians 5:19, John 3:16, and Genesis 3:15), and, therefore, all people are equal by virtue of Christ's redemptive work; and

WHEREAS, It is God's desire to have all people live in His salvation (Ezekiel 18:32, I Timothy 2:4, Titus 2:11 and II Peter 3:9) and, therefore, the Gospel is for all people; and

WHEREAS, Despite the fact that the only true division between humans is whether they are in Christ or not, because of our sinful nature, generally people throughout history have in some way divided into "us" and "them" based on many factors, such as, ethnicity, sex, physical characteristics, economic status, nationality, or "race", and

WHEREAS, Because of the continuum of sinful divisions, an "us" group is prejudice for its own group and is typically prejudice against "them" groups; and, when an "us" group has dominance, it will commonly mistreat the "them" groups by behavior ranging from apathy to paternalism to genocide, therefore be it;

*Resolved*, That we the people of the Montana District of the Lutheran Church Missouri Synod confess our sins of prejudice and divisiveness; and be it further

*Resolved*, That, as a fruit consistent with repentance, we the people of the Montana District strive, by the grace of God, always to respect all people for the potential of God restoring them to His image in Christ; and be it further

WHEREAS, The churches of the Lutheran Confession have diligently and respectfully followed the practice of frequent communion in the midst of a gathered local congregation served by local pastors who are "servants of Christ and stewards of the mysteries of God," (1 Cor. 4:1) as was handed down by Jesus to St. Paul and the first Apostles and to us; and

[83] But this "blessing" or the recitation of the Words of Institution of Christ by itself does not make a valid sacrament if the entire action of the Supper, as Christ administered it, is not observed (as, for example, when the consecrated bread is not distributed, received, and eaten but is instead locked up [in the tabernacle], made into a sacrifice, or carried around in a procession). [84] On the contrary, Christ's command, "Do this," must be observed without division or confusion. For it includes the entire action or administration of this sacrament: that in a Christian assembly bread and wine are taken, consecrated, distributed, received, eaten, and drunk, and that thereby the Lord's death is proclaimed, as St. Paul presents the entire action of the breaking of the bread or its distribution and reception in 1 Corinthians 10:16 [85] In order to preserve this true Christian teaching on the Holy Supper and to avoid and eliminate many kinds of idolatrous abuses and perversions of this testament, this useful rule and guide is taken from the Words of Institution: nothing has the character of a sacrament apart from the use [usus] instituted by Christ or the divinely instituted action [actio]. (That is, when Christ's institution is not observed as he established it, there is no sacrament.) This rule dare not be rejected in any way, but it can and should be followed and preserved in the church of God with great benefit.<sup>2</sup>; and

WHEREAS, It is not possible to provide in-person pastoral care or complete the "entire action or administration" of the sacraments "in a Christian assembly" when members of the congregation participate remotely using the internet or other electronic means; and

WHEREAS, The sacraments were instituted by Christ to destroy doubt and bring the certainty of His forgiveness; and

WHEREAS, "Virtual" or "online" communion, as it has been variously called, is a rejection of proper pastoral care and oversight, breaks the "useful rule and guide" established by our Lutheran Confession, and creates uncertainty, doubt, and a division of the local gathered body of believers and a division in practice between congregations; and

WHEREAS, The Council of Presidents unanimously adopted the resolution: "To Encourage Advocating In-Person Communion," wherein the final resolved encourages congregations and pastors "to refrain from the practice of online communion,"; therefore be it

WHEREAS, Christ our Lord says with regards to marriage, "What therefore God has joined together, let not man separate," (Matthew 19:6; Mark 10:9; cf. Genesis 2:24; 1 Corinthians 57:1lb); and

WHEREAS, The only exception given by our Lord is on the grounds of adultery, (Matthew 75:32; Matthew 19:9); and

WHEREAS, Men called into the Office of the Public Ministry are also called to be above reproach. Specifically with regards to marriage, this requires him to be the husband of no more than one wife, (1 Timothy 3:2; Titus 1:6); and

WHEREAS, Unbiblical divorce and remarriage disqualifies a man from the Office of the Public Ministry, (1 Timothy 3:2; Titus 1:6); and

WHEREAS, The decision whether or not to reinstate a former member of the Synod rests at the sole discretion of the Council of Presidents, (Bylaw 2.18.1); and

WHEREAS, The decision to declare applicants for colloquy to be qualified for the pastoral ministry and to certify such men for placement rests at the sole discretion of the Colloquy Committee for the Pastoral Ministry, (Bylaw 3.10.2.2.b); and

WHEREAS, In the action of reinstating or not reinstating a former member of the Synod, the Council of Presidents does so as an officially established advisory body of the Synod, (Bylaw 201.2.1.g); and

WHEREAS, By the actions of reinstating and colloquizing, the Council of Presidents and Colloquy Committee for the Pastoral Ministry, respectively, state that a man is qualified for the Office of the Public Ministry in The Lutheran Church-Missouri Synod. As this is an assignment given to them by the members of the Synod in convention (having been codified in the Bylaws of the Synod), they do so as representatives of the members of the Synod (Bylaw 263.10.1.4; Bylaw 2.18.1); therefore be it

*Resolved*, That the Council of Presidents not reinstate a man into the Office of the Ministry who has unbiblically divorced his wife; and be it further; and be it further

*Resolved*, That the Colloquy Committee for the Pastoral Ministry not colloquize a man into 30the Office of the Public Ministry who has unbiblically divorced his wife; and be it further

*Resolved*, That when a man is readmitted into the Office of the Public Ministry, the reason for readmission be articulated in official Synodical publications and the vote of each member of the Council of Presidents be made public; and be it further

*Resolved,* That when a man is colloquized into the Office of the Public Ministry, the reason for colloquization be articulated in official Synodical publications and the vote of each member of the Colloquy Committee for the Pastoral Ministry be made public, and be it finally

*Resolved*, That the Montana District in convention adopt this overture and submit it to the Synod Convention for adoption.

# To Restore the Binding Key to the Rites of Ordination and Installation of a Pastor

3 OVERTURE 5-03

 WHEREAS, Jesus says in Matthew 16:19, "I will give you the keys of the kingdom of heaven, and whatever you bind on earth shall be bound in heaven, and whatever you loose on earth shall be loosed in heaven." Again, He says in Matthew 18:18, "Truly, I say to you, whatever you bind on earth shall be bound in heaven, and whatever you loose on earth shall be loosed in heaven." And, in John 20:21-23, "Jesus said to them again, "Peace be with you. As the Father has sent me, even so I am sending you." And when he had said this, he breathed on them and said to them, "Receive the Holy Spirit. If you forgive the sins of anyone, they are forgiven; if you withhold forgiveness from anyone, it is withheld,"; and

WHEREAS, The ordination and installation rites in the TLH Agenda ask only three questions of the man to be ordained and installed and do not go into detail about the duties of the Christ's Office that he will perform, but asks only if the man intends to discharge those duties faithfully in accordance with the Scriptures and the Symbols of the Evangelical Lutheran Church, i; and

WHEREAS, The ordination and installation rites in the LW Agenda specifically include the reading of John 20:21-23 and expand the number of questions asked of the man being ordained and installed to six while also going into more detail about the duties of Christ's Office that he will fill, including explicitly mentioning the "loosing key" but omitting mention of the "binding key," and

WHEREAS, The ordination and installation rites in the LSB Agenda add a seventh question for the man being ordained and installed while making only a minor change in the wording of other questions and also explicitly mention the "loosing key" but continue to omit mention of the "binding key,"iii; and

WHEREAS, This omission of the "biding key" leaves out a significant portion of Christ's command and necessary Christian doctrine and may improperly teach the full extent of the pastoral office's responsibility; therefore be it

*Resolved*, That the MT District in Convention instruct the current and all future MT District Presidents to include these words in the rites of Ordination and Installation of Pastors: "and do you promise to retain the sins of those who are impenitent as long as they do not repent," when he or his agent conduct these rites; and be it further

*Resolved*, That the MT District in Convention request CPH to insert these words where necessary in all future additions of the Agenda, and to send out an erratum for all owners of current editions; and be it finally

*Resolved*, That the MT District in Convention petition the Synod in Convention to make this resolution its own.
