President Forke adjourned the convention in the Name of the Father and of the + Son and of the Holy Spirit.

# "Thy Word" President's Report 2022 Montana District Convention

Unmoored- our nation has been chewing away at the line that has provided safe anchor from the beginning. For centuries believers and unbelievers alike had some sense that the Word of God contained wisdom that stood the nation and its citizens in good stead. No more! We are completely unmoored from God's Word. No one outside of the Church any longer finds value in God's Word. What is more, huge swaths of "the Church" have abandoned God's Word for their own understanding. Without this anchor we are subject to the wind, waves, tides, and terrors of this world. The authors of the Formula of Concord rightly reminded us that the Word of God is a lamp to our feet and a light to our path. Let's take a few minutes to look at what Psalm 119, the source of our theme verse, has to say about the Word of God.

#### I. His Word.

- A. God's Word gives life.
  - 1. "My soul clings to the dust; give me life according to your word!" V25
  - 2. "I am severely afflicted; give me life, O LORD, according to your word!" V 107

The Word of God created all life in the beginning when He spoke it into existence. His Word alone gives life when it is spoken as the Gospel of Jesus Christ. As you receive physical life by God's creation, so you receive spiritual life when He creates faith in Christ in you by the power of His Word.

- B. God's Word never changes.
  - 1. "Forever, O LORD, your word is firmly fixed in the heavens." V89
  - 2. "The sum of your word is truth, and every one of your righteous rules endures forever." V160

The Word of God is the only permanent fixture of truth upon which we can build our lives. Our culture presses science forward as the final arbiter of truth, but this can only lead you away from the truth of God's Word. Scientific truths change from age to age as observations change, but the Word of God is always true and fixed by God's command.

- C. God's Word directs our life.
  - 1. "Your word is a lamp to my feet and a light to my path." V 105
  - 2. "The unfolding of your words gives light; it imparts understanding to the simple." V 130

Book stores are crammed full of self-help tomes. The Word of God does not teach you how to help yourself. It teaches you how God has helped you through the work

of Jesus and how it continues to help you by strengthening your faith. He provides the answers you need to live your life in faith in Jesus who is the light of the world.

- D. God's Word gives salvation.
  - 1. "My soul longs for your salvation; I hope in your word." V 81
  - 2. "You are my hiding place and my shield; I hope in your word." V 114

The Word of God teaches the way of salvation through faith in Jesus Christ. Faith means to see what can be only seen through faith. It is not based on evidence, but on the Word of God. Consequently, Christians are alive in hope. We hope in Jesus to have all that we need for this life and the next.

- E. God's Word gives strength
  - 1. "My soul melts away for sorrow; strengthen me according to your word!" V 28
  - 2. "Then shall I have an answer for him who taunts me, for I trust in your word." V42

Do you sometimes get weary with the drag and stress of this daily life? Where do you turn for strength? The psalmist reminds us that the Word of God is our strength. We cannot find strength in ourselves or in our own words. Likewise, the words of worldly voices may sound cute, and perhaps even wise, but only the Word of God can give the strength you need to endure in faith through this sinful world.

- F. God's Word gives joy.
  - 1. "How sweet are your words to my taste, sweeter than honey to my mouth!" V103
  - 2. "I rejoice at your word like one who finds great spoil." V 162

The world depends on happiness to make it through the day. Happiness, however, is dependent on the circumstances of this life. If the circumstances are not what you envisioned, you will not be happy. Joy is not based the circumstances of life, but on the Word of God. We hear that we are forgiven in Jesus, and we rejoice despite the circumstances of life.

#### II. His Word in the Church

As the pressures on the Church grow as result of living in a world that is less respectful of the faith, it will become more and more significant that Christians are steeped in the Word of God. It is the only source of strength, peace, and endurance for the days ahead. This is why we listen to the Word during the Sunday services and bible class. This is why we attend weekly bible studies and hold family devotions. That is why, even at district conventions we devote so much time to the study of God's Word.

The problem is that sinners forget God's Word. Even in the most dramatic of circumstances we can forget what God has said to us. The ladies went to the tomb on Easter morning and the angel said, "Why do you seek the living among the dead? He is not here, but has risen. Remember how he told you, while he was still in Galilee, that the Son of Man must be delivered into the hands of sinful men and be crucified and on the third day rise." Luke 24:5–7. If the ladies who cared for Jesus had to be reminded of His Word how much more so do we, who in the busyness of our lives lose track of what He has to say to us, need to be reminded.

This is one reason that God invented the Office of Pastor. God sends Pastors to congregations to remind us of His Word, to deliver the gifts of Word and Sacrament so that we can regularly hear what God has to say to us. Pastors, as God's stewards, not only speak to the church members God has given them, but they also speak to a world that is lost in sin. Teachers in our Lutherans schools also teach God's Word daily to the children in their care.

Much has been written about how the Church is in decline. While the number of Americans who claim to be Christians fell from 70% in 1950 to 60% in 2020, the overall percentage of Americans attending church fell from 23% to 8% during the same time period. Furthermore, the number of Americans claiming no religious affiliation grew from 36 million in 2007 to 56 million in 2014. Estimates are that 3500 people are leaving the church every day.

One perspective on this decline is to wring our hands, descend into a depression, and calculate the days until the Church disappears. On the other hand, we could begin to calculate how many people need to hear about Jesus. The answer, of course, is all of them. This ought to remind us that Jesus said, "The fields are white for the harvest." John 4:35 There is much for us to do.

When Jesus contemplated the harvest of those who were yet to know Him, He did not wring His hands. Instead, He folded them, and encouraged you to do likewise. "The harvest is plentiful, but the laborers are few. Therefore, pray earnestly to the Lord of the harvest to send out laborers into his harvest." Luke 10:2

In 2022 we can again say that the laborers are few. From 2004 to 2018 enrollment for pre-seminary (undergraduates) students declined 59% and for Lutheran school teacher 61%. Enrollment at the seminaries has declined 55%.<sup>2</sup> Furthermore, 44% of active ordained men are over 55 years of age.

With these statistics in mind The Lutheran Church—Missouri Synod has initiated a program entitled "Set Apart to Serve" (SAS). It's goal is to encourage young men and women to go into full time church work. The program's early research has found that the top four influences that lead young people into church work are: Pastors, Commissioned workers, Family, Lutheran School teachers. They have also discovered that youth going into church work are generally deciding in late middle school to early high school years. Resources for this program can be found at the LCMS website.

Dear brothers and sisters in Christ, Church workers, parents, grandparents, congregational members, for the sake of the proclamation of the Gospel please prayerfully consider how you may encourage young people to consider church work. I sincerely hope that this convention will adopt a resolution encouraging congregations to participate in "Set Apart to Serve."

#### III. His Word in the Home.

Worldly pressures are not only growing on the Church but also on the Christian family. There are forces that have proudly, publicly announced their desire to eradicate the nuclear family. These are generally anti-marriage forces. They believe that marriage harms their opportunities to function in the world as they desire. Christian families have only begun to feel this force. A more ubiquitous, if not widely recognized, force is that of extra-curricular activities that compete with Christian worship and education and fracture the family with a constant busyness. Many Christian parents have been convinced by the spirit of the age that they are being good parents when they enroll their children in multiple activities that just happen to preclude attendance at Sunday worship or catechism instruction. Somehow making it into a good university, or gaining a scholarship, has become more important than investing in an eternal welfare.

In contrast, listen to what God says about the responsibilities of parents. God commands parents to train children in the Word. "Fathers, do not provoke your children to anger, but bring them up in the discipline and instruction of the Lord." Ephesians 6:4 Long before Paul, Moses wrote, "And these words that I command you today shall be on your heart. You shall teach them diligently to your children, and shall talk of them when you sit in your house, and when you walk by the way, and when you lie down, and when you rise. You shall bind them as a sign on your hand, and they shall be as frontlets between your eyes. You shall write them on the doorposts of your house and on your gates." Deuteronomy 6:6–9. At its 2019 convention The LCMS called for parents to take these texts to heart in its Resolution 12-03a "Resolved, that congregations should encourage and train parents, guardians, and members to be active teachers and life-long learners of the faith..." (Emphasis added)

If Christian parents were to take this charge seriously perhaps we could head off a looming crisis. The family is in trouble in the United States. Although there is ample evidence, very few people seem to admit the significance of the father of the family actively living the Word of God.<sup>3</sup> If a father does not go to Church, even if the mother does only 2% of the children will become a regular worshipper in adulthood. If a father does attend, regardless of what the mother does over 66% of the children will become regular worshippers. If a mother is the first person in a family to become a Christian, there is a 17% probability the household will follow. If a father is the first person in a family to become a Christian, there is a 93% probability that the household will follow. These hard statistics are not meant to diminish the role of the mother, they are simply a much-ignored reality.

These statistics also reflect how households in America have changed. Fewer than 25% of households are traditional nuclear families.<sup>4</sup> Our Lutheran school Teachers experience the fallout of this truth daily. They are also undoubtedly aware that 33% of American children are born out of wedlock.

How can Christian parents prepare their children for life with Jesus while at the same time help fend off the decline of our culture? The answer is not rocket science. Simply put, do what our Father has told us to do, read, study, and discuss His Word in our families. Consider the following statistics. If the Word of God is not taught and discussed in the family around 20% of the children will continue in the faith. If the Word of God is taught and discussed in the family around 65% of the children will continue in the faith. When both parents attend Sunday School 72% of their children will attend Sunday School when grown. When neither parent attends Sunday School 6% of their children will attend when grown. I sincerely hope that this convention will adopt a resolution encouraging, and equipping parents to raise their children in the faith.

#### IV. His Word in the Lutheran School.

One of the most overlooked jewels in The Lutheran Church—Missouri Synod is our Lutheran schools. These schools cannot take the place of Christian parents, but they are a marvelous supplement, and are pledged to the teaching of God's Word. We all know and agree that religion cannot be taught in public schools, but Lutheran Schools are places where God's Word is taught in every subject. Even if you do not have school age children you should be aware that our Lutheran Teachers seek to relate the Word of God to every subject taught in school. Jesus is not relegated to "religion" class. He is real in every subject.

In addition to godly subject matter, Lutheran Schools are also places where teachers model the love of Christ. Children are not subjected to the latest fads of the godless world in Lutheran schools. Instead, they are taught to avoid the ways of the world. This is not only taught. It is modelled in the words and lives of their teachers. Sometimes these attitudes are more readily caught than taught.

Lutheran Schools do not drive a wedge between the students and their parents. They are places where families are supported through the Word. A lateral benefit of Lutheran Schools is that because they follow the Word of God, they are also in the process of encouraging and enabling families to function as God calls them to function. I sincerely hope that this convention will adopt a resolution encouraging the support of our Lutheran grade and high schools.

One more issue should be drawn to your attention. Lutheran Schools depend on orthodox education of their teachers. I have already noted the dire statistics regarding the number of Lutheran Teachers available. This is not a matter of numbers only. Many of you will be aware of the difficulties that our LCMS universities have been experiencing. Most of them are educating a very low percentage of Lutheran Church workers. Some have struggled with outside forces like gender-theory and critical race

theory. If their primary objective is not to educate Lutheran Church workers, the pressure to compromise His Word in favor of one program or another is great. At our 2018 Montana District convention we adopted a resolution calling for a study of our LCMS universities. It was not acted on by the 2019 Synodical convention. I sincerely hope that this convention will adopt a resolution calling for a thorough study of the LCMS university system, with an eye toward prioritizing the education of Lutheran Church workers.

#### Conclusion

Dear brothers and sisters, I conclude by encouraging you not to despair. Despite the severe statistics I have shared, we know that God's Word is victorious. The Word was put in the tomb once before, but death could not hold it there. He is risen! "For the word of God is living and active, sharper than any two-edged sword, piercing to the division of soul and of spirit, of joints and of marrow, and discerning the thoughts and intentions of the heart. And no creature is hidden from his sight, but all are naked and exposed to the eyes of him to whom we must give account." Hebrews 4:12–13.

This sword is at work in you and in the world, and it will continue to be victorious. You can always depend on it for it is truly a lamp to your feet and a light to your path

# District President Oral Report 35<sup>th</sup> Montana District Convention 2022

# I. The Word of God is living and active.

"For the word of God is living and active, sharper than any two-edged sword, piercing to the division of soul and of spirit, of joints and of marrow, and discerning the thoughts and intentions of the heart."

(Hebrews 4:12)

The English language comprises around one million words at present. The average American adult uses about 42,000 of them at his prime. That means the average English speaker uses about 4% of the words that are available to him. Nonetheless, words play a major role in our everyday lives. We are constantly using words. On one level we comprehend their power. We know they can be used for good or evil. We understand that words can whip a crowd into a frenzy of mob action, or they can calm and give peace in the midst of turmoil.

What we may never consider is the deficiencies of our words, what they cannot do. Our words cannot create or sustain life. They cannot peer into the soul of a man and discern the thoughts and intentions of his heart. These powerful functions are reserved for the Word of God. Imagine, for a moment a Word so powerful that, when spoken, can bring a universe into existence. Imagine a Word so powerful that, when believed, can raise a cold, dead, sin-drenched heart from the tomb of damnation to the throne of heaven where it becomes a living, breathing child of God. Imagine a Word so powerful that it can cause humans to see themselves as they really are, a Word that can direct all of humankind to a more meaningful, life of love for God and neighbor.

You don't have to imagine such a Word because you already hold it in your hands and in your heart. This is the Word of God. It is living and active, according to the writer to the Hebrews. Not only does it have life in it, but it also brings about life. It doesn't stir a foul furor of useless activity. The Word of God is always active toward faith in Jesus and life in His name. This you have witnessed in your own life. When the Word of God was spoken over you in your baptism its life, its energy was directed toward bringing you to eternal life through faith in Jesus.

The work of The Lutheran Church—Missouri Synod is not to proclaim this powerful Word, (although that does happen incidentally). The synod is not the Church. The work of the synod is to support the congregations and church workers who are responsible for the proclamation of the Word. Sometimes, I hear people talk about "the synod" as if it is above the congregations. This should never be true. The synod exists only to assist congregations in various ways. As the president of the Montana district today I report to you some of the ways that the synod works to support the work of the Word that you church workers and lay people are doing every day.

# II. The Montana district supports the work of the Word through finances.

I am sure that it is difficult for you to know about or to remember all that the district does for the congregations and church workers. I want to remind you of this activity not for the purpose of drawing attention to the district, but in order to put the work of the district in the context of the work of the Word of God. It is the sincere desire of the leadership of the Montana district that all that it does is focused on supporting the congregations and church workers as they go about the work of the Word where God has placed them.

#### **Gifts**

From time to time the physical needs of congregations get in the way of their efforts to proclaim the Word. Furnaces fail, roofs rot, and sidewalks sag. That is the way of life in a sinful world. The district is in a position to help with these needs through gifts to congregations when something goes wrong. Our Mission and Ministry fund, for these purposes is strong. Various congregations have asked for and received help from the district for these types of needs.

In addition, the district has helped facilitate gifts from one congregation to the next. Congregations that have been blessed with an abundance have called me to ask if there are any congregations that are in particular need. It is a great joy to observe brothers and sisters caring for each other's needs in this way.

#### Grants

Lutheran Schools- The Montana district has a Schools Grant Fund through which grants are given, upon application, to support the work of the Word in our schools. The Montana district has six elementary schools and fourteen preschools that may benefit from this fund. The fund provides around \$5,000 a year in grants.

Church worker student loan repayment- I am sure you are aware that student indebtedness is a big problem. For church workers who come out of college and seminary owing thousands of dollars for their education this debt can prove debilitating. They may feel pressure to move to a larger congregation where they might be better able to handle their payments.

The Montana district has a program to help church workers with student loan repayments. Every year we give away around \$30,000 to help repay loans.

#### Missionaries

In the past four years the Montana district has helped support five long-term and two short-term missionaries of the synod in the amount of \$51,900. The Board of Directors determined this was not only a good way to support the work of the Word but also a good example to the congregations of our district.

# **Scholarships**

Church workers- Educating church workers is a primary function of the synod. If we do not have enough church workers, which at present we do not, (see my written report page 34) the work of the Word will suffer. Education is expensive, so, the Montana district maintains a sizable fund to grant scholarships to students committed to church. Each year we give away around \$30,000 in scholarships to students who are committed to studying for full-time church work.

Lutheran school students- Sending your children to one of our Lutheran elementary schools is also expensive. We believe in our schools, so at the last district convention a fund was established to help schools have some money to offer to families that would like to attend a Lutheran school but need help. Each year we give around \$3000 to help students attend these schools.

#### Subsidies

The Montana district supports four ministries through heavy subsidies. The members of these congregations certainly do their part to keep their congregations going, but the circumstances are such that they cannot do it on their own. That is where the district comes in. The district is able to distribute resources in such a way that tiny strategically located congregations can be supported.

#### Anaconda- Redeemer

We began work at re-invigorating this congregation in 2018. Anaconda is sixth largest community in Montana. We think it is important to be represented there. Pastor Jim Pierce serves.

#### Big Timber/Livingston-Emmaus

We began work in this field as an intentional dual-parish. Recently, the congregation determined that the work in Big Timber was not proving fruitful and regrettably, they closed that wing of the congregation. The work of the Word in Livingston, however, is growing strong.

# Crow Agency- Crow Lutheran Ministries

Indian ministry began in the 1970s in Montana. For 50 some years the district has consistently agreed, despite the difficulty of advancing the Gospel on the Crow and Cheyenne reservations, that these are places that need extra care for the work of the Word to continue. Each reservation represents a large isolated population that needs to hear about Jesus. Pastor Dan Jacobs serves Crow.

#### Lame Deer- Circle of Life

Pastor Dennis Bauer serves Lame Deer.

#### Disclaimer

The Montana District Board of Directors does its best to support the work of the Word through financial assistance. Obviously, everyone will not agree on the decisions of the Board, but the directors are good men that you have elected. They are always striving to make godly decisions. Please keep them in your prayers.

### III. The Montana district supports the work of the Word through visitation.

One of the primary duties of a synod is what goes by the name of "ecclesiastical supervision." The term means that congregations of The LCMS can depend on the synod to supervise the doctrine and behavior of both church workers and congregations.

The chief mechanism of seeing to this supervisory responsibility of the synod is the visitation program of the district president. Every triennium the district president visits the congregations, the schools and the church workers of the district. The idea is that through presence and teaching the district president reminds congregations and church workers that they are not alone. They are apart of the larger body, the Church. Congregations and church workers need to be reminded that no matter how remote, how small, or how unpromising their work seems to be, they are an important part of the work of the Word. Whether proclaiming to hundreds or tens, God uses His people to speak the truth of His Word into the world.

The visitation of the district president is ultimately focused on the work of the Word. How is the congregation proclaiming the Gospel? How are the church workers doing the same? What are the unique characteristics of this community that create opportunities for God's Word to be spoken and heard? What hindrances are they experiencing, and what can the district do to help them move forward? Without a visitation program congregations may tend to feel alone and isolated, and church workers may feel as if no one cares. They may forget they are part of the larger confession. Pressures may move them in the direction of thinking only of the benefits to their congregation. These pressures do not benefit the work of the Word. The district president visits for the sake of the proclamation of the Word of God.

#### IV. The Montana district supports the work of the Word through conflict resolution.

Conflict is a normal part of life in a sinful world. Congregations and church workers sometimes end up at odds with each other. The synod has developed the office of district president as the primary guardian of doctrine and practice. This office then, is often the first resource within the synod for dealing with conflict. The intent is to bring healing for the sake of the work of the Word. If a church worker is behaving in an ungodly manner, or is teaching falsely, the congregation may need help to bring the worker to repentance. The district president is careful, on the one hand to protect congregations from church workers who would harm the work of the Word.

On the other hand, if a congregation is behaving in an ungodly manner, or is insisting on false teaching, the church worker may need help in bringing the congregation to repentance. In that case the district president works to protect the church worker from a congregation that would harm the work of the Word.

The goal is confession and absolution, and this powerful tool is often put to use so that the work of the Word can be restored in an effective manner. Conflict is never easy, but God works in mysterious ways. Through difficult times our faith is often strengthened. There are moments when we see God at work to save us. Conflict is often one of those moments, although we rarely think of it as a way that God uses to promote the proclamation of the Word. In that we would be wrong. Avoiding all conflict does not serve the proclamation of the Gospel.

#### V. The Montana district supports the work of the Word through representation.

I am convinced that the Montana district has much to say to The Lutheran Church—Missouri Synod. The congregations and church workers of this district are deeply devoted to the Word of God and the Lutheran Confessions. This devotion to the Word, and the relationships between church workers based on the Word, has historically, preserved us from faddish influences of the world. The solid body of work offered to the synod by the previous district president, the sainted George Wollenburg has secured the Montana district a reputation for truth telling.

I have striven to maintain this reputation by representing the Montana district at all meetings on a synodical level. Chief among those are the meetings of the Council of Presidents. This quarterly meeting of the 35 district presidents as well as the President and vice-presidents of the synod usually runs around 5 days. During that time we study the Scriptures and Confessions, as well as manage the roster of church workers, deal with discipline, and plot strategy for the work of the Word. In all of these areas as well as others that occur from time to time, it is good for the synod to hear from the representative of the Montana district.

The voice of the Montana district is also heard by the LCMS through the work of this body. Solid, biblical, and common sense resolutions have flowed from the Montana district convention to the synod convention for decades. This convention will be no different.

The Montana district is represented to the LCMS not for the sake of its reputation, but for the sake of the proclamation of the Word. This opportunity is a great blessing, and by God's grace it will benefit the work of the Word.

# VI. The Montana district supports the work of the Word through a common confession.

Look around you dear brothers and sisters. In this room are delegates from the 68 congregations of the Montana district. They are more than delegates. They are brothers and sisters in the family of God. They are more than brothers and sisters,

because all believers are so. These brothers and sisters hold the same confession of faith that you hold. That unity is a tremendous, if often overlooked blessing. I want to emphasize here how much we need each other. As the pressures rise on Christians to compromise the Word, I think we will find that we need each other more and more. There is great value in the encouragement we gain from each other to stay strong in the Word. It is easy to see this at times like this when we are all together. Remember this moment. Strive to maintain the unity of the faith, and to build each other up in love and good works. Pray for each other. Love at all times.

There is a tendency for every congregation to be primarily concerned with its own needs and desires, to make decisions that benefit its own bottom line. Focusing on the work of the Word upends the priority list. We are 68 congregations working together to enhance the pure proclamation of the Word in the area of the country that God has given to us. If the common confession gains the priority in the Montana district some decisions may be influenced in a different direction. This already happens but I am calling for us to be more mindful of the need.

For example, I was present when a triple parish was setting its budget for the year. The representative of one of the congregations stood up and said, "Our congregation has had a really good year. We know that your congregation has not had such a good year. This year we would like to shoulder a bit more of the financial burden in order to help you get back on your feet." I tell you that I had tears in my eyes on that day. Were purer words of concern for the common confession ever spoken?

We want the Word to be proclaimed in its truth and purity. We know that our confession does that, so we look to expand its reach. When we look at the map of Montana there are certain areas where the LCMS is not well represented. This concern for the common confession has everything to do with the work of the Word. It drives a strategic program for where we want to maintain congregations and where we want to open new ones. Today, we celebrate this common confession. We rejoice that God has brought us together in such a way that we agree to speak and act in accordance with the Word of God as confessed in the Lutheran Confessions.

So, I encourage you to cherish this moment. Use this week to develop lasting relationships with brothers and sisters from across the district. Get out of your comfort zone and introduce yourself to delegates you don't know. Ask them about their own lives and about the conditions of their home congregation. This is not just an exercise in human relations. This is about the work of the Word. I am certain that we will need each other when persecutions come. Now is a great time to lay a foundation for helping one another in the future work of the Word.

Look around you dear brothers and sisters. You are the Church, and God has given you to each other, and to the work of the Word.

#### VII. The Word of God does not return void.

This mustard seed of a Word is a small thing in the eyes of the world. It does not seek political or personal power. It does not compromise itself for the sake of success.

It does not make financial profit a priority. It is the still small voice of the Spirit that changes hearts and minds by creating faith in Jesus. This is the work of the Word, faith in Jesus.

This Word does not always make sense to us. Why is it so difficult to support our church workers and our congregations? Why are so many of our congregations getting smaller? Why do people no longer want to attend Sunday services? Why does the world suddenly hate us? It may not always make sense, but it always accomplishes what God wants even if we don't understand or recognize what it has done. This is the foundation and goal of all that we do in the Montana district. We trust the Word of God to do the work God promised it would do, and we ask Him to bless our work to that end.

Hear the Word of the Lord through the mouth of the prophet Isaiah, and find comfort in this truth.

For my thoughts are not your thoughts, neither are your ways my ways, declares the LORD.

For as the heavens are higher than the earth, so are my ways higher than your ways and my thoughts than your thoughts. "For as the rain and the snow come down from heaven and do not return there but water the earth,

making it bring forth and sprout, giving seed to the sower and bread to the eater, so shall my word be that goes out from my mouth;

it shall not return to me empty,

but it shall accomplish that which I purpose, and shall succeed in the thing for which I sent it.

Isaiah 55:8-11.

Title: To Prayerfully and Financially Support Shepherd of the

Valley (Salmon, ID) Lutheran Church's Mission Ministry to

the People of Challis, ID

**Action: ADOPTED** 

WHEREAS, Jesus Himself gives us the command to "Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, teaching them to observe all that I have commanded you" (Matt 28:19); and

WHEREAS, The 2019 LCMS Convention passed four National Witness resolutions, including Res. 1-02, "To Encourage the Planting of Churches"; and

WHEREAS, Shepherd of the Valley Lutheran Church in Salmon, Idaho, has a history over the past decades of providing mission ministry and prayer support to the people of Challis, Idaho (60 miles upriver, south of Salmon); and

WHEREAS, There is a current need for mission work to the people of Challis; and

Whereas, The congregation of Shepherd of the Valley has been conducting worship services in the Challis Community Church twice a month since Easter of 2021, with an average attendance of 18.5 people, making it the highest attended worship service of any Christian denomination in Challis; and

WHEREAS, The congregation of Shepherd of the Valley has recently voted to expand the mission ministry efforts to the people of Challis to include weekly worship services, confirmation classes, Sunday School, and, God willing, the eventual planting of a new LCMS church; and

WHEREAS, The congregation of Shepherd of the Valley has thus far been the sole provider of all pastoral support, worship assistance personnel, worship service materials/resources, time, travel, and financial resources; and

WHEREAS, The Montana District President has obtained the blessing from the Northwest District President for the expansion of mission work into this area of Idaho; therefore be it

RESOLVED, That all congregations in the Montana District be encouraged to diligently pray for the mission work that the Holy Spirit is doing in the people of Challis through Shepherd of the Valley Lutheran Church in Salmon; and be it finally

RESOLVED, That—when and if needed—financial assistance from the Montana District be provided at the Board of Directors' discretion to help defray the costs of needs to support a mission in Challis, including, but not limited to: renting, heating the place of worship, supplies, and travel costs.

Title: To Encourage Coordination within Circuits for the Mutual

**Benefit of Congregations** 

**Action:** ADOPTED

WHEREAS, "A visitation circuit is a network of congregations that 'walks together' for mutual care, support, advice, study, ecclesiastical encouragement, service, coordination, resources, and counsel—all for the sake of greater congregational participation in God's mission" (LCMS 2019 Handbook, bylaw 5.1.1); and

WHEREAS, The circuit gathers together in forum for its mutual benefit and encouragement in said work and outreach; and

WHEREAS, Congregations within each circuit, blessed by God in many and various ways, are in position to support one another to meet local needs; therefore be it

*Resolved,* That circuits working through the Circuit Forum evaluate shared needs, hardships, and opportunities; and be it finally

*Resolved*, That the 2022 Montana District Convention encourage the circuits working through the Circuit Forum to coordinate opportunities for partnership, such as, but not limited to, Vacation Bible School, pulpit supply, support for new and ongoing missions, and needs that arise due to vacancies.

Title: To Invite Congregations to Utilize "Set Apart to Serve"

**Action: ADOPTED** 

WHEREAS, The pressure is growing on the Church as a result of living in a world that is less respectful of the Christian faith; and

WHEREAS, The need for pastors and church workers is urgent, as studies show that because of the significant number of pastors reaching retirement age, we will see the number of ordained pastors decline from 6,000 to 3,000 over the next fifteen years; and

WHEREAS, From 2004 to 2018 enrollment for pre-seminary (undergraduate) students declined 59% and for Lutheran school teachers 61%; enrollment at the seminaries has declined 55%, and 44% of active ordained men are over 55 years of age, according to "Set Apart to Serve" research; and

WHEREAS, Research shows that the top four influencers that lead young people into church work are: ordained and commissioned workers, Lutheran school teachers, and families; and

WHEREAS, The Lutheran Church—Missouri Synod has initiated a program entitled "Set Apart to Serve," the purpose of which is to encourage young men and women to go into full time church work; therefore be it

*Resolved,* That the Montana District in convention invite congregations of the District, the ordained and commissioned workers, Lutheran school teachers, and families to utilize "Set Apart to Serve" as they encourage young men and women to enter church work vocations.

Title: To Create an Online Alternative Leading Toward Ordination and

**Full Master of Divinity Degree** 

Action: NOT ADOPTED

WHEREAS, God's Word calls us to pray for additional workers in the harvest, "When [Jesus] saw the crowds, he had compassion for them, because they were harassed and helpless, like sheep without a shepherd. Then he said to his disciples, 'The harvest is plentiful, but the laborers are few; therefore pray earnestly to the Lord of the harvest to send out laborers into his harvest'" (Matthew 9:36–37, ESV); and

WHEREAS, the reformers write in Treatise on the Power and Primacy of the Pope that the local church is granted the rite of ordination, "[Christ] grants the power of the keys principally and without mediation to the church, and for the same reason the church has primary possession of the right to call ministers" (Treatise, 24); and

WHEREAS, The need for pastors and church workers is urgent, as studies show that because of the significant number of pastors reaching retirement age, we will see the number of ordained pastors decline from 6,000 to 3,000 over the next fifteen years; and

WHEREAS, From 2004 to 2018 enrollment for pre-seminary (undergraduate) students declined 59% and for Lutheran school teachers 61%; enrollment at the seminaries has declined 55%, and 44% of active ordained men are over 55 years of age, according to "Set Apart to Serve" research; and

WHEREAS, Rev. Dr. James Baneck, in his August 2021 article "Understanding the Church Worker Recruitment Initiative" wrote, "Yet, we are not driven by fear but hope. We raise up workers in the church not to sustain institutions but to serve the church"; and

WHEREAS, the congregations of the Montana District LCMS give thanks to God and celebrate the various alternate routes to ordination and pastoral ministry available in the LCMS, there is a growing need for general ordination pastors who are able to receive divine calls from congregations without restriction, provide supervision for other rostered church workers, supervise vicars, hold elected or appointed office on the district or national Synod level such as a Circuit Visitor, and vote as delegates at the Synodical conventions of the church; and

WHEREAS, there are pathways by which pastors, from church bodies outside the Lutheran Church-Missouri Synod, who meet specific criteria may secure admission to

the ministerium of the LCMS as general ordination pastors through Colloquy. This admission may be provided through a "colloquy" (discussion, interview) with the Colloquy Committee for the Pastoral Ministry; therefore be it

Resolved, to encourage the Montana District in convention to support the exploration of an online and remote option leading to ordination and a full Master of Divinity degree; and be it finally

Resolved, the Montana District in convention memorialize the LCMS to be gathered in convention in 2023 by submitting this resolution to same.

President Forke report, §II MT Dist. Convention Handbook, pp. 33–35

Title: To Develop a Bible Study to Address Divisions and How

That Issue Impedes the Service of the Gospel

Action: NOT ADOPTED

To clarify, in this overture "division" is defined as standing apart, usually with some hostility. This is not to be confused with "difference", which is to acknowledge (and hopefully respect) that everyone is different in some way. For example, respecting that there is difference between female and male, and that there is blessing in the difference; whereas with division between female and male can lead to conflict and harm of one another.

WHEREAS, God created the human race, male and female, from one (Genesis 2:7 and Acts 17:26) in His image and likeness (Genesis 1:26-28), and, therefore, all people are equal by virtue of creation; and

WHEREAS, Because of Adam's disobedience, everyone is infected by sin and comes short of the glory of God, yet God gave His Son to reconcile to Himself all people (II Corinthians 5:19, John 3:16, and Genesis 3:15), and, therefore, all people are equal by virtue of Christ's redemptive work; and

WHEREAS, It is God's desire to have all people live in His salvation (Ezekiel 18:32, I Timothy 2:4, Titus 2:11 and II Peter 3:9) and, therefore, the Gospel is for all people; and

WHEREAS, Despite the fact that the only true division between humans is whether they are in Christ or not, because of our sinful nature, generally people throughout history have in some way divided; therefore be it

*Resolved,* That the Montana District President or his designee develop a Bible study which may be used in Circuit forums over the next triennium to address the issue of divisions and how that issue impedes the service of the Gospel.

TITLE: To Emphasize the Teaching of Law and Gospel

**Action: ADOPTED AS AMENDED** 

WHEREAS, The Montana District devoted time to the study of the Formula of Concord, Epitome at its 2022 District Convention; and

WHEREAS, This confession placed special emphasis on the teaching of the Law and the Gospel by saying, in part, "We believe, teach and confess that the distinction between the Law and the Gospel is to be kept in the Church with great diligence as a particularly brilliant light." (Formula of Concord Epitome Art. V.); and

WHEREAS, Without the proper distinction of Law and Gospel the Holy Scriptures remain a closed book<sup>1</sup>; and

WHEREAS, The suggestion has been made that "two kinds of righteousness" is a better paradigm than law and gospel for preaching and teaching, which suggestion has caused discussion around our synod; and

WHEREAS, The law/gospel structure of sermons has been cast as outdated in some circles, in favor of more creative rhetorical approaches; and

Whereas, As few as 34% of the teachers in the K-12 school of our Synod are rostered Lutheran teachers²; and

WHEREAS, This "particularly brilliant light" offers a key understanding of the "Good News" to both catechumens and seasoned believers; therefore be it

*Resolved,* That delegates to the 2022 Montana District Convention rejoice in being renewed in this article of doctrine by sharing it in their reports to their congregations; and be it further

*Resolved,* That Pastors and teachers of the Montana District be encouraged to keep this teaching with great diligence through proper instruction and supervision; and be it further

*Resolved,* That pastors of churches in the Montana District which operate schools engage with school leaders to ensure that teachers are instructed in the proper application of Law and Gospel in teaching; and be it finally

*Resolved,* That pastors of churches in the Montana District which operate schools engage with school leaders to ensure that teachers receive adequate supervision in the proper application of Law and Gospel in teaching.

Title: To Reject and Condemn the Practice of Virtual (online)

Communion

Action: ADOPTED AS AMENDED

WHEREAS, The churches of the Lutheran Confession have diligently and respectfully followed the practice of communion in the midst of a gathered local congregation served by local pastors who are "servants of Christ and stewards of the mysteries of God," (1 Cor. 4:1) as was handed down by Jesus to St. Paul and the first Apostles and to us; and

WHEREAS, These local pastors "are to be found trustworthy" (1 Cor. 4:2) and have vowed "to administer the holy sacraments in accordance with their divine institution," and

WHEREAS, Our Lutheran Confession teaches specifically regarding Holy Communion:

[83] But this "blessing" or the recitation of the Words of Institution of Christ by itself does not make a valid sacrament if the entire action of the Supper, as Christ administered it, is not observed (as, for example, when the consecrated bread is not distributed, received, and eaten but is instead locked up [in the tabernacle], made into a sacrifice, or carried around in a procession). [84] On the contrary, Christ's command, "Do this," must be observed without division or confusion. For it includes the entire action or administration of this sacrament: that in a Christian assembly bread and wine are taken, consecrated, distributed, received, eaten, and drunk, and that thereby the Lord's death is proclaimed, as St. Paul presents the entire action of the breaking of the bread or its distribution and reception in 1 Corinthians 10:16 [85] In order to preserve this true Christian teaching on the Holy Supper and to avoid and eliminate many kinds of idolatrous abuses and perversions of this testament, this useful rule and guide is taken from the Words of Institution: nothing has the character of a sacrament apart from the use [usus] instituted by Christ or the divinely instituted action [actio]. (That is, when Christ's institution is not observed as he established it, there is no sacrament.) This rule dare not be rejected in any way, but it can and should be followed and preserved in the church of God with great benefit.<sup>2</sup>; and

WHEREAS, It is not possible to provide in-person pastoral care or complete the "entire action or administration" of the sacraments "in a Christian assembly" when members of the congregation participate remotely using the internet or other electronic means; and

WHEREAS, The sacraments were instituted by Christ to destroy doubt and bring the certainty of His forgiveness; and

WHEREAS, "Virtual" or "online" communion, as it has been variously called, is a rejection of proper pastoral care, negates the ability to practice the immediate Pastoral oversight of confession of sins and faith, breaks the "useful rule and guide" established by our Lutheran Confession, and creates uncertainty, doubt, and a division of the local gathered body of believers and a division in practice between congregations; and

WHEREAS, The Council of Presidents unanimously adopted the resolution: "To Encourage Advocating In-Person Communion," wherein the final resolved encourages congregations and pastors "to refrain from the practice of online communion,"; therefore be it

Resolved, That the Pastors of the Montana District provide a careful Biblical and catechetical instruction to their congregations regarding Holy Communion giving attention to the duties of a pastor and that of the congregation in this matter; and be it further

*Resolved,* That the congregations of the Montana District be encouraged to clearly and unequivocally reject and condemn the practice of virtual (online) communion by teaching members of the specific dangers; and be it further

Resolved, That the President of the Montana District (the Ecclesiastical Supervisor), seek information from all Montana District congregations about this practice and begin specific discussions to dissuade any congregation of this district that is considering, teaching, or practicing virtual (online) communion; and be it finally

*Resolved,* That the Montana District memorialize the Convention of the LCMS to broaden its scope to include every District and adopt this at its 2023 convention.

Title: To Implement The 2019 Synod Resolution 12-03a To

**Encourage and Train Parents and Guardians and Members To** 

Be Active Teachers and Life Long Learners of The Faith

Action: ADOPTED AS AMENDED

WHEREAS, The President's Report to the Montana District made clear there is an urgent need to engage our families to a growing faith life; and

WHEREAS, The scriptures direct parents to be faithful in the faith formation of their children (Deuteronomy 6); therefore be it

*Resolved,* That the Montana District President and Board of Directors be directed, in the next Triennium, to develop and implement a specific program assisting congregations in outreach and training, which encourages parents in home faith development; and be it further

*Resolved,* That specific training be made available to the congregations of the Montana District involving pastors, parents, and lay-leaders; and be it finally

*Resolved,* That a report of the same and its results be brought before the next Montana District Convention.

#### **RESOLUTION #03-01**

Title: To Encourage and Emphasize the Need for Congregations in

the Montana District to Continue Efforts to Support the

**Sanctity of Human Life** 

**Action:** ADOPTED

WHEREAS, The Lutheran Church-Missouri Synod and The Montana District of The LCMS affirm that God created human life and blessed it: "Before I formed you in the womb I knew you, and before you were born, I consecrated you..." (Jeremiah 1:5), and "You formed my inward parts; you knitted me together in my mother's womb. I praise you, for I am fearfully and wonderfully made" (Psalm 139:13-14), and "God created man in his own image, in the image of God he created him; male and female he created them." (Genesis 1:27); and

WHEREAS, The LCMS therefore supports the sanctity of human life from conception to natural death; and

WHEREAS, With the possible reversal of Roe vs. Wade in the U.S. Supreme Court, and the subsequent remanding of life-related law to the states, there are groups in Montana supporting a special session of the legislature to pass laws further restricting or prohibiting abortion; and

WHEREAS, The Montana state constitution has been interpreted to protect the right to abortion on demand based on the right to privacy, and certain groups are interested in changing the Montana constitution to protect the sanctity of life; and

WHEREAS, Members of LCMS congregations of the Montana District have the vocation of citizens of their state; and

WHEREAS, The Montana District congregations support pro-life ministries and organizations, and speak in favor of life and support for parents; therefore be it

Resolved, We commend the Montana District Board's past and current support of, and financial contributions to, pro-life ministries, as listed on page 42 of the Convention Workbook; and be it further

Resolved, That congregations of the Montana District be encouraged to redouble our efforts to speak for life and support pro-life ministries as the issue is discussed by state leaders and supporters of abortion over the coming triennium; and be it finally

*Resolved,* that the Montana District Board of Directors issue a news release stating the District's action in convention to reiterate its support for the sanctity of human life and its opposition of abortion

Title: To Reaffirm the Biblical Practice of Gathered Local

Congregations with Rightly Called Local Pastors and To Encourage Congregations to Practice In-person Worship,

Teaching, and Administration of the Sacraments

Action: ADOPTED AS AMENDED

WHEREAS, The churches of the Lutheran Confession have consistently maintained membership rosters for the sake of good order and pastoral care; and

WHEREAS, Local congregations have long striven to work with one another fraternally and for the sake of good order in regard to transfers and changes in membership, as well as honoring church discipline when such has been necessary; and

WHEREAS, Pastors are instructed to "shepherd the flock of God that is *among* you, exercising oversight," (1 Peter 5:2, italics added) and they have vowed to "perform the functions of a pastor in an evangelical manner; to aid, counsel, and guide members of all ages and social conditions; to visit the sick and the dying; to admonish the indifferent and the erring," <sup>1</sup>; and

WHEREAS, A pastor, who is not physically *among* his people, is not able to shepherd the flock by visiting the sick and the dying or to exercise oversight or to administer the sacraments in person; and

WHEREAS, The emerging practice of congregations seeking and receiving as members those who are geographically distant, especially when there is a local congregation near such individuals, creates confusion and division in congregations, circuits, and districts while generating many questions about pastoral oversight and visitation, care at the time of death, and Christian burial, etc.; and

WHEREAS, There are already a number of "churches" in the quickly expanding online world of remote pastors who teach and guide virtual members; and

WHEREAS, A growing number of Christians are choosing to join virtual churches and participate exclusively online, and our Lutheran congregations are not immune from this temptation to abandon the traditional gathered body of believers as recorded in Acts 1:12-14; and

WHEREAS, The writer to the Hebrews teaches, "let us consider how to stir up one another to love and good works, not neglecting to meet together, as is the habit of some,

but encouraging one another, and all the more as you see the Day drawing near," (Hebrews 10:24-25); therefore be it

*Resolved,* That the Pastors and congregations of the Montana District of the LCMS be encouraged to study God's Word and our Lutheran Confessions to be reminded what it means to be a Christian congregation and a member of the body of Christ; and be it further

*Resolved,* That the congregations of the Montana District of the LCMS, be encouraged to limit online worship; and be it further

*Resolved,* That congregations of the Montana District of the LCMS be discouraged from practicing remote membership and virtual congregations; and be it further

*Resolved*, That the congregations of the Montana District of the LCMS, be encouraged to teach our members the specific dangers of remote and virtual worship attendance; and be it finally

*Resolved,* That this resolution be forwarded to The Lutheran Church—Missouri Synod for adoption at its 2023 convention.

#### **RESOLUTION #03-03**

Title: To Direct Synod in Convention to Establish a Commission to

Study the Possibility of Utilizing a Health Sharing

**Community Group** 

Action: ADOPTED AS AMENDED

WHEREAS, Concordia Health Plans (CHP) only offers health insurance for church staff and professional church workers employed by LCMS congregations, schools, districts and other approved Synod entities; and

WHEREAS, The cost of providing CHP health care coverage often proves cost prohibitive to many smaller congregations/schools and/or restricts the viability and growth of their respective ministries; and

WHEREAS, The Affordable Care Act (ACA) requires the purchase of health insurance that complies with government regulations but also allows for health care cost sharing programs to provide such health care coverage, often at a more reasonable cost; and

WHEREAS, Some health insurance providers pay for medical procedures that violate Biblical teachings and values, such as abortions or "gender reassignment surgeries;" therefore be it

*Resolved,* That the Montana District of The Lutheran Church--Missouri Synod in convention request the Synod at its 2023 convention to appoint a commission to study establishing a health care cost sharing program open to all members of Synod, as well as all individual members of LCMS congregations, with the objective of reducing health care costs.

#### **RESOLUTION #03-04**

Title: To Acknowledge that Drag Queen Performances Are an

Offense to God

**Action:** ADOPTED

WHEREAS, Our Lord Jesus Christ especially blessed little children during His earthly ministry (Mark 10:13-16) and issued a vivid warning to those who would endanger the innocence of children (Matthew 18:5-6); and

WHEREAS, Each child deserves the protection and care not only of his parents, but also of the community at large and it is simply evil to expose children to sexually explicit themes; and

WHEREAS, This fact is recognized in the Montana law against obscenity, which makes special mention of obscenity aimed at children, "anyone under 18 years of age," (Montana Code Annotated 2021, 45-8-201); and

WHEREAS, Inviting a drag queen to perform for children is intended to introduce children to sexually explicit themes, which is contrary to common sense, natural law, and all that is good and holy; and

WHEREAS, Zoo Montana has invited a drag queen to do exactly this on June 22, 2022; therefore be it

*Resolved*, That the convention of the Montana District of The Lutheran Church – Missouri Synod acknowledge that all such drag queen performances, especially directed at children, are an offense to God and all decent people; and be it further

Resolved, That the Montana District President write a letter to the leadership of Zoo Montana expressing the truth of the evil of drag queen performances, God's judgment, and the redemption that is in Christ Jesus, and be it finally

*Resolved,* That the Montana District Board of Directors issue a news release statewide stating the District's action in convention.

Title: To Develop Biblically Faithful Textbooks/Curricula for Our

Day Schools, High Schools, and Home Schools

Action: ADOPTED AS AMENDED

WHEREAS, Education in all subject areas is first and foremost about what is taught, namely that which is good, true, and beautiful; and

WHEREAS, Secular education in all subject areas is increasingly subject to forces from anti-God, anti-Christ, anti-family, pro-death, amoral, anti-truth, and even anti-beauty perspectives; and

WHEREAS, The Holy Scriptures provide the norm and framework for knowledge in all subject areas, all being interwoven in significant ways with right theology, ethics, history, and human nature as revealed by God therein; and

WHEREAS, The LCMS has the second largest system of parochial schools in America, but too often they are using secular textbooks/curricula, or publications from non-Lutheran traditions; and

WHEREAS, Many Lutheran parents who homeschool their children find good, biblically faithful textbooks/curricula options to be sorely lacking; and

WHEREAS, Christian schools and home schools in general would benefit greatly from having more biblically faithful Christian textbook/curricula options; and

WHEREAS, The natural sciences, especially biology and earth sciences, are prone to the grievous errors of Darwinism and other widely accepted secular theories which directly undermine the integrity of the Scriptures, and the Gospel itself, by putting Death before the Fall; and

WHEREAS, The Discovery Works science textbooks available from Concordia Publishing House (the only day school curricula available from CPH besides Religion Curriculum and some Lesson Plans) are outdated (© 1999) and rather limited (Grades 1-6); and

WHEREAS, The need is urgent, since surveys show that sixty percent of young adults raised as Christians are rejecting the faith,<sup>1</sup> their doubts arising in middle school and high school when Darwinism and its many related false "-isms" are taught by the secular textbooks but either no counter arguments for biblical truth are available or those presented are inadequate; and

WHEREAS, The LCMS has a university system and two seminaries comprising expertise across all subject areas, including early childhood education, for producing excellent textbooks/curricula for grades K-12 as well as providing theologically sound editorial oversight to ensure content is biblically faithful in its Christian apologetic; and

WHEREAS, The LCMS has its own publishing house; therefore be it

*Resolved,* That the Montana District of the LCMS memorialize the Synod in convention to direct and coordinate the preparation and production of biblically faithful textbooks/curricula across all subject areas, for grades K-12; and be it further

*Resolved,* That this curriculum be among the highest priorities for CPH; and be it further

*Resolved,* That the first drafts for textbook/curricula material be made available by 2025 with the rest of the textbooks/curricula to follow in a timely manner; and be it finally

*Resolved,* That CPH engage the expertise of LCMS university and seminary faculties, as well as LCMS day school, high school, and homeschool teachers for the development of these textbooks/curricula.

#### Resolution #4-02

Title: To Encourage Both LCMS Seminaries to Continue Training

Men for Faithful Service and To Petition the Synod to

**Dramatically Increase Funds Sent to Undesignated Seminary** 

Operations.

**Action:** ADOPTED

WHEREAS, Both of our LCMS Seminaries continue to teach and prepare theological pastors who understand, believe, and teach the Lutheran Confession faithfully; and

WHEREAS, Our seminaries have increasingly been forced to secure their own funding for operations, necessitating the formation of separate development offices and staff<sup>1</sup>; and

WHEREAS, One of the reasons for the formation of a Synod was the common and truthful belief that congregations could do together what none could do alone, including providing seminaries for the training of pastors in the Synod<sup>2</sup>; and

WHEREAS, The LCMS model of residential seminary education has served the Synod well since its founding and has become a model for seminaries around the world, with partner churches calling for aid and counsel in providing similar educational opportunities and standards for their students<sup>3</sup>; and

WHEREAS, Congregations of the Synod and global missions will always need well-educated pastors and experienced and gifted faculties; and

WHEREAS, The cost of maintaining academic standards, recruiting and teaching future pastors, and operating residential seminaries continues to increase; and

WHEREAS, Many other church bodies in the United States are abandoning residential models and moving to online teaching and remote learning while requiring less overall education and training in the sacred texts and doctrine of the Christian Church to the detriment of pastoral formation; and

WHEREAS, Many in our Synod are also tempted to close a seminary and find cheaper and more expedient ways to solve the short-term clergy shortage that we face; and

WHEREAS, Such short-term thinking can provide some relief for the immediate crisis, but often has unintended consequences and creates greater struggles for the future; and

WHEREAS, Jesus has told us that the harvest is plentiful but the laborers are few, to pray to Him to send out laborers into His harvest field; and

WHEREAS, The Lord, in His mercy, has faithfully and generously provided these seminaries for the preaching and teaching of His Word, and they are a great blessing to confessional Lutheranism in the United States and throughout the world; therefore be it

RESOLVED, That letters of encouragement be sent to each seminary from the Montana District Board of Directors thanking them for their faithfulness to our Lutheran Confession and the formation of pastors, while also encouraging them to continue this work; and be it further

*RESOLVED*, That congregations of the Montana District be encouraged to consider generous contributions to the Joint Seminary Fund<sup>4</sup>, a fund that provides roughly one million dollars per fiscal year to each seminary<sup>5</sup>, or directly to one or both of the seminaries; and be it further

RESOLVED, That the Montana District lead this effort by example, setting a goal of contributing 5% of unrestricted giving from District congregations to the Joint Seminary Fund beginning in fiscal year 2023; and be it further

RESOLVED, That the Montana District petition the Synod in convention to return to the earlier practice of our Synod when seminaries were mostly funded by unrestricted monies given to the Synod at large by districts, member congregations, and individuals. Specifically, that the Synod would adjust budget priorities as necessary so as to make our seminaries a priority by providing for 50% of each seminary's budget beginning in 2024, with a stated goal of increasing that percentage at each convention until both seminaries are fully funded by the Synod budget; and be it finally

*RESOLVED,* That this resolution be forwarded to The Lutheran Church–Missouri Synod for adoption at its 2023 convention.

Title: To Encourage and Equip Fathers in their God-Given Task of

Raising Children in the Faith

Action: ADOPTED AS AMENDED

WHEREAS, God commands fathers to train their children in the Word. "Fathers, do not provoke your children to anger, but bring them up in the discipline and instruction of the Lord" (Ephesians 6:4); and

WHEREAS, Moses wrote, "And these words that I command you today shall be on your heart. You shall teach them diligently to your children, and shall talk of them when you sit in your house, and when you walk by the way, and when you lie down, and when you rise. You shall write them on the doorposts of your house and on your gates" (Deuteronomy 6:6-9); and

Whereas, One-quarter of the world's population is under 15 years of age (www.statista.com/statistics/265759/world-population-by-age-and-region/); and

WHEREAS, Some children are not raised with their father present; and

WHEREAS, Many grandparents are raising their grandchildren while trying to help their adult children ("When Grandparents Raise Their Grandchildren," Psychology Today, 2017); and

WHEREAS, Many adults have limited parenting skills or may not accomplish their responsibility in passing the faith to their children. "Train up a child in the way he should go; even when he is old he will not depart from it" (Prov. 22:6); and

WHEREAS, 25 percent of children whose primary faith influence is the church will remain faithful in adult life, and 81 percent of children whose primary faith influence is the family will remain faithful into adulthood (Peter L. Benson, Congregations at Crossroads: A National Study of Adults and Youth in the LCMS [Search Institute, 1995], 21), which suggests that a home-centered paradigm is more effective for retention than one that is exclusively church-centered; and

WHEREAS, Synod in 2019 resolved that "LCMS districts share successful strategies among their congregations, with other districts, and with Synod as a whole"; therefore be it

*Resolved,* That fathers in the Montana District be encouraged in their God-given responsibility to teach their children the faith; and be it further

*Resolved,* That the Montana District in Convention directs the District Education Committee to find and highlight suitable material to assist fathers and mothers and caregivers in the God-given task of raising children in the faith; and be it further

*Resolved*, If gaps are found in the educational materials, the District Education Committee will ensure further resources will be developed; and be it further

*Resolved,* Montana District in Convention directs our Education Committee to create an instructional seminar on how to best access and utilize the materials for the home. This seminar to be available district wide, whether in-person or online to train parents/caregivers; and be it finally

*Resolved,* That the Montana District Education Committee make every effort to submit their findings to the District President in time to be placed in the 2023 Synodical Convention Workbook district report in accordance with the 2019 LCMS synod resolution 12-03a.

#### Resolution #04-04

Title: To Appoint a Task Force to Refocus the Concordia University System

for the Education of Professional Church Workers Consistent with the

**Lutheran Confessions** 

**Action: ADOPTED** 

WHEREAS, The Concordia University System (CUS) is comprised of six colleges and universities in the United States which are affiliated with The Lutheran Church–Missouri Synod (LCMS); and

WHEREAS, The initial purpose of these colleges and universities was to prepare men and women for full-time service in the church; and

WHEREAS, The majority of students at CUS institutions are not preparing for full-time church work; and

WHEREAS, From 2004 to 2018 enrollment for pre-seminary (undergraduates) students declined 59% and for Lutheran school teacher 61%. Enrollment at the seminaries has declined 55%. Furthermore, 44% of active ordained men are over 55 years of age; and

WHEREAS, A number of the faculty at CUS institutions are not rostered members of Synod nor members of LCMS congregations; and

WHEREAS, The encroachment of false teachings from the secular culture onto CUS campuses threatens the confession of our faith; and

WHEREAS, A refocused CUS would enhance the ability of the Synod to attend to the integrity of our confession; be it therefore

*Resolved,* That the Montana District in convention memorialize the Lutheran Church—Missouri Synod at its 2023 convention to direct the President of the Synod to appoint a blue-ribbon task force to perform the following:

- A. Establish a plan for restoring and retaining an LCMS identity on CUS campuses.
- B. Prioritize the training of rostered church workers of Synod with our confession of faith.
- C. Develop a plan to increase the percentage of LCMS rostered faculty, with a goal of 100%.
- D. Prepare a report on these tasks for the 2026 LCMS convention.

#### **RESOLUTION #05-01**

Title: To Amend the Montana District Bylaws to Provide for the

Care of an Outgoing District President in a Manner

Consistent with the Care Given by Synod to an Outgoing

President

Action: ADOPTED AS AMENDED

WHEREAS, Montana District Bylaw 2.2.1.4.c reads "If the District President is not reelected, he shall continue to receive his full salary and benefits for a period not to exceed ninety days from the day the newly elected President takes office. If he finds other employment, accepts a call, or retires before the end of ninety days, his salary and benefits from the District shall end by the first of the month following his assumption of such employment, call, or retirement"; and

WHEREAS, The equivalent bylaw (3.2.4.1.a-b) in the Synod bylaws provides for an outgoing President for a period of six months while rendering transitional service; therefore be it

Resolved, That Bylaw 2.2.1.4.c of the District Bylaws be amended as follows:

2.2.1.4.c If the District President is not re-elected, he shall continue to receive his full salary and benefits for a period not to exceed six months from the day the newly elected President takes office, while rendering transitional service. If he finds other employment, accepts a call, or retires before the end of six months, his salary and benefits from the District shall end by the first of the month following his assumption of such employment, call, or retirement.

#### **RESOLUTION #05-02**

Title: To Restore the Binding Key to the Rites of Ordination and

**Installation of a Pastor** 

**Action:** ADOPTED

WHEREAS, Jesus says in Matthew 16:19, "I will give you the keys of the kingdom of heaven, and whatever you bind on earth shall be bound in heaven, and whatever you loose on earth shall be loosed in heaven." Again, He says in Matthew 18:18, "Truly, I say to you, whatever you bind on earth shall be bound in heaven, and whatever you loose on earth shall be loosed in heaven." And, in John 20:21-23, "Jesus said to them again, "Peace be with you. As the Father has sent me, even so I am sending you." And when he had said this, he breathed on them and said to them, "Receive the Holy Spirit. If you forgive the sins of anyone, they are forgiven; if you withhold forgiveness from anyone, it is withheld,"; and

WHEREAS, The ordination and installation rites in the The Lutheran Hymnal Agenda ask only three questions of the man to be ordained and installed and do not go into detail about the duties of the Christ's Office that he will perform, but asks only if the man intends to discharge those duties faithfully in accordance with the Scriptures and the Symbols of the Evangelical Lutheran Church¹; and

WHEREAS, The ordination and installation rites in the Lutheran Worship Agenda specifically include the reading of John 20:21-23 and expand the number of questions asked of the man being ordained and installed to six while also going into more detail about the duties of Christ's Office that he will fill, including explicitly mentioning the Loosing Key but omitting mention of the Binding Key<sup>2</sup>; and

WHEREAS, The ordination and installation rites in the Lutheran Service Book Agenda add a seventh question for the man being ordained and installed while making only a minor change in the wording of other questions and also explicitly mention the Loosing Key but continue to omit mention of the Binding Key<sup>3</sup>; and

WHEREAS, This omission of the Binding Key leaves out a significant portion of Christ's command and necessary Christian doctrine and may improperly teach the full extent of the pastoral office's responsibility; therefore be it

Resolved, That the Montana District in Convention instruct the current and all future Montana District Presidents to include these words in the Rites of Ordination and Installation of Pastors: "and do you promise to retain the sins of those who are impenitent as long as they do not repent," when he or his agent conduct these rites; and be it further

*Resolved,* That the Montana District in Convention request the Board for National Mission of the Lutheran Church – Missouri Synod to insert the Binding Key language where applicable into the Rite of Ordination; and be it further

Resolved, That the Board for National Mission of the Lutheran Church – Missouri Synod deliver the revised rite to Concordia Publishing House for publication, or announce that they choose not to include the Binding Key in the Rite of Ordination and publicly provide the rationale for continuing to omit the Binding Key by November 30th, 2024; and be it finally

*Resolved,* That the Montana District in Convention petition the Synod in Convention to direct the Board for National Mission of the Lutheran Church—Missouri Synod to make this inclusion.

#### The Installation of a Pastor:

"I ask thee, therefore, dear Brother, in the presence of God and this Congregation: Art thou willing and ready to take upon thee the charge of this Congregation, and to perform faithfully all the duties of thy ministry? Answer: I am."

"Wilt thou preach and teach the pure Word of God in accordance with the Confessions of the Evangelical Lutheran Church, and adorn the doctrine of our Savior by a godly and holy life? Answer: Yes, with the help of God." (TLH Liturgy and Agenda, CPH 1921, pg. 375 – 385)

#### **RESOLUTION #05-03**

Title: To Prevent the Admission, Reinstatement, or Colloquization

of a Divorced Man into the Office of the Public Ministry who

has Married Another Woman

Action: ADOPTED AS AMENDED

WHEREAS, Christ our Lord says with regard to marriage, "What therefore God has joined together, let not man separate," (Matthew 19:6; Mark 10:9; cf. Genesis 2:24); and

WHEREAS, A man is guilty of adultery if he marries another woman while his wife lives; however, if his wife dies he is free to marry, (Romans 7:2-3); and

WHEREAS, Men called into the Office of the Public Ministry are called to be above reproach. Specifically, with regard to marriage, this requires him to be the husband of no more than one wife, (1 Timothy 3:2; Titus 1:6); and

WHEREAS, Divorce and remarriage disqualifies a man from the Office of the Public Ministry, (1 Timothy 3:2; Titus 1:6); and

WHEREAS, The decision whether to accept or deny a request for reinstatement shall be at the sole discretion of the Council of Presidents, (Bylaw 2.18.1); and

WHEREAS, The decision to declare applicants for colloquy to be qualified for the pastoral ministry and to certify such men for placement rests at the sole discretion of the Colloquy Committee for the Pastoral Ministry, (Bylaw 3.10.2.2.b); and

WHEREAS, In the action of reinstating or not reinstating a man into the office of the ministry, the Council of Presidents does so as an officially established advisory body of the Synod, (Bylaw 1.2.1.g); and

WHEREAS, By the actions of admitting, reinstating, or colloquizing, the Council of Presidents and Colloquy Committee for the Pastoral Ministry, respectively, state that a man is qualified for the Office of the Public Ministry in The Lutheran Church-Missouri Synod. As this is an assignment given to them by the members of the Synod in convention (having been codified in the Bylaws of the Synod), they do so as representatives of the members of the Synod (Bylaw 3.10.1.4; Bylaw 2.18.1); therefore be it

*Resolved,* That the Council of Presidents not admit a divorced man into the Office of the Ministry who has married another woman; and be it further

*Resolved,* That the Council of Presidents not reinstate a divorced man into the Office of the Ministry who has married another woman; and be it further

*Resolved,* That the Colloquy Committee for the Pastoral Ministry not colloquize a divorced man into the Office of the Public Ministry who has married another woman; and be it further

*Resolved,* That when a man is reinstated into the Office of the Public Ministry, the reason for reinstatement be made available upon request; and be it further

*Resolved,* That when a man is colloquized into the Office of the Public Ministry, the reason for colloquization be made available upon request; and be it finally

*Resolved,* That the Montana District in convention adopt this resolution and submit it to the Synod Convention for adoption.

### **RESOLUTION #05-04**

Title: To Reform the Composition of the Boards of Regents of the

Universities of the Concordia University System to Improve

**Doctrinal Fidelity and Amenability to Ecclesiastical** 

**Supervision** 

**Action:** ADOPTED

WHEREAS, The Concordia University System is a synodwide corporate entity of the Lutheran Church – Missouri Synod (Bylaw Section 1.2.1(w)); and

WHEREAS, Synodwide corporate entities are separate corporations established by the Synod for business and legal reasons, and not for purposes of independence from the Synod, immunity from ecclesiastical supervision by the Synod, or propagation of positions contrary to the teachings of the Synod; and

Whereas, Synodwide corporate entities including the Concordia University System "are to be servants of and to the Synod and its members," (Bylaw Section 3.6.1); and

WHEREAS, Synodwide corporate entities shall be accountable to the Synod in convention for the discharge of their assigned duties (Bylaw Section 3.6.1.6(h)); and

WHEREAS, Synodwide corporate entities "shall be accountable to the President of the Synod for doctrinal faithfulness" (Bylaw Section 3.6.1.6(i)); and

WHEREAS, All governing documents and instruments of synodwide corporate entities must be in conformity with the Constitution, Bylaws, and applicable resolutions of the Synod in convention (Bylaw Section 3.6.1.7) and must provide that the entity is "a component part of the Synod" (Bylaw Section 3.6.1.8); and

WHEREAS, The Concordia University System has the overall responsibility to provide for the education of pre-seminary students, ministers of religion-commissioned, other professional church workers of the Synod, and others desiring a Christian liberal arts education by facilitating prior approval for theology appointments to college or university faculties (Bylaw Section 3.6.6.1); and

WHEREAS, The Board of Directors of the Concordia University System is charged with a mandatory duty to ensure that the boards of regents and campus administrators are actively working to preserve their Lutheran identity by supporting the objectives of the Synod (Constitution Art. III) and deliver academic and student programs designed to give students Christ-centered values (Bylaw Sections 3.6.6.6(a) and (b)); and

WHEREAS, The composition of the boards of regents of the institutions of the Concordia University System was expanded to include from 4 to 8 regents appointed by each board of regents itself to add expertise to the boards; and

WHEREAS, Expertise certainly is needed in the boards of regents, subsequent experience has shown a tendency resulting in part from the new composition of the boards of regents for those boards and campus administrators to exhibit independence from the Synod, propagation of positions contrary to the teachings of the synod, and resistance to ecclesiastical supervision by the Synod; and

WHEREAS, A board of regents of an institution of the Concordia University System violated in multiple substantial ways numerous bylaws governing the search for and appointment of a new president of the institution, insomuch as to practically abdicate their responsibilities; and

WHEREAS, By virtue of the duties imposed upon him and the powers vested in him by the Constitution and Bylaws of the Synod to exercise ecclesiastical supervision (for example, Bylaw Section 1.2.1(j)), the President of Synod with a visitation team visited the campus of that institution to gather facts; and

WHEREAS, Following the visitation by the President of Synod and visitation team, the President delivered to that institution a letter exercising the ecclesiastical supervision imposed upon and vested in him (letter from The Rev. Dr. Matthew C. Harrison, President of the Synod, to members of the CUWAA Board of Regents, Monday of Easter IV, A.D. 2022, May 9, 2022); and

WHEREAS, The board of regents of that institution has failed or refused to give the letter of ecclesiastical supervision even the consideration, let alone the action, due in the circumstances and under the Constitution and Bylaws of the Synod; and

WHEREAS, This failure or refusal is, in part, a symptom of the independence from the Synod and resistance to ecclesiastical supervision by the Synod that stems in part from the new, expanded composition of the board of regents where many members are appointed by the board of regents itself; and

WHEREAS, The harms resulting from independence and resistance to ecclesiastical supervision clearly outweigh the benefits of expertise provided by the new, expanded composition of the boards of regents; and

WHEREAS, Therefore it is necessary to reform the composition of the boards of regents for the sake of maintaining the Concordia University System as a component part of the Synod, as servant of and to the Synod and its members, in doctrinal faithfulness, with Lutheran identity and Christ-centeredness, amenable to ecclesiastical

supervision by the Synod through the Synod's chosen office for exercising supervision; therefore be it

*Resolved,* That Bylaw Section 3.10.6.2(1) through (5) on the composition of the boards of regents of the colleges, universities, and institutions of the Concordia University System be amended to provide as follows:

- 1. Two ordained ministers, one commissioned minister, and two laypersons shall be elected by the conventions of the Synod.
- 2. One ordained minister, one commissioned minister, and two laypersons shall be elected by the geographical district in which the institution is located. If any board is required by its governing documents to include one or more persons holding residence or church membership in a specific locality, the institution is responsible for ensuring (including by appointment, if necessary) that individual(s) meeting such requirements are included among those persons serving on such board, and no such geographical restriction shall apply to Synod elected regents.
- 3. [Deletion of current provision in subsection (3) for the appointment of no fewer than four and no more than eight members by the board of regents. When codified in the revised and update synodical handbook, this deletion would cause a renumbering of the remaining subsections.]
- 4. The president of the district in which the college or university is located or a district vice-president as his standing representative shall serve as a voting member.
- 5. One member, who may be an ordained minister, a commissioned minister, or a layperson, shall be appointed by the President of the Synod;

## and be it further

Resolved, That each college, university, or institution of the Concordia University System shall devise a plan of transition to the number of regents and composition of the board of regents mandated by this resolution to be fully implemented no later than the regents' first meeting in the third quarter of 2026 so that no current regent shall have the regent's current term shortened but no unnecessary delay in implementing this resolution is allowed; and be it further

*Resolved*, That the plans of transition shall be subject to approval by the President of Synod, and shall be submitted to the President of Synod for review by February 1, 2024; and be it finally

*Resolved,* That this resolution be forwarded to the Lutheran Church – Missouri Synod for adoption at its 2023 convention.

# Triennium Treasurer's Report 2022 District Convention

The importance of the relationship of service and oversight that exists between the Montana District and the District Congregations, expressed in part during District Conventions, is invaluable. Over the past triennium, in keeping with the Board of Directors (BOD, Board) focus on transparency and faithful stewardship, the Office of the Treasurer has pursued providing clear and useful financial information regarding the district finances and relevant financial information for use by congregational treasurers and their congregations. Included in the Triennium Report (expanded into four years) are comparative financial statements of The Montana District of the Lutheran Church – Missouri Synod, reporting years 2018-2020 (audited) and 2021 (unaudited). Through generous gifts, donations, and bequests from our district congregations and individual donors, as well as investment income, the Montana District has been able to both meet its financial obligations and plan for future ministry with confidence. This is possible both through the faithfulness of the Board in honoring the mission of the District and the faithfulness of the District Congregations in providing direction to the Board. For instance, the by-laws of the Montana District, proposed by the Board and approved at a District Convention, prevent any Board of the Montana District from engaging a loan to conduct operating activities (salary, office expenses, purchase of fixed assets for operations, etc.). This assists in keeping budgetary planning focused not just on the year ahead, but on the effect of the budget on future ministry years.

A brief review of the financial highlights of the past triennium, expanded, includes the following:

# 2018-2021 Highlights

- Periodic review of financial procedures and internal controls was conducted and updates were made as recommended.
- New FASB standards were enacted during the triennium and the District reporting was updated for implementation; the goal of these new standards is transparency in expense and liquidity reporting. Beginning with 2018, the Statement of Functional Expenses is included with District reporting.
- \$93,605 in scholarships were awarded to church worker program students at Concordia Seminaries and Universities. These scholarships were funded through donations, bequests, and investment revenue received from the Lutheran Church Missouri Synod Foundation where the monies are held in investment to maintain a scholarship program supporting the training in ministry of members of Montana District Congregations.

- Montana District awarded \$97,423 in student loan repayment grants to church workers serving Montana District congregations to support both district church workers and their congregations. These awards were funded primarily through LCEF Operating Results given to the District, and in part General Fund monies.
- Lutheran schools in Montana District applied for and received \$15,774 in grants in support of their programs. This fund was begun with donor money, increased with Board directed General Funds, and is held with LCMS Foundation to maximize income on the balance to maintain the grant program.
- The BOD directed \$25,584 in assistance to MT District congregations for various financial difficulties over the expanded triennium.
- \$15,116 in Mercy Fund Grants were awarded during the triennium. The Mercy Fund was created to aid MT District called workers who are facing catastrophic medical costs beyond their ability and their congregations' capacity to assist. This fund is fully supported by individual and congregational restricted donations.
- The BOD has been active in supporting pro-life ministry and in supporting religious freedom in Montana and nationally. \$934 was sent to Lutherans for Life, \$335 supported religious freedom in Montana and the Montana Life Coalition, and nationally \$2,250 was invested in religious freedom through Alliance Defending Freedom.
- To support District congregations in communicating the truths of God's word on His creation of men and women, the BOD purchased and provided 200 copies of God Made Boys and Girls by Marty Machowski. LCEF provided funding to support this.
- Montana District has four congregations that are subsidized mission foci of the District: Crow Lutheran Ministry, Circle of Life Lutheran Church, Emmaus Lutheran Mission and Redeemer Lutheran Church.
  - To support Indian ministry congregations, the Board directed \$308,494 in subsidies supporting Circle of Life, with \$4,146 sent in support from District congregations, and \$206,148 in subsidies supporting Crow Lutheran Ministries, with \$3,596 sent from District congregations.
  - Emmaus Lutheran Mission serving Big Timber and Livingston was begun in a previous triennium. This support has continued through this triennium. \$279,502 has been spent in support of this ministry as well as \$49,000 to assist in providing facilities for worship. MT District Congregations and individuals sent \$14,937 to the District office to support this subsidy, and LCEF supported the District subsidy in the amount of \$27,416.
  - During the Triennium, the BOD initiated a revitalization mission effort in Anaconda, Montana, through Redeemer Lutheran Church. The Montana District subsidizes this effort and has invested \$227,102. This subsidy was

- funded by MT District congregational support of the subsidy in the amount of \$1,919, and LCEF funding in the amount of \$9,616.
- Congregational convention assessments of \$45,100 were collected over the triennium, with \$26,976 expended for the 2018 District Convention and \$25,386 for the 2019 Synodical Convention.
- As directed through resolution 1-04 at the 2015 District Convention, the MT District sends support for missionaries called out of service in Montana District to the mission field. During the Triennium and 2021, the Board directed \$35,000 in support of 6 missionaries.
- In 2019, the District vehicle was destroyed by hail and replaced. The Board sets aside General Funds into a Vehicle Replacement Fund during every month with positive unrestricted net income to be prepared for such events, and the vehicle was replaced using these monies.
- The District office is moving locations in Billings. The BOD has signed a contract with Christ the King Lutheran Church, paying \$250,000 taken from the General Fund for 15 years rent in advance at a flat rental fee to rent office space in their new building, and anticipates moving into the facility in the Spring of 2022. The BOD plans to sell the current District facility within 2022.

# **Convention Study Summary**

During the Convention, in five sessions, over 4 hours were dedicated to the study of the Formula of Concord: Epitome. The delegates listened as Rev. Ryan Wendt read selections each day. The readings were one to two articles each. Following the reading, the delegates formed small groups and discussed these truthful words by following a discussion guide prepared by President Forke. Special emphasis was placed on our confession proclaiming the truth of God's Word alone. If the Word does not speak, we do not speak. We refuse to speculate; instead, we confidently stand on His Word, and are comfortable leaving the mysteries of God as mysteries.

# AMICUS CHRISTI - Mr. Kenneth Holste

Born and raised on a small farm in northwestern Kansas, the second of six siblings, five boys and a girl (poor Betty) and attended one and two room Lutheran Elementary schools. After graduating from Atwood High School, attended Concordia Teachers College in Seward, Nebraska, graduating with a Science and Math degree in Secondary Education thinking I wanted to teach in a Lutheran High School.

The Lord had other plans...being assigned to Trinity Lutheran School in 'Cowsbell' (Kalispell) MT, teaching math in grades 3-8 and science in K-8. It was a bit scary that week, after man first walked on the moon, for someone who had never been farther west than Denver to head for the Flathead Valley having no idea what or where the Flathead Valley was but after 1100 miles, all 2 lane highways, and topping the hill on Hwy 93 at Polson with Flathead Lake and the mountains in front of me, was an experience not to be forgotten. That same summer the Lord sent a young parish worker (Carol Bluhm) from northeastern Kansas to Trinity and after working together for three years we started our life together on June 25, 1972.

The month of July was camp counselor time until the mid 90's with both of our sons living with us in our one room cabin at Trinity Lutheran Camp. We took a break in the summers of the early 80's as I earned my Masters degree from Concordia, Seward, (no on-line courses then). The opportunity to work with hundreds (?thousands) of youth from across the State of Montana and beyond was wonderful and during this time the Basketball Camp was born which is still going strong 30+ years later.

During the late 70's and 80's I had the privilege of serving on the MT District Board of Directors, being able work with and learn from many gifted servants of our Lord. For the majority of my time at Trinity, I have been a part of the Board of Christian Day School as the Assistant Principal or in an Interim role as Principal, and since retiring from the classroom after 43 years, have become a part of the Board of Directors of TLC. Driving the school bus still gives opportunity for lots of contact with the students (including our grandkids).

It has truly been a team ministry with my wife Carols' support and encouragement ever present throughout the journey. Her, and consequently my, involvement with the Developmentally Disabled program at Trinity and the Pro-Life stance in the Flathead Valley have been a part of our lives since the early 70's.

I thank God for the many blessings He has given us and pray that we can continue to further the spreading of His Kingdom in Montana and the Flathead Valley now and in the future.

# **AMICUS CHRISTI - Pat Lewis**

Patrick "Pat" Lewis was Baptized into Christ in 1975 at Pilgrim Luther Church in Santa Monica, California.
