

PARLIAMENTARY PROCESS

The parliamentary process is intended to enable a group to conduct its business with the least possible confusion in order that everyone in the group may understand as clearly as possible what is being decided.

The parliamentary process also protects the rights of both minority and majority within an assembly. Unless the assembly creates special rules itself, the rules given in "Robert's Rules" are followed.

Ir

In	order to help delegates understand parliamentary procedure we offer these few basic rules and procedures.
1.	Always address the chairman, or the presiding officer. Debate between members is not permitted. Comments and discussion are addressed to the assembly.
2.	Wait until the chairman has recognized you, and granted you permission to speak. "The chair recognizes Mr./Mrs " "You have the floor."
3.	Main Motions require a majority vote, and are amendable.
4.	Try to learn the basic language used in parliamentary procedure. This is given below for your use: MAIN MOTION: I move I move the adoption of this report I wish to present the following resolution I move its adoption, or I move the adoption of the proposition in the report.
	COMMITTEE RESOLUTIONS Resolutions presented by a convention committee do not require a motion or a second. The presumption is that this has already happened since the committee has formalized, adopted and presented the resolution to the convention.
	The chairman says, "This resolution (motion) is now before the Convention" places any motion or resolution on the floor for discussion. <i>Prior to this announcement by the chairman any discussion is out of order.</i>
	POSTPONE INDEFINITELY I move to postpone this matter indefinitely. In effect kills a motion. AMEND
	I move to amend the motion by inserting between and I move to amend by adding after I move to amend by striking out and inserting I move to amend by striking out the motion and substituting this motion. (Read or state substitute motion)
	COMMIT OR RE-COMMIT I move that this matter be referred to a committee of to be named by with instruction
	POSTPONE TO A SET TIME I move that this matter be postponed to I move that this matter be postponed to meeting at (name time) and be made a Special Order of business. (2/3 vote is required) PREVIOUS QUESTION I move the previous question. (2/3 vote required)

SPECIAL STANDING RULES

- 1. Only substantive amendments to a resolution shall be offered from the floor (those impacting its purpose or effect). Editorial corrections or non-substantive changes to introduced resolutions should be shared in writing with the Secretary. Until a resolution is presented to the delegates, any such changes should be suggested directly to the floor committee chair.
- 2. Unless covered by these Special Standing Rules, parliamentary procedure shall be governed by the most recent edition of Robert's Rules of Order Newly Revised.
- 3. Delegates are encouraged to keep their comments on task. In order to facilitate this, the Chair may ask delegates to limit their debate time. No delegate or representative may speak more than twice on the same motion on the same day and may not speak a second time until all delegates and representatives desiring to speak the first time have had the opportunity. The chair shall have discretion to make exceptions to this rule. When a floor committee is called on to answer a question or to give information, this rule shall not apply.
- 4. A delegate who speaks on an issue may not move to call the question at the close of his or her speech.
- 5. If a substitute motion is offered and seconded, the presenter shall be offered two (2) minutes to provide the rationale for offering it and a member of the floor committee shall be offered two (2) minutes to present rationale for why the committee believes the original motion is to be preferred. The convention shall decide by majority vote without further debate whether or not to consider the substitute. If the decision is in the affirmative and if the substitute motion is subsequently adopted, the original motion dies. If the substitute motion does not receive favorable action either to consider or adopt, the original motion is again considered.
- 6. No motion to reconsider or rescind shall be made or called up during the last day of the convention.
- 7. A delegate may speak against a resolution which was drafted by a floor committee upon which the delegate serves.

2025 MT District – LCMS Convention Expense Reimbursements

The MT District will cover delegates' (Pastor, Lay, and Advisory), Board of Directors', parish ministry committee members', and special invited guests' travel, meals, and lodging expenses as indicated below. All other convention guests will attend at their own expense.

Expenses will be reimbursed on an accountable basis in accordance with IRS guidelines. In the case of lodging and meals, this requires itemized receipts for all claimed expenses. Mileage reimbursement requires beginning and ending odometer readings and days traveled. <u>Use of the 2025 District Convention Check Request Form is REQUIRED for all reimbursements</u>, and is located following these directions.

Travel.

- Delegates are encouraged to travel to and from the convention by privately owned vehicle. Please share rides when possible. Any alternate method of travel must be approved in advance through the MT District office.
- The district will reimburse eligible attendees at the rate of <u>70 cents per mile</u> to the driver/owner of the vehicle. In order to meet the IRS reporting requirements, the beginning and ending odometer reading and dates of use must be reported. Only the driver/owner of the vehicle will be reimbursed for mileage.
- Mileage allowance will be limited to the most direct route from the delegate/guest home to/from Billings.
- <u>Two-day travel is automatically authorized</u> for those individuals traveling more than 300 miles to the convention using the most direct route from their homes to Billings.

Lodging.

- The MT District will cover up to \$65.00 per night for lodging during the convention. No fees/charges (i.e. room service, movies, etc.) beyond covered lodging will be reimbursed.
- The MT District will cover costs of lodging from Sunday night through Wednesday night. If additional nights are required, reimbursement will require advance approval through the MT District office.
- Covered lodging expenses for eligible attendees staying at the Billings Hotel and Convention Center will be billed directly to the MT District office. Attendees will be required to pay any charges above the covered lodging expenses at checkout including \$65/night for single room request. If you have no charges above the covered lodging expenses, you will not be required to make any payment at checkout.
- Eligible attendees may choose to lodge at a different establishment and will be reimbursed as noted above. Itemized receipts are required for reimbursement.
- Reimbursement of lodging expenses while traveling to and from the convention is limited to
 those individuals traveling over 300 miles from their homes to Billings. Lodging
 reimbursement during travel is limited to \$200 maximum per night charge plus taxes.
 Itemized receipts are required for reimbursement. No lodging reimbursement will be
 provided for incidental charges.

Meals.

• <u>All meals while in travel status and while attending the convention are included</u>. The convention banquet dinner is provided by the district at no cost to eligible attendees; meal reimbursement during the banquet is not available. Breakfast is provided Monday-Thursday

- for those lodging at the Billings Hotel & Convention Center and will not be otherwise provided or reimbursed.
- You are authorized a meal reimbursement of: breakfast \$10.00, Sunday; lunch \$15.00, Sunday-Thursday; and dinner \$20, Sunday, Monday, Wednesday, and Thursday. Itemized receipts are required for all reimbursed meals (total of bill with tip and list of items). Alcoholic beverages are not eligible expenses. If you cover the meal costs of other delegates please include their names on the receipt noting items. If your receipt includes the costs of ineligible guests, deduct their items from the total submitted for reimbursement. Meals consumed prior to leaving home and after returning home are not eligible for reimbursement.
- Reimbursement of meals on 6/7 and 6/13 are reserved for those traveling in excess of 300 miles each way.

Check Request Form Instructions:

- 1. **Please print**. "Payable to," "Date," **full** "Mailing Address," "From," "Mode of transportation," expense information, and "Signature" are required blanks. **Incomplete or Illegible forms will result in delayed payment.**
- 2. Itemized receipts are required for all meal and lodging reimbursements. Original receipts **OR** copies may be submitted (the IRS recommends you also keep a copy or the originals for your own records). Actual odometer readings are required by the IRS for mileage reimbursements.
- 3. Meals reimbursements are available as follows, unless prior authorization is received:
 - Breakfast, \$10.00 maximum, Sunday
 - Lunch, \$15.00 maximum, Sunday-Thursday
 - Dinner, \$20.00 maximum, Sunday, Monday, Wednesday, Thursday
 - On Tuesday, a dinner banquet is provided; no other reimbursement will be authorized.
- 4. Alcoholic beverages are not reimbursable.
- 5. Your check request and receipts may be submitted one of two ways:

- 6. <u>In accordance with IRS regulations on accountable reimbursement plans, reimbursement requests</u> submitted after the 60-day grace period will not be accepted.

District President's Report 2025 Montana District Convention

"I Am Not Ashamed"

As President of the Montana District of The Lutheran Church—Missouri Synod it is my firm conviction that the confession made by our beloved Synod is a true exposition of the Holy Scriptures and a correct exhibition of the doctrine of the Evangelical Lutheran Church. With that conviction in mind it has been my endeavor, over the past 19 years, to oversee and facilitate a bold proclamation of the Gospel of Jesus Christ to the people under our purview as a district, both to those who are of the faith, and to those who do not yet know Jesus as Lord.

The religious climate of 21st century America is not welcoming of this message, so, to say the least, it has been a difficult journey. Yet, the saints of the Montana district are a tough, resilient bunch, who after reeling for a time as a result of the change from being cultural insiders to being cultural outsiders, have begun to learn how to stand firm in the face of the mockery and hatred of the world.

At this point, let me express my sincere thanks to the faithful Pastors, teachers and lay-members of the Montana district for allowing me to participate in their work of proclaiming Jesus to the nations at a pivotal time in our nation's history. I do believe these 19 years have included much of the pivot from a time when the Church was culturally powerful, to a time when the Church is disrespected and intentionally misunderstood. If that assessment were true, it would be a good time for a change in leadership in the district as we begin a new season of proclamation in a changed world. I will address this future position in my spoken words during the convention.

Congregations

During the past 19 years God has seen fit to grant four new congregations to the district, (Thompson Falls, Dillon, Livingston, Challis, ID.) We rejoice at the gift, and we pray for these fledgling congregations that God may grow them up strong and bold.

At the same time, we must acknowledge that the overall number of congregational members representing our district has shrunk. We grieve over the realities of this sin-bound world even as we pray that God would see fit to plant faith in more and more hearts. The reality is that our congregations are smaller than they used to be. That means that we have had to do things a bit differently than previously.

Around 85% of our congregations have fewer than 100 people in church on a weekend. Around 50% have fewer than 50 in average attendance. This is a significant number, because it means that most of our congregations are not able independently to support a Pastor. Consequently, around 70% of our congregations are in multi-parish relationships, that is, one Pastor serving two or three congregations.

While the proliferation of multi-point parishes may seem like doing things in a new way, it is more like "forward to the past." The history of the Montana district is full of Pastors serving many congregations. This time around, we have added a technological twist. At least six of

our congregations are using technology to deliver services, (without including the Lord's Supper) when the Pastor is not able to be present at every congregation he serves. I expect that number to go up. A number of our congregations have also been served by bi-vocational Pastors. These Pastors work at another job to supply much of their income. This is not unlike the circumstances of the Apostle Paul who proclaimed the Gospel and worked as a tent-maker.

Another new way of thinking about congregations in the Montana district is to recognize that the mission is very close, not necessarily far away. I am not degrading the need for foreign missions. However, more of our larger congregations are beginning to acknowledge that they can benefit the proclamation of the Gospel right here at home, by helping to keep our small, isolated congregations open. This may, and has happened either through formal relationships, or through occasional financial assistance. In my view, these intentional inter-district mission efforts are essential to the future of the Montana district. If we don't start drawing closer as district congregations, we may end up closing some.

The preceding paragraph provides an apt segway to outline the underlying philosophy of my approach to work in the Montana district. The practical result of my confidence in the rightness of our confession has led me to believe that we should seek to keep all of our congregations open, no matter how small. The sincere hope, perhaps even the plan, is that as other congregations in small town Montana find it necessary to close, our congregations may benefit from being the last Christian congregations standing. Finding ways to keep tiny, isolated congregations open has been the signature effort of the past 19 years.

Pastors

Much of the weight of serving small, isolated congregations falls on the Pastors of the district. They cover a lot of miles, and they don't get paid very much. Yet, they serve for the sake of the Good News of Jesus. Many thanks to them for their faithfulness to the confession and their selfless service to the saints of the district.

In this convention you will hear much about the need for Pastors. It is true that The LCMS has fewer Pastors than are needed to serve all its congregations. In my estimation, this does not mean that we should panic. It does not mean that we should lower the standards that we have established for the education of our Pastors. It does not mean that we should depend on institutions other than our seminaries to prepare our Pastors.

I would offer two practical actions that every one of us can use to respond to the shortage of Pastors. 1) We can do what Jesus told us to do. (Matthew 9:38) We can pray privately and in our Churches, that He will send us more Pastors. 2) We can actively participate by encouraging young men from Montana to become Pastors. Right now, we have four men from Montana studying for the ministry. I think we should be sending more men to study, because men from Montana will be better prepared to serve in small, isolated congregations.

Schools

Montana district congregations are supporting six Lutheran grade schools, and fourteen preschools. These are extremely important institutions because they are not only about excellent education. They are also, and primarily about the nurture and admonition of faith in Christ in the young people entrusted to our care. As the public education system gets drug further into the liberal social issues of the day, I predict that our schools will become more popular. This raises the need for a cautionary word. Our schools must have strong school boards and administrative staff that are willing to put the true confession of the faith ahead of enrollment numbers. A huge enrollment, at the cost of a compromised confession is an absolute failure. We exist to teach Jesus.

Teachers

Thank God for faithful Lutheran school teachers, (and other church workers who teach in one way or another). These are unsung heroes of the faith. Day in and day out they labor to find a way to present Jesus to their students in the context of their particular subject matter. This has been my charge to our teachers; whatever subject you teach you must find a way to teach Jesus as an integral part of that arena of life. And they do it! They do it because they love Jesus. They certainly do not do it for the sake of compensation. How could we ever compensate them for the hours and hours they spend devoted to our children? Please join me in thanking them for their service.

If you think the shortage of Pastors is having an impact on our Church, the shortage of teachers, and particularly principals is way worse. You will hear a presentation from the Director of the Synodical program "Set Apart to Serve" (SAS) during this convention. He will remind you that every congregation, whether you support a school or not, can encourage young people to enter full-time church work as teachers. The workers are few. The challenge is great. We want Montana teachers to come back to Montana.

Synod

Our beloved Synod, The Lutheran Church — Missouri Synod is a grand institution created by our forefathers in the faith, to support and encourage the congregations and the church workers in the essential task of the proclamation of the Gospel. It has weathered many storms in its 178 year history. The first 128 years we experienced rapid growth. The past 50 years have mostly exhibited decline. satan is evil. The world is cruel. People are sinners. We should not despair. We should pray and trust that God will lead us to be faithful and bold in the one calling of the Church; proclaim Jesus.

This decline in numbers causes some people to panic and turn to less than faithful responses. I caution you against this. Panic is never productive. It is not time to turn to anything other than the power He has given us, His Word. The Word of God has seen the Church through the centuries and the Word alone will see us through this difficult time.

Neither is it time to turn inward, to take care of ourselves, to avoid contact with the world, to hunker down and hope there is something left over when we come out of these doldrums. Now is the time for bold proclamation, for fearless interaction with a mocking world, for shameless stands no matter the cost.

Please keep our beloved Synod in your prayers. In my estimation the greatest challenge before The LCMS is the loss of what it means to be a "Synodical Union." (See preamble to The LCMS constitution.) When the Synod was formed there was a strong sense that our congregations and church workers needed each other, and for that reason they worked hard to maintain the true confession of faith. They realized that it was this confession that held them together.

Today The LCMS is less of a "Synodical Union," and more of a federation of districts. Individual districts have headed off in their own direction in any number of ways, implying that they are not in fellowship with other districts, that everyone should follow their lead, and even creating their own methods for educating church workers. This constituent led theory of independent district action is absolutely contrary to the historical understanding of the "Synodical Union." The Montana district has resisted independent action and has consistently stressed the need for a "Synodical Union" based on a common confession. Please join me in praying for a return to our historical roots on this matter.

Dear brothers and sisters in Christ, In Jesus you have all that you need. Do not be ashamed! Instead, glory in His name. Make His name known among the peoples. Rejoice and be glad. Your salvation has been procured. You belong to Him forever. No one can snatch you out of His hand. His Church will endure until the end. You are not small or insignificant to Him. He will keep you safe until He brings you home. To Him be all glory, praise and honor, through Jesus Christ our Lord. Amen.

Appendix I The problem of unsanctioned MDiv Programs in our Synod

Statement on Unsanctioned MDiv Programs

J. S. Bruss President, Concordia Theological Seminary, Fort Wayne May 07, 2025

Dear CTSFW Friends and Supporters,

Concerned members of our congregations have been asking me with increasing frequency, "What does Concordia Theological Seminary, Fort Wayne (CTSFW), think about the two online MDiv programs that some in our Lutheran Church—Missouri Synod (LCMS) have been promoting?"

Study in one of those programs, Luther House of Study (LHOS), has been promoted among LCMS members by Unite Leadership Collective (ULC), a parachurch organization focused on developing local, congregational leadership. Meanwhile, the Center, another parachurch organization focused on outreach, is inviting LCMS members to study at the Center for Missional and Pastoral Leadership (CMPL), a venture under the umbrella of the Institute of Lutheran Theology (ILT). Students in these programs can earn the Master of Divinity (MDiv) degree through online coursework and practicums in their home congregations. If you read no further, it's important to know the following:

- Graduates from neither of these programs may be ordained or installed in an LCMS congregation or ministry.
- Neither of these seminaries is owned, operated, authorized, or governed by the LCMS. Let me explain why that matters.

The Lord Christ has called His church to faithfulness in the things of God (John 8:31), to love toward one another (John 13:35), and to unity in His mystical Body, the Church (John 17:20-21, Ephesians 4:4-6). This unity is grounded in "continuing steadfast in the apostles' teaching" (Acts 2:42).

To foster that unity, the LCMS has from its inception owned and operated two seminaries, CTSFW and Concordia Seminary, St. Louis (CSL). They are the only two seminaries authorized by the LCMS to prepare and examine future pastors for the parishes and missions of our Synod. The Synod maintains—and the seminaries gladly accept—Synod governance so that they may be held to account for their fidelity to our shared doctrine and witness. In turn, our LCMS ordains into the ministry only those men whose doctrine and life have been formed and examined by them.

This arrangement has proven an inestimable blessing for the LCMS. I've often put it this way:

• If your pastor confesses and teaches and believes that the Son of God really was conceived by the Holy Spirit, was born of the Blessed Virgin, bore your sin and death,

- put them to death in His own death, and rose again bodily, and that bodily you will rise on the Last Day, thank God for our seminaries.
- If your pastor believes, teaches, and confesses that you are justified by faith alone in Christ alone, without any decision on your part or merit or worthiness in you, thank God for our seminaries.
- If your pastor believes, teaches, and confesses that the Bible is the inspired, inerrant Word of God, thank God for our seminaries.
- If your pastor believes, teaches, and confesses that the host is the Body and the wine the Blood of Christ, and that they should not be administered to those with whom we disagree in doctrine, thank God for our seminaries.
- If your pastor pronounces the Absolution with the scriptural conviction that this Absolution forgives your sins, thank God for our seminaries.

Such things are hardly luxuries. They are eternal life and eternal salvation.

It is telling that both LHOS and CMPL stand and wish to stand outside of our long-established and beneficial Synod governance. They simply do not have the same responsibility or accountability to the Synod.

CMPL faculty and advocates of LHOS

- voice concerns about the dearth of LCMS pastors yet steer potential pastors away from the two LCMS seminaries and gladly receive tuition from LCMS men for an MDiv that cannot lead to LCMS ordination;
- decry the cost of seminary attendance, even as the two LCMS seminaries offer a tuitionfree MDiv;
- characterize moving to seminary as an insurmountable hurdle, even as "no one who puts his hand to the plow and looks back is fit for service in the kingdom of God" (Luke 9:62), and movement is an inconvenience that a healthy ministerium must simply accept;
- champion the effectiveness of online education, even as the experience of COVID exposed its weaknesses and limitations;
- insist that they are only raising up "leaders," not pastors, but steer students into a professional degree intended to lead to ordained pastoral ministry and, in the case of CMPL, present themselves as the Center for Missional and Pastoral Leadership;
- maintain that the micro-context of a single parish, often the student's only experience
 with Lutheranism, can provide the theological and pastoral depth that our seminaries'
 students gain from experience in their own congregation, their fieldwork congregation,
 and their vicarage congregation, and from a CTSFW faculty with over 230 years of
 cumulative pastoral experience and over 500 cumulative years of forming pastors;
- wish you to believe that their graduates' Lutheran bona fides can be achieved by a liberal Lutheran faculty (LHOS) and an LCMS faculty that has willingly opted against LCMS governance (CMPL).

Some have suggested that the residential MDiv education and formation offered by CTSFW and CSL should be regarded as "the gold standard," leaving the online MDiv programs as an

acceptable—albeit silver or bronze—standard. The history of our LCMS tells a different story: residential MDiv education and formation is simply the standard—it always has been.

But because of that, it's easy for the CMPL faculty and advocates for LHOS to claim otherwise. The fact is, the vast majority of LCMS Lutherans really know nothing but the teaching and sacramental administration of pastors residentially educated and formed at CTSFW and CSL. When CTSFW pastors "make it look easy" that's exactly what they're doing: making it look easy. Their deftness in handling the Word of God and applying it faithfully is based on hundreds of hours of formal study of God's Word, our Lutheran Confessions, Christian dogma, the history of the Church, and pastoral theology. They've been steeped in Lutheran liturgy and hymns. During seminary they've taken in over 600 sermons. And they've learned from expert pastors at their home churches, fieldwork congregations, and vicarage congregations how to apply the Word of God to different situations in the same place and to the same situation in different places in faithfulness toward God and in love toward the people.

That's because, by the grace of God, our LCMS seminaries know what we're doing. We've been doing it—and doing it exceedingly well—for nearly 180 years. Our seminaries are a "luxury" our church can't do without. So, if you'd like an LCMS pastor in your LCMS church today and twenty years down the road, support our seminaries with your prayers and financial resources. If you prize the unity of love and doctrine in our LCMS, treasure our seminaries. And if you're moved to serve the church as a pastor, contact us at CTSFW. The fields are white for harvest (John 4:35).

I know that as I write all this, I echo the studied perspective of my good friend and colleague at CSL, President Tom Egger, and invite you to take a moment to read his statement on this matter. Meanwhile, hold fast to Christ; and may the good and gracious Father of our Lord Jesus Christ, who raised Him from the dead, guard and keep you by the power of His Spirit in the one, true faith. Amen.

Statement on the Center for Missional and Pastoral Leadership

Dr. Thomas J. Egger President Concordia Seminary, St. Louis May 07, 2025

In recent weeks, I have received requests to respond to the public launch of the Center for Missional and Pastoral Leadership (CMPL), a non-LCMS, online theological program directly appealing to LCMS students and donors. In their promotion of this new program, CMPL leaders and faculty have made contradictory statements, vacillating between promising that their project will help address the pastoral shortage in The Lutheran Church—Missouri Synod (LCMS) on the one hand, and stressing that they are not claiming to qualify students for ministry in the LCMS on the other. I have serious concerns about this program, and I would encourage LCMS friends not to promote or support it.

A central purpose in the formation of the LCMS, nearly two centuries ago, was to share together in the task of preparing and recognizing LCMS pastors, whom LCMS congregations would then be free to choose and call for service in their midst. For this purpose, the LCMS has, from its beginning, supported and operated its own seminaries: Concordia Seminary, St. Louis and Concordia Theological Seminary, Fort Wayne. This shared commitment to pastoral formation and pastoral "rostering" has served Christ's mission well. As nearly every mainline denomination in America has lost its way and departed both from Scriptural faithfulness and from true missionary zeal, the LCMS has remained true to its confessional, Scriptural roots and to its missionary character and commitment. Thanks be to God — this is the Lord's doing and grace.

Prior to organizing this new "Center" (CMPL), there was no consultation with the leadership of the LCMS, with the St. Louis seminary, with the Fort Wayne seminary, or with the body to which our Synod's bylaws direct such endeavors, the LCMS Pastoral Formation Committee. None. Not a single conversation about this effort that seeks to reinvent pastoral formation for the LCMS.

This new self-authorized online school, CMPL, is a serious departure from our church's mutual commitment to carry out pastoral formation together, a mutual commitment that we have repeatedly confirmed and emphasized through our history. Our most recent LCMS national convention resolved that "districts and members of the Synod honor, use, and promote Synod-approved programs and not create independent programs of pastoral preparation or direct men to a pastoral preparation program outside of our Synod's seminaries" (2023 Resolution 6-02A).

Despite the involvement of respected brothers in this CMPL project, including some with former connections to Concordia Seminary, St. Louis, I must say clearly to the church: Their project is ill-conceived and illegitimate and will cause division and confusion. What will members make of men serving as pastors in LCMS congregations who are not LCMS pastors? How can this not cause serious confusion and offense among our laity and within our church? It violates not only our explicit LCMS commitments to one another, but also the Apostle's mandate that things in the church be done "decently and in order ... for God is not a God of confusion but of peace" (1 Cor. 14:33, 40 ESV). It will not result in a greater number of pastors

for LCMS congregations and mission starts, but fewer, as prospective future LCMS pastors are discouraged from attending our two LCMS seminaries, and as LCMS seminary donors are courted to fund instead this non-LCMS school.

Our LCMS seminaries already offer pastoral formation programs that answer the need for distance education alternatives in situations where this is genuinely needed. In 2007, the LCMS in convention created a partially online pastoral formation program, the Specific Ministry Pastor (SMP) Program. The SMP Program is offered by both LCMS seminaries, and we have no intention of discontinuing the SMP Program, despite false rumors to the contrary.

There is no reason not to direct all future candidates for pastoral ministry in the LCMS to the seminaries of the LCMS. The intense recruitment effort of our Synod, districts and seminaries in recent years is already beginning to bear fruit. The number of pastoral students at our LCMS seminaries is up over the last five years, compared to the five years prior, and we are pursuing additional measures to identify and open doors to prospective future pastors. If we continue to work together, instead of beginning to row in different directions, this will make a real difference.

To those LCMS brothers involved in this independent project, my consistent appeal has been and continues to be: Please stop recruiting men from within the LCMS who desire to serve as LCMS pastors to attend this non-LCMS program that doesn't qualify them for pastoral ministry in the LCMS. This is not walking together, and it will cause great confusion and further division in our Synod.

Those involved rationalize this project by claiming that our LCMS seminaries are not producing a sufficient number of pastors and that our LCMS seminaries are cost prohibitive. Yet, even while they are repeating these criticisms, they have been discouraging people from attending our LCMS seminaries and actively seeking to persuade LCMS seminary donors to fund their project instead. If they are genuinely trying to advance the mission and ministry of LCMS congregations, then such undermining of the seminaries of the LCMS is counterproductive — and divisive.

In closing, my appeal to LCMS friends is this: Let us continue to share together the vital work of pastoral formation for the LCMS, for the sake of a clear confession of Christ for our children and grandchildren and for the world. Please do not support the splintering of this effort into "every district for itself, every congregation for itself and every pastor for himself." Let's work together, in an orderly and honest way. This is what I strive for every day. That is what our seminaries were founded for. God grant it, for Jesus' sake.

Appendix II

Other matters which the Montana District Convention may wish to address

1. Theological integrity-

Something could be said to the Synod about maintaining the purity of our confession.

Possible resolveds:

- 1. To encourage church workers to be faithful to their public confession.
- 2. To encourage church workers to have the integrity to leave the Synod if their confession is at variance with that of the Synod.
- 3. To encourage ecclesiastical supervisors to begin specific discussions with those known to teach contrary to the position of the Synod.
- 4. To call districts to recognize the Synod is not a federation of districts and therefore to submit to the will of the Synod.

2. Speaking the truth in love-

Something could be said to the Synod about the habit of publicly attacking reputations.

Possible resolveds:

- 1. To encourage Church workers to hold each other accountable to the eighth commandment.
- 2. To not be conformed to the world in our online activities

3. Four Year cycle

Something could be said to the Synod about holding Synodical conventions every fourth year instead of every 3 years. This would be a tremendous financial savings as well as increase the terms of service for Synodical officials, allowing another year of freedom from election pressures.

4. Supporting Lutheran Schools

Something could be said to the District or Synod about the fact that Lutheran Schools are a primary mission tool of the Synod. How can we better support them?

Possible resolveds:

- 1. To encourage the support of Lutheran Schools
- 2. To consider opening schools.
- 3. To encourage support of the Montana District Schools fund and Lutheran Schools Scholarship fund.

5. Report on the teaching of evolution in institutions of higher education

Something could be said to the Synod about giving our congregations assurance that the teaching of evolution is not being tolerated in our institutions of higher education. I know we have consistently spoken on this issue, but nothing has changed. (I have a possible overture from the Denver Creation Society)

Possible resolveds:

- 1. 1. To require the President of Synod report on the results of his wishts to our schools with respect to the teaching of evolution.
- 2. To encourage Regents, Professors, and ecclesiastical supervisors to be faithful to Synodical confession
- 3. To require the President of the Synod to appoint a committee to investigate what is being taught.

6. Seminaries

Something could be said to the Synod about supporting our Seminaries. The dependence of seminaries on restricted funds is dangerous.

Possible resolveds:

- 1. To encourage larger contributions from Synod to seminaries.
- 2. To abandon current accreditation system inasmuch as it may require seminaries to perform in ways that are not in line with our confession.
- 3. To call our seminaries to protect professors from undue pressure to perform academically, thereby inadvertently driving them to come up with something new.

7. Sunday School Curriculum

Something could be said to the Synod about producing a Sunday School curriculum for very small congregations.

Possible resolved:

1. To call for the production of a Lutheran, lectionary based curriculum that could be easily applied when children show up for an occasional service.

8. Christian Nationalism

Something could be said about the evils of mixing the Christian faith with nationalistic fervor.

Possible resolveds:

- 1. To declare that the United States of America does not have favored nation status with God.
- 2. To condemn racial divisions that suggest some people are not worthy of hearing the Gospel or of our care.

9. Adoption

Something could be said to the about the need for Christians to adopt children. There are approximately 368,500 children in the foster care system in the U.S. These children want and need parents to care for them.

Possible resolveds:

- 1. To declare that Christians have an obligation to care for the widowed and orphaned.
- 2. To encourage adoption as a life choice.
- 3. To encourage the support of adoptive families.

10. Need for Church Workers

The LCMS has roughly half the number of students studying for fulltime Church work that we had in 2004. Montana has roughly 20% vacancy rate. We need Pastors and teachers.

Possible resolveds:

1. To encourage every Montana District congregation to use Set Apart to Serve Materials

11. Gender Theory and its impact on the family

Something could be said about God's creation of two genders and the destructive forces at work in ungodly sexual behavior and the purported change of gender.

Possible resolveds:

- 1. To declare that there exist only two genders created by God.
- 2. To declare that a sexually pure and decent life consists of living within these two genders.
- 3. To call for protection of our children from this radical gender identity theory.

12. Synodical Union

Something could be said about reclaiming a beneficial understanding of our Synodical Union.

Possible resolve

1. To direct the President's office to produce a study of what it means to be part of a Synodical Union.

Triennium Treasurer's Report 2025 District Convention

The importance of the relationship of service and oversight that exists between the Montana District and the district congregations, expressed in part during District Conventions, is invaluable. Over the past triennium, in keeping with the Board of Directors (BOD, Board) focus on transparency and faithful stewardship, the Office of the Treasurer has pursued providing clear and useful financial information regarding the district finances and relevant financial information for use by congregational treasurers and their congregations. Included in the Triennium Report (expanded into four years) are comparative financial statements of The Montana District of the Lutheran Church – Missouri Synod, reporting years 2021-2023 (audited) and 2024 (unaudited). Through generous gifts, donations, and bequests from our district congregations and individual donors, as well as investment income, the Montana District has been able to both meet its financial obligations and plan for future ministry with confidence. This is possible both through the faithfulness of the Board in honoring the mission of the district and the faithfulness of the district congregations in providing direction to the Board. For instance, the by-laws of the Montana District, proposed by the Board and approved at a District Convention, prevent any Board of the Montana District from engaging a loan to conduct operating activities (salary, office expenses, etc.). This assists in keeping budgetary planning focused not just on the coming year, but on the effect of the budget on future ministry years.


A brief review of the financial highlights of the past triennium, expanded, includes the following:

2022-2024 Highlights

- A periodic review of financial procedures and internal controls was conducted and updates were made as recommended.
- External audits were conducted each year, and all audits concluded that no material
 misstatements exist. The 2024 audit is engaged but not completed as of the printing of
 the convention book.
- \$81,522 in scholarships were awarded to church worker program students at Concordia Seminaries and Universities. These scholarships were funded through donations, bequests, and investment revenue received from the Lutheran Church Missouri Synod Foundation where the monies are held in investment to maintain a scholarship program supporting the training in ministry of members of Montana District congregations.
- Montana District awarded \$97,727 in student loan repayment grants to church workers serving Montana District congregations to support both district church workers and their congregations. These awards were funded primarily through LCEF Operating Results given to the district, and in part General Fund dollars.
- Lutheran schools in Montana District applied for and received \$9,824 in grants in support of their programs. This fund was begun with donor money, increased with

- Board directed General Funds, and is held with LCMS Foundation to maximize income on the balance to maintain the grant program.
- \$2,000 in Mercy Fund Grants were awarded during the triennium. The Mercy Fund was
 created to aid MT District called workers who are facing catastrophic medical costs
 beyond their ability and their congregations' capacity to assist. This fund is fully
 supported by individual and congregational restricted donations.
- The BOD has been active in supporting pro-life ministry and in supporting religious freedom in Montana and nationally. \$981 was sent to Lutherans for Life, \$154 supported religious freedom in Montana (travel and lodging to testify with the state legislature), \$916 was used to provide CI-128 informational pamphlets to MT District congregations in advance of the 2024 election in support of life issues, \$466 was expended in participating in the Life Conference in DC, and \$1,500 was invested in religious freedom through Alliance Defending Freedom.
- Montana District has four congregations that are subsidized mission foci of the district: Crow Lutheran Ministry, Circle of Life Lutheran Church, Emmaus Lutheran Mission, and Redeemer Lutheran Church.
 - To support Indian ministry congregations, the Board directed \$221,367 in subsidies supporting Circle of Life, with \$9,304 sent in support from District congregations, and \$116,190 in subsidies supporting Crow Lutheran Ministries, with \$8,842 sent from District congregations.
 - Emmaus Lutheran Mission serving Livingston was begun in a previous triennium. This support has continued through this triennium. \$179,251 has been spent in support of this ministry. MT District congregations and individuals sent \$11,502 to the district office to support this subsidy, and LCEF supported the district subsidy in the amount of \$8,110.
 - During the Triennium, the BOD initiated a revitalization mission effort in Anaconda, Montana, through Redeemer Lutheran Church. The Montana District subsidizes this effort and has invested \$155,756. This subsidy was funded by MT District congregational support of the subsidy in the amount of \$5,352, and LCEF funding in the amount of \$8,110.
- Congregational convention assessments of \$46,157 were collected over the triennium, with \$34,012 expended for the 2022 District Convention and \$21,756 for the 2023 Synodical Convention.
- As directed through Resolution 1-04 at the 2015 District Convention, the MT District sends support for missionaries called out of service in Montana District to the mission field. During the Triennium, the Board directed \$18,000 in support of three missionaries.
- As directed in 2022 District Convention Resolution 4-02 the Montana District sends funds in support of the preparation of pastors through the Joint Seminary Fund. Over the triennium, 46,115.

- As directed in 2003 District Convention Resolution 3-01, the Montana District sends 25% of the unrestricted congregational giving to the MT District to Synod: \$434,273 over the triennium.
- In addition, the Montana District collected benevolent funds and distributed them in support of a MT District church worker in acute need in the amount of \$9,674, and in support of lay individuals in need in the amount of \$1000.
- \$11,000 in grants were issued to MT District Lutheran schools in tuition assistance for student families in financial need.



- <u>Financial Assets</u> include checking, savings, certificates of deposit, mutual funds and stocks, and accounts receivable. Financial Assets exclude property, plant, and equipment and prepaid expenses.
- <u>Available Financial Assets</u> exclude donor restricted and board designated funds in excess of the planned budgetary expenses for the year.
 - o For example, on January 1, 2022, the Church Worker Scholarship Fund had a balance of \$660K. The budgeted scholarship expense for 2022 was \$30K. \$30K from the Church Worker Scholarship Fund was an <u>Available Financial Asset</u> reported in purple, and \$630K was *not available* to meet expenses in 2022. The full \$660K was reported in green in <u>Total Financial Asset</u>.
 - <u>The General Fund</u> makes up the majority of <u>Available</u> Financial Assets each year. The majority of the budgeted expenses are paid out of the General Fund. The General Fund is supported almost wholly through the monies sent to the District by MT District Congregations in accordance with their Congregational Plans of Support.
 - o <u>For more</u> information on the fund balances that the Financial Assets are divided into, please see the previous page. The Board of Directors uses funds to assist in planning for future budget years.

Western Circuit - Circuit Visitor Report

Rev. Ray Larson had served as circuit visitor for over a decade until he passed away on Christmas Eve 2022. We sincerely miss Ray at our Winkels and Rosanne at our Winkel suppers. In the spring of 2023 Rev, Sandersfeld was assigned and assumed duties of the CV. Regular Winkel meetings have been held each September through May 2022-2023, 2023-2024 and now 2024-2025. We gather at 10:45, worship together, eat lunch and then explore an exegetical study most often based on the 3-year readings to come, a study in the Book of Concord (Formula-Solid Declaration) and then most recently Quinstedt on the Atonement. We spend from 20 – 45 minutes in personal family/congregation/health updates and sometimes report or reflect on books or articles recently read. We try to dismiss by 4:30 and then may gather locally for supper.

In 2023 Christ our Savior, Challis, Idaho was officially established and the circuit celebrated that Sunday afternoon event. In April of 2023 I was also blessed to preach and officiate at the installation of Rev. Michael Musegades at Challis. He is now faithfully serves the new, dual parish of Salmon and Challis, serving Salmon each Sunday morning and Challis in the afternoon. The Challis congregation itself was officially established in 2023 after time as a preaching station persistently done under Pastor Musegades. Such work at Challis had been sporadic for perhaps 30 years depending on the pastor and people living in Challis; this proved to be God's time.

Since assuming duties I have filled pulpits at 6 of our circuit congregations: Messiah, Missoula, Shepherd of the Valley T. Falls, Faith, Condon and Holy Cross, Seely Lake and Grace, Hamilton. Not necessarily with official business, but I have been in every congregation over these last two years and have been blessed by the preaching of brother Pastors. On Reformation Sunday 2023 I retired from Grace, Hamilton (which I had served since 2006) after 40 years of active ministry, ordination and marriage to my wife Dee in 1983. Rev. Andrew Eckert of Stevensville faithfully filled that vacancy until Rev. Justin Herman was called and installed in September of 2024. There have been no other vacancies in the circuit.

In November of 2024 I presided over a Circuit Conference at which Rev. Andrew Eckert was duly elected by pastors and representatives from all of our 7 parishes to serve as Circuit Visitor once ratified by the District Convention. We now have 3 dual parishes in our circuit for a total of 9 congregations. We have 1 associate pastor, Steve Carlson at First, Missoula. We have 3 more emeritus pastors: Ray Wiegert, Jim Knapp (seasonally) and myself, Vern Sandersfeld. We have 7 active full-time pastors in our circuit: Berger, Iverson, Fitch, Johnson, Eckert, Herman and Musegades. I have been honored and humbled to serve among these men and in the District under President Forke, blessed staff and faithful God's people by the grace of God alone.

Might I take this moment to say how truly grateful I am to have a faithful Synod and District, faithful pastor-brothers who have surrounded me, blessed years starting as a vicar under Pastor Reiner in Kalispell, (where I met my wife!) as Missionary at Large and then dual parish pastor in ND, Pastor at Whitefish, Sherwood, Oregon and now back home in Hamilton, Montana. I pray God gives you a true heart of thankfulness for our church, your brother pastors and God's

people. I pray God gives you the eyes to see the blessing we have as pastors to simply serve others and proclaim the name of Jesus Christ and Him crucified. Dee and I have indeed seen that God has worked all things for good

Summary Minutes Montana District Board of Directors 2022-2025

June 8, 2022

Meeting conducted through electronic means. Kendall Hartmann authorized to sign closing documents on sale of District Office. Mileage rate for District Convention set to \$0.48/mile.

July 25, 2022

Finances are good despite a net quarterly loss due to market volatility for invested funds. Recommended to LCEF that they provide resources to church workers for financial planning and student loan debt relief. Annual audit showed no discrepancies. Scholarships were awarded to two students. School fund grants were approved. District Compensation guidelines for 2023 were adopted. Montana District offered to administer the sale of Emmaus Lutheran Mission's building in Big Timber with net proceeds remitted to the District. Susan Loomans appointed Treasurer. Per diem hotel rate changed to \$200/night.

October 13, 2022

Net loss to District assets due to negative market returns, expenses, and return of Soldier of the Cross funds (which were unused) to Synod. Constitution and bylaws for Mount Olive in Billings approved. Kendall Harman appointed as Board Representative to Synod Convention. Bylaw amendments recommended by Commission on Constitutional Matters recommended to next District Convention. District campus ministry funds given to First Lutheran in Bozeman for use in their campus ministry. Student Loan Repayment Grants fully funded and dispersed. Budget passed. Emmaus Lutheran required to compensate pastor at full level indicated in their subsidy request. District priorities passed. Mileage policy amended to limit reimbursement to the cost of the least expensive airfare. Per diem for lunch increased to \$15.

January 30, 2023

Total decrease in assets in 2022 was \$98K, mostly due to poor market returns. Proceeds from sale of Broadwater property added to Mission and Ministry Fund. Adjustments made to 2023 budget due to discrepancies between anticipated and real expenses at new District Office. Standing committee chair appointments in progress. Wendt, Tabbert, and Zoeller to work on a committee reviewing subsidized congregations. Board will visit Native American Missions (Lame Deer and Crow Agency) at May 9th BOD meeting.

May 8, 2023

Net increase in assets over first quarter. Constitution for Christ Our Savior in Challis, Idaho approved. They are now a congregation of the Lutheran Church—Missouri Synod. Subsidized ministries criteria discussed. Articles of Incorporation amended to update address.

Lehmann and Forke to develop Child Protection Policy. Bylaw change suggested to amend 2^{nd} VP Vacancy procedures.

July 23, 2023

Small net loss to assets. Finances are in good shape. CCM approved changes to Articles of Incorporation. Audit completed. No material errors. One adjustment. Challis application to join LCMS approved. Russ Dewell, Steve Jarvis, and William Warberg approved as district reconcilers. School grants approved. Scholarships for three students approved. Church Worker Compensation guidelines approved. James Holowach nominated to CCM.

August 10, 2023

Meeting conducted through electronic means. Scholarships were awarded to four students. Dennis Bauer was appointed District Reconciler.

October 18, 2023

Slight decrease in District assets due to expected expenses. Finances in good shape. Susan Loomans and Ruth Kosche appointed to attend LCEF meeting. Student Loan Repayment Grants approved. Amendments made to Subsidized Ministry Proposal. Emmaus required to pay money owed to Concordia Plans in order to receive 2024 District subsidy. Child Protection Policy adopted. Forke and Wendt to work on Church Worker Scholarship Policy. Douglas Bauman nominated for Board of National Mission. Eric Loftsgaarden nominated for LCMS Foundation Board of Directors. Budget adopted.

January 29, 2024

District ended 2023 with a net income of 44.6K. Subsidized Ministries Policy adopted. Anaconda subsidy adjusted due to vacancy. Susan Loomans appointed Quickbooks Administrator (so that she can officially communicate with the company). Tabbert and Forke to represent district in visitation by Boards for National and International Mission. Brian Lee, Sam Grayl, and Ryan Wendt to serve on Set Apart to Serve committee. Funds sent to Joint Seminary Fund from District General Fund (per District Convention action).

May 10, 2024

Net income in first quarter of 2024. Constitution and Bylaws for Concordia Williston approved. District expanded enrollment parameters in the CRSP to include all paid employees of the District. Treasurer authorized to replace District Copier. District Treasurer moved to hourly wage.

August 5, 2024

Slight loss in net access. Finances of District still good. Constitution and Bylaws for First Lutheran, Bozeman approved. Church Worker Scholarship Policy approved. Margaret Skoog appointed Parish Nurse Representative. Church Worker Scholarships awarded to three students. President Forke to be paid through July 31, 2025 (per bylaws).

October 7, 2024

Third quarter showed a loss due to replacement of copier, but YTD shows a gain. Scholarship granted to late applicant. Church Worker Scholarship Policy amended to allow Board to take extenuating circumstances into account when awarding scholarships. Congregation subsidy levels discussed and set. Budget approved. Convention mileage rate set at \$.48/mile.

January 27, 2025

Net income of \$8,751 for 2024. Susan Loomans appointed representative to LCEF conference. Montana District Staff granted discretion to adjust subsidies of subsidized congregations of district. Severance set for Pastor Merz. Housing allowance for DP increased to \$2,500/month beginning February 1st. Audit received for 2023. New auditing firm will be employed.

Committee for Convention Nominations

The last election to take place during the Montana District Convention plenary sessions is that of a delegate and an alternate delegate to the Synodical Committee for Convention Nominations. See details of the position below.

This election will be effected by a nominating ballot and succeeding election. Please do some thinking prior to the convention about whom you may nominate for this very important position.

The members of the 2026 Committee for Convention Nominations (CCN) of the Synod are elected by district conventions according to Bylaws 3.12.3–3.12.3.3 (2023 Handbook, pp. 189–90). Districts elect one (1) member of the committee and one (1) alternate through their regular nomination and election procedures. This member must be either a professional church worker (ORD/COM, that is, an ordained or commissioned minister) or a layperson (LAY) as follows:

3.12.3.2 3.12.3.3 In preparation for the following, odd-numbered regular convention (e.g., 69th in 2026), the remaining districts shall elect in the same manner:

One-half of the electing districts shall be designated by the Secretary of the Synod to elect a professional church worker and the other half a layperson, with roles reversed every six years

Limitations on holding multiple offices in the Synod do not apply (Bylaw 3.12.3).

Meeting Requirements:

Persons elected to this committee must be prepared to serve at the call of the Secretary of the Synod at least six (6) months prior to the next Synod convention and to participate in one or more meetings, as needed, in St. Louis in the months immediately following. We anticipate the first meeting to be held on Jan. 15–17, 2026, and ask that the elected members hold these dates (for arrival on Wednesday evening, Jan. 14, and departure no earlier than Saturday evening, Jan. 17) in their calendars for this purpose. Online registration, with final travel details, will take place in late summer 2025.

Responsibilities:

The CCN will be responsible for selecting two (2) or more candidates and at least one alternate for all elective offices, boards, and commissions to be filled by the convention except President, First Vice-President, and regional vice-presidents. The committee will base its decisions upon review of biographical and evaluative information regarding candidates whose names were submitted by persons from throughout the Synod. Members of the committee should be able to work closely with other committee members for the common good of the Synod and be willing to set aside personal interests as appropriate in order to place into nomination those candidates most qualified to carry out the responsibilities of the offices being filled. Members of the Committee for Convention Nominations (CCN) may also be asked to serve at the time of the convention to process nominations from the floor.

Since the 2013 Convention, appointments to theological faculties at all universities and seminaries, as well as all college, university, and seminary presidential appointments, have been subject to the prior approval process. While the convention in 2013 amended the bylaws to delegate the responsibility for prior approval to specific groups (see bylaws referenced below) the bylaws did not, and still do not, stipulate how the process of prior approval should be carried out. Over time this has led to questions as to the standards used to evaluate candidates as well as the process utilized by the prior approval panels. In the hopes of building trust and relieving any undue criticism of the panels and the process, the following overture aims to increase transparency for the process and standards used by the panels as well as ensuring clear communication between the panels, the candidates, and the Synod.

WHEREAS, One of the expressed purposes of Synod is to "recruit and train pastors, teachers, and other professional church workers and provide opportunity for their continuing growth" (Art. III.3); and

WHEREAS, Synod has the responsibility to oversee that training; and

WHEREAS, Synod has designated that responsibility to the prior approval panels outlined in various bylaws (3.6.6.1, 3.10.5.7.3, 3.10.6.8.2, 3.10.6.9.2); and

WHEREAS, Those panels have responsibility not only to work in behalf of the Synod but also are responsible to the Synod; and

WHEREAS, Those under consideration for theological professorships and other such positions as require prior approval have ordinarily been ordained into the Office of Holy Ministry or have been commissioned and/or consecrated into an auxiliary office of the Church; and

WHEREAS, Those under consideration for aforementioned positions have also been examined and approved for service on the roster of The Lutheran Church — Missouri Synod; and

WHEREAS, Those individual members of Synod have, by virtue of their membership in the Synod, agreed to the confessional basis as outlined in Art. II, as well as recognize and affirm the validity of Bylaws 1.6–1.8; therefore be it

Resolved, That the District in convention give thanks to the Lord of the Church for using the Synod and its agencies to preserve and enlarge the workers of the harvest; and be it further

Resolved, That District in convention give thanks to those engaged in the various prior approval processes for being engaged in difficult and important work; and be it further

Resolved, That District in convention memorialize the Synod to require that process used by the various panel to carry out the responsibility entrusted to it by the Synod be made transparent and publicly available; and be it further

To Request an Apology for the Publication of Luther's Large Catechism with Annotations and Contemporary Applications (LLCACA) and to Republish it in Modified Form

WHEREAS, Romans 16:17 says, "Now I urge you, brethren, note those who cause divisions and offenses, contrary to the doctrine which you learned, and avoid them;" and

WHEREAS, 1 Timothy 2:12 says, "And I do not permit a woman to teach or to have authority over a man, but to be in silence;" and

WHEREAS, Galatians 5:9 says, "A little leaven leavens the whole lump;" and

WHEREAS, *LLCACA* was created in response to a request by the Synod in convention, tasking the CTCR (Commission on Theology and Church Relations) with producing a new edition of the Large Catechism with explanations to aid understanding; and

WHEREAS, According to online advertising for *LLCACA*, it was "Developed and written primarily for Lutheran pastors, church workers, and seminary students." (Amazon.com product description 1/29/2025 *); and

Whereas, The introduction in *LLCACA* says, "Luther's Large Catechism itself, together with the annotations and essays that follow, seeks to teach the baptized. This is not a book primarily for pastors, though we hope it will be a helpful resource for all called church workers, including pastors. This is for the whole church – for the ordinary layperson who wants to grow deeper in faith and understanding and be able to give 'a reason for the hope that is in you' (1 Peter 3:15). It is the goal of this book both to edify or build up readers with a deeper understanding of God's Word and to equip them with knowledge so they can respond to challenges to the confession of the Lord's truth in our culture." (General Introduction by John T. Pless and Larry M. Vogel, Editors). *LLCACA* is therefore a Catechetical book for laity as well as clergy, teaching everyone and anyone the faith taught in our Catechism; and

Whereas, A number of people have defended and upheld the publication of *LLCACA*, including the Rev. President Matthew Harrison, who said, "I have had time to re-evaluate the controverted sentences and found that while some things might have been expressed more clearly, nevertheless, there is nothing in the content of the volume promoting critical race theory (CRT), confusion of sexuality issues, or any theological position at odds with biblical and confessional Lutheranism. The Lutheran Church—Missouri Synod's doctrine is established only by the Scriptures and confessed in the *Book of Concord*. By God's grace we remain steadfast in this eternal truth and confession as we await the return of our blessed Savior Jesus Christ. Frankly, I think each reader will be astounded at the content and quality of the volume.;" and

WHEREAS, There was nonetheless an indiscriminate use of authors to teach our clergy and lay people; and

WHEREAS, Women teachers contributed to *LLCACA*, and were thus put in the position of catechizing our lay people, seminarians, and pastors (whether the ladies' content is good or not); and

WHEREAS, Because *LLCACA* is intended to teach our people the true faith, it is especially a very serious cause of offense that at least one author from outside our Synod who is known to be a false teacher was allowed to catechize our people by writing essays in *LLCACA*; and

WHEREAS, This individual, Steven Paulson, who is an ELCA pastor, has denied the substitutionary atonement, thereby following the teachings of Gerhard Forde, who also taught that the death of Christ was not a payment made for our sins, when in an essay he said, "Forde Lives!" Paulson also said, "The stupefied atonement question - Why could God not just up and forgive? - is answered simply: He did!" (*The Essential Forde: Distinguishing Law and Gospel*, eds. Nicholas Hopman, Mark C. Mattes, and Steven D. Paulson, Minneapolis: Fortress Press, 2019, p. 29); and

WHEREAS, Paulson rejects the so-called "legal scheme" of the vicarious satisfaction throughout his book *Lutheran Theology*, thereby rejecting vicarious satisfaction as confessed in many places in the Book of Concord; and

WHEREAS, Paulson also teaches antinomianism, as convincingly demonstrated and refuted by Dr. David P. Scaer, "Is Law Intrinsic to God's Essence?" Concordia Theological Quarterly, volume 82, Number 1-2, January/April 2018; and

WHEREAS, Even though Paulson does not appear to explicitly teach these things in *LLCACA*, he does however teach about the Third Commandment, so antinomianism surely colors some of what he says, most importantly with what he neglects to say; and

WHEREAS, Additionally, the denial of the substitutionary atonement must always color everything a man teaches, even if it is not referred to; and

WHEREAS, Paulson, as a teacher in the ELCA, officially stands with the official teachings of the ELCA, including denying the inerrancy of Scripture, acceptance of women and gay clergy, etc.; and

Whereas, Perhaps most dangerously, even if Paulson's words in *LLCACA* happen to be orthodox by themselves, by using him as a teacher in an official publication, laymen may be unsuspectingly led to assume that the Synod endorses him and that there is nothing wrong with his theology thereby leading them to read more of his harmful materials; and

WHEREAS, Those authorities who have now publicly endorsed or supported the publication of *LLCACA* include 1) the CTCR by producing it, 2) Concordia Publishing House (CPH) by publishing it, 3) the Synod President by praising it; therefore be it
